## Message From State Superintendent Tony Smith, Ph.D.

Hello,

Last Wednesday, the State Board of Education met in Springfield and approved the 2016 Financial Profile report. The number of school districts earning the top rating of Financial Recognition grew this year to 568. Illinois' average financial rating score also increased slightly. However, this positive trend does not tell the whole story.

The Financial Profile analysis found that 499 or 58.6 percent of school districts are expected to deficit spend, based on districts' budget submissions for fiscal year 2016. Many districts also continue to borrow to

maintain daily operations, with districts issuing \$307.2 million in debt in their operating funds in FY 2015, and still must continue to make difficult choices to cut spending.

This data is deeply troubling. Though some districts may be running more efficiently on paper, they've had to reduce staff, forgo supplies, delay necessary building repairs and maintenance, and eliminate programs for students. Several years of reduced state funding are now denying our students valuable opportunities. Worse, many of the affected students are those who rely on public school services the most. This loss strengthens our commitment to establishing a more equitable education finance system that considers schools' unique student populations, the availability of local resources, and the need for services.

In other Board news, members of the Student Advisory Council (SAC) presented the findings of their research project. This year's council focused on the importance of students' feedback in efforts to improve teacher quality and build a more collaborative school community. The quality of the research and thought these students put into their project is truly extraordinary. The SAC has also asked to increase its participation at Board meetings for the upcoming school year. The council helps keep the student voice and experience present in our discussions, and I look forward to working with this student group to expand its interaction with the Board.

The Board also honored Julia Zhang, 11, of Highland Middle School in Libertyville District 70. Her artwork won first place in the 34th Annual Arts Education Week poster contest. Julia's entry features the four areas of fine art – dance, drama, music, and visual arts – to reflect this year's contest theme, "There is Magic in the Arts!" I am also pleased to report that J. Sterling Morton High School District 201 has been named a College Board Advanced Placement ® District of the Year. The award recognizes the district as the nation's leader among medium-size school districts in simultaneously expanding access to challenging AP courses while improving AP exam performance. Morton was one of 425 school districts across the United States and Canada that was selected for the annual AP District Honor Roll. From this list, three AP Districts of the Year – one for each category of district population size: small, medium, and large – were selected based on an analysis of three academic years of AP data.

We are so proud of the hard work of the staff and students and Morton's commitment to providing all students greater opportunities for exposure to college-level coursework. Morton's award ties in with an exciting new project to eliminate racial and income inequality in our high schools' most rigorous courses. Illinois is the first state selected to partner with the Lead Higher Initiative in a statewide challenge to close equity gaps in high school AP and International Baccalaureate (IB) courses. Through this partnership, we will receive the tools and resources to strengthen our efforts to find students, in particular underrepresented students, who are eligible for AP coursework and give them greater support. Seven Illinois school districts have already committed to close their AP and IB gaps by fall 2016, and 15 more have been selected for the 2016-17 Lead Higher district cohort. You can read more about this incredible opportunity to ensure greater accessibility for all students here.

# **ESEA Changes Requirements** for Highly Qualified Teachers

With the passage of the Every Student Succeeds Act (ESSA), some provisions are being phased in or phased out, with full implementation set for 2017-18. One provision that is no longer required for the 2016-17 school year is the Highly Qualified requirements for teachers and paraprofessionals as outlined in section 1119 of the Elementary and Secondary Education Act.

Effective July 1, teachers and paraprofessionals must meet state and local licensure requirements. ## Important Information on the Illinois Science Assessment for High School

Thanks to the feedback of a number of high school educators and administrators, we have adjusted the testing parameters for high school students who will take the Illinois Science Assessment.

Students who are enrolled in one of the following courses and who do not have a prior full year credit in any of the following courses must test: 03051A000 Biology, 03052A000 Biology – Advanced Studies, 03056A000 AP Biology, or 03057A000 IB Biology.

Students who will take the Dynamic Learning Maps alternate assessment in science will test at grades 5, 8, and 11. There is no end-of-course assessment available on the alternate assessment, so it will be administered

at grade 11, which is the currently tested grade in English language arts and math on the alternate assessment.

## **ISAC FAFSA Completion Initiative**

There's still time for high school seniors to access federal and even some institutional aid for college by filing a Free Application for Federal Student Aid



(FAFSA). Although the Illinois Student Assistance Commission (ISAC) recently announced

this year's <u>cut-off date</u> for fiscal year 2017 Monetary Award Program (MAP) awards (students who filed FAFSAs on or after March 10 will not be eligible for MAP unless ISAC determines there will be additional funds to distribute later in the year), federal Pell dollars and other financial aid continue to be available to Illinois students.

Last year, more than 61 percent of Illinois' 12th-grade students completed a FAFSA (as of June 30, 2015). This year, ISAC aims to move the needle even higher and help more students get to college.

Schools can help increase their FAFSA completion rates by participating in ISAC's <u>FAFSA Completion</u> <u>Initiative</u>. This free service offers schools a way to

effectively improve school FAFSA completions by easily identifying students who have not filed a FAFSA, so high school counselors can reach those who might otherwise not complete an application. Principals can sign up their high school for the initiative through the <a href="Gift Assistance Program Portal">Gift Assistance Program Portal</a>.

ISAC is also offering and/or helping to support free FAFSA Completion Workshops across the state. Visit the <u>ISAC Outreach Calendar</u> to learn more. The <u>ISACorps</u>, the agency's team of near-peer college mentors, can also help support in-school events and are available to provide one-on-one assistance.
