Message From State Superintendent Tony Smith, Ph.D.

Thank you for all the amazing work you are doing for our students. Although it's early in the year, I've already seen students, teachers, and administrators doing great work!

Last week, we had a kickoff call for our statewide Lead Higher Initiative work. The Lead Higher Initiative is a consortium created in April 2015. It includes Equal Opportunity Schools, College Board, International Baccalaureate, and lead philanthropic partner the Jack Kent Cooke Foundation. Illinois is the first Lead Higher state, thanks to the committed leadership in districts across the state to increase enrollment and outcomes in Advanced Placement (AP) and International Baccalaureate (IB) courses. Opportunity Schools, our partner in this work, is focused on ensuring that all students have the opportunity to succeed in challenging high school courses with a focus on AP and IB.

Twenty-one school districts have increased AP and IB participation and outcomes by explicitly recruiting historically underrepresented students who have demonstrated potential to succeed in AP or IB. These districts are building a community of practice focused on equity and access in AP and IB. Our goal is to get all the students who are "missing" from these existing course enrolled and supported while we continue to expand these courses statewide. We hope to support and transform existing programs in the state by heeding the lessons learned by these leading districts. We want new programs to launch without gaps in student participation.

Districts are doing specific outreach and creating new ways to engage. I encourage you to watch these powerful videos that include student voices and some serious teacher enthusiasm!

Those Who Excel

Meet Illinois Teacher of the Year Finalist Ted Houpt of Danville CSD 118

Edward "Ted" Houpt is proud of the fact that his entire career as an educator has been at Danville High School in Danville Consolidated School District 118 for 27 years.



Ted's father introduced him to the wonders of history when Ted was in

third grade and the family visited Washington, D.C. That trip awoke a passion in Ted that would ultimately become his profession. He became convinced that he could share his enthusiasm and joy for the richness of history -- not just the events, but the people behind the events. Clearly, he has exceeded his goal as is evident by a former student who says, "If I had to name a single person who is most responsible for the path my life has taken, it would have to be Mr. Houpt. I can attribute the changes in myself almost solely to the influence of Mr. Houpt's teaching, mentorship, coaching, and general presence in my life during my years in high school and beyond."

Ted is described as a true leader within the school, the district, and the community. He continuously advocates for teachers and is instrumental as a mentor to new teachers. Ted does not discuss retirement or summer breaks because he never stops evolving and learning. He is improving his teaching skills so that his students get

the best education he can give them. He brings history to life and he challenges his students to think in a deep, critical way rather than just memorizing dates and facts. A colleague described Ted's teaching by saying, "His ability to link the past to student's own lives allows each student in his class to be fully engaged as if they are on their own personal journey through history."

His Modern World Issues class allows students to learn about the world they are living in and gives them an opportunity to study the present-day challenges facing global society. He also coaches tennis and boys varsity basketball. Ted sponsors a Local History Club that gives students an opportunity to go on monthly outings to learn about the history and heritage of Danville. No matter what Ted is doing, he is always learning and always thinking of new ways to help his students succeed.

Ted is one of our 10 finalists for Illinois Teacher of the Year, which we will name at the Those Who Excel banquet in Normal on Oct. 22.

State Funding and Forecasting

FY 2017 General State Aid Claim is Final

The fiscal year 2017 General State Aid (GSA) claim has been completed and is now final. Districts may view their calculation of entitlement and payment schedule in GSA Inquiry. In FY 2017, districts receive the greater of (A) their FY 2016 payment plus a share of the new \$250 million equity grant pool or (B) their FY 2017 GSA claim. For those districts where option A is the greater amount, the difference between FY 2017 claim and the larger FY 2016 payment plus equity grant appears in the calculation of entitlement as the Stop/Loss Adjustment. This portion of the claim was first applied in the payment made Aug. 20 and will continue throughout the year. All portions of GSA payments will appear in FRIS as revenue code 3001.

Grant Accountability & Transparency Act

FY 2017 Indirect Cost Rates- REVISED

In accordance with a Delegation Agreement between the U.S. Department of Education and ISBE, and pursuant to its authority under the Grant Accountability and Transparency Act (GATA) and administrative rules, the

Governor's Office of Management and Budget has granted ISBE an exception to the federal Uniform Guidance and GATA regarding the determination of indirect cost rates that may be utilized by all grantees that receive a state award or federal pass-through award for grant programs administered by ISBE.

Local Education Agencies (LEAs) may utilize either the restricted indirect cost rate the LEA negotiates annually with ISBE (school districts) or the statewide average indirect cost rate calculated by ISBE (Regional Offices of Education, Intermediate Service Centers, special education cooperatives, area vocational centers, charter schools, and university laboratory schools approved by ISBE). These LEAs will also utilize the ISBE-established restricted indirect cost rates for state and federally funded grant programs administered by other state agencies. Therefore, LEAs do not need to take any further action in order to establish or utilize an indirect cost rate for any state or federally funded grant program administered by any state agency

Not-for-profit agencies, community/faith-based organizations, and for-profit entities may utilize the statewide average indirect cost rate calculated by ISBE for all state and federal grant programs administered by ISBE. Colleges and universities will be restricted to a maximum indirect cost rate of 8 percent or other indirect cost rate calculated by their cognizant federal agency, whichever is less, for state and federal grants administered by ISBE. However, these entities must negotiate a separate indirect cost rate or select another indirect cost rate option through the State of Illinois Centralized Indirect Cost Rate System (linked below) in order to claim an indirect cost reimbursement for state and federally funded grant programs administered by other state agencies.

Notice of State Award and Grant Agreement Pages in eGMS - NEW

All FY 2017 state and federal grants in the electronic Grants Management System will incorporate the new Notice of State Award (NOSA) and Grant Agreement pages. Specific conditions are reflected in the NOSA as a result of the Fiscal Internal Control Questionnaire (ICQ) and Program Risk Assessment grantee responses. Per the requirements of GATA, please be advised that a required component prior to FY 2017 grant execution is grantee acceptance of the specific award conditions as well as the terms, conditions, assurances, and grant exhibits in the Grant Agreement.

IMPORTANT: ISBE is currently reviewing the specific conditions assigned to grantees as a result of the responses from the ICQ and Program Risk Assessments. ISBE is meeting with other state agencies to discuss the appropriate course of action to implement specific conditions in the NOSA, including evaluation of grantee risk and the necessity of imposing additional specific award conditions. Your organization will be kept advised of the decisions, adoption of administrative rules, and ISBE's implementation plan in this regard. Depending on the specific condition, you will be notified how you can provide evidence of your organization's corrective actions to ISBE or your state cognizant agency according to the timeframe indicated in the NOSA. Grantees completing their GATA registration should have received an automated notification to complete the ICQ. Separately, each grantee was also required to login via the ISBE IWAS portal and complete the Programmatic Risk Assessment. The completion status of these important steps can be accessed at www.isbe.net/GATA/pdf/gata-grantee-status-report.pdf. If specific conditions are not present in the NOSA section, this indicates that either the ICQ and/or Program Risk Assessment has not been submitted and/or approved. Guidance for resolving grantee registration issues can be found under the Prequalification and Registration Status header on the ISBE GATA website at www.isbe.net/GATA/default.htm.

As reminder, each grantee must complete the following:

- 2. Fiscal Internal Control Questionnaire (ICQ) After completion of the registration process, an automated email will provide a link to access the grantee's State of Illinois ICQ form, which must be completed and submitted.
- 3. Program Risk Assessment Access via the IWAS login portal and choose the GATA Risk Assessment System. A DISTRICT ADMIN-level user must submit the GATA Risk Assessment. The GATA Risk Assessment application link will not be available to all users. Users with district-level accounts should request access to the system internally from their administrator. Technical assistance regarding system access steps can be directed to the ISBE Help Desk at (217) 558-3600.

Grantee registration and submission of the ICQ and Program Risk Assessment are required to be completed one time by each grantee and are good for one year.

FY 2017 NSLP Equipment Assistance Grant RFP Released

The Illinois State Board of Education has released a Request for Proposals (RFP) for the FY 2017 National School Lunch Program (NSLP) Equipment Assistance Grants. These grants will provide \$1,127,625 in total to approved School Food Authorities (SFA) on a reimbursement basis to assist in purchasing equipment to serve healthier meals that meet the updated meal pattern requirement, improve food safety, and expand access.

Each SFA participating in the federally funded NSLP is eligible to submit an application for schools under its jurisdiction. An SFA is defined as a governing body that is responsible for the administration of one or more schools and has the legal authority to operate the NSLP therein. Although all NSLP SFAs are eligible to apply, priority will be given to schools 1) that have higher percentages of students eligible for free and reduced-price meals. (If needed, refer to the FY 2016 eligibility listing posted at

www.isbe.net/nutrition/htmls/eligibility_listings.htm.);
2) that did not receive equipment assistance grants

since FY 2009 (If needed, refer to the "Previously Funded" listing at

www.isbe.net/nutrition/htmls/nslp_grant.htm.); 3) that demonstrate high need, i.e., are able to show they are in an underserved area, have limited access to other resources/funding to purchase equipment, or have equipment that is is outdated, nonfunctioning, or nonexistent; 4) that demonstrate how these funds will improve the quality of school meals; 5) that commit to implementing strategies for adopting smarter lunchrooms; 6) that participated in the School Breakfast Program (SBP) in SY 2015-16; and 7) that are self-prep and/or satellite meals to other schools participating in NSLP. Refer to "Review Criteria."

The grant period will begin no sooner than Jan. 1, 2017, and will extend from the execution date of the grant agreement until June 30, 2018. All funds must be expended by the end of the grant period and the final Claim for Reimbursement for NSLP Equipment Assistance Grant funds, including invoices, must be received no later than July 31, 2018.

USDA Announces Availability of Farm to School Grants for FY 2017

On Sept. 13, the U.S. Department of Agriculture (USDA) announced that up to \$5 million in grant funds is available to help schools create or strengthen farm-t-school programs this school year. These annual competitive grants, which are administered by the USDA's Food and Nutrition Service, will help further USDA efforts to increase locally sourced foods in America's school meals.

Farm-to-school programs help form healthy habits and support local economies. The local foods offered through farm-to-school programs help school meal programs fulfill the updated school nutrition standards with appealing and diverse offerings. According to the 2015 USDA Farm to School Census, schools with

robust farm-to-school programs report reductions in food waste; higher school meal participation rates; and increased willingness of the students to try new foods, notably fruits, and vegetables. In addition, in school year 2013-14 alone, schools purchased more than \$789 million in local food from farmers, ranchers, fishermen, and food processors and manufacturers.

The USDA's Farm to School Grants make these outcomes possible by funding school districts, state and local agencies, Indian tribal organizations, agricultural producers, and nonprofit organizations in their efforts to increase local foods served through child nutrition programs, teach children about food and agriculture through garden and classroom education, and develop schools' and farmers' capacities to participate in farm-to-school programs. The funds may be used for training, supporting operations, planning, purchasing equipment, developing school gardens, developing partnerships, and implementing farm-to-school programs.

The Farm to School Grant Program was authorized in the Healthy, Hunger-Free Kids Act of 2010. To date, USDA has funded 300 projects in all 50 states, the District of Columbia, and the U.S. Virgin Islands. Since its inception in FY 2013, more than \$20 million has been awarded through the Farm to School Grant Program. This year, awards ranging from \$20,000 to \$100,000 will be distributed in four different grant categories: Planning, Implementation, Support Service, and Training.

Applications are due by Dec. 8. On Thursday, Sept. 29, the USDA will host a webinar to review the Request for Applications and assist eligible entities in preparing proposals. Visit the <u>grants homepage</u> for more information and to register for the webinar.
