## Meet Illinois Teacher of the Year Finalist Matt Herndon of Wood River-Hartford SD 15

Matt Herndon has teaching in his genes, literally! His father, grandfather, grandmother, and great-grandfather were all teachers, and Matt married a teacher as well. He credits his dad and his elementary school



physical education teacher with his decision to become a physical education teacher. Matt says both men possess qualities he admired growing up and were excellent role models who made clear the necessity of physical education. He strives to be that same positive role model for his students and he stops at nothing to help his students succeed.

Matt developed the physical education curriculum for Lewis and Clark Junior High School in Wood River-Hartford School District 15, where he has taught for his entire 18-year career. Once that was in place, he collaborated with his colleagues and created the district's physical education curriculum. One of Matt's students shared this thought: "He genuinely cares, and is concerned for all students. If I ever need advice, I know I can count on Mr. Herndon to help. He makes P.E. fun because he switches up the games every 2 weeks and he is very creative, even researching games students play in other countries and teaching them to us."

Whenever he sees a need, Matt finds a way to fill it. He raises funds to ensure his students have the equipment they need to understand the important roles healthy living and physical activity play in a person's life. He built the fitness room from the ground up and students, parents, and teachers all utilize the facility. A fellow teacher describes Matt's commitment to his students, district, and the community: "Matt takes the initiative to identify problems and devise solutions. He is an important, effective, and integral part of our program. He is a motivated, dedicated, responsible teacher with a high degree of integrity."

Matt is one of our 10 finalists for Illinois Teacher of the Year, which we will name at the Those Who Excel banquet in Normal on Oct. 22.

### **Reorganization Feasibility Studies**

The Illinois State Board of Education (ISBE) is now accepting agreements for the fiscal year 2017 School District Reorganization Feasibility Studies. Feasibility studies are a tool to be used by school districts wanting to investigate the advantages and/or disadvantages of reorganization options. The school board of each district involved in a feasibility study must approve, by board resolution, the initiation of the study. The districts involved will submit a proposed agreement with an independent contractor(s) to their Regional Office of Education (ROE) or Intermediate Service Center (ISC) in Cook County. The ROE or ISC, as applicable, will submit the agreement to ISBE for approval.

ISBE shall set the final state allotment for each study after review of the submitted study agreement. Funding shall be contingent on factors such as the number of districts involved in the study, the combined student enrollment of districts involved in the study, multiple studies with the same district or districts, new study versus update of a prior state-funded study, etc. Any study cost above the state funding will be the responsibility of the participating districts. In order to receive reorganization feasibility study funds in FY 2017, agreements must be approved by the ROE or ISC and ISBE, and studies must be completed, approved for payment by the ROE or ISC, and submitted to ISBE no later than June 30, 2017.

# State Funding and Forecasting

#### FY 2017 General State Aid Claim is Final

The FY 2017 General State Aid (GSA) claim has been completed and is now final. Districts may view their calculation of entitlement and payment schedule in GSA Inquiry. In FY 2017, districts receive the greater of (A) their FY 2016 payment plus a share of the new \$250 million equity grant pool or (B) their FY 2017 GSA claim. For those districts where option A is the greater amount, the difference between FY 2017 claim and the larger FY 2016 payment plus equity grant appears in the

calculation of entitlement as the Stop/Loss Adjustment. This portion of the claim was first applied in the payment made Aug. 20 and will continue throughout the year. All portions of GSA payments will appear in FRIS as revenue code 3001.

# Grant Accountability & Transparency Act

### FY 2017 Indirect Cost Rates- REVISED

In accordance with a Delegation Agreement between the U.S. Department of Education and ISBE, and pursuant to its authority under the Grant Accountability and Transparency Act (GATA) and administrative rules, the Governor's Office of Management and Budget has granted ISBE an exception to the federal Uniform Guidance and GATA regarding the determination of indirect cost rates that may be utilized by all grantees that receive a state award or federal pass-through award for grant programs administered by ISBE.

Local Education Agencies (LEAs) may utilize either the restricted indirect cost rate the LEA negotiates annually with ISBE (school districts) or the statewide average indirect cost rate calculated by ISBE (Regional Offices of Education, Intermediate Service Centers, special education cooperatives, area vocational centers, charter schools, and university laboratory schools approved by ISBE). These LEAs will also utilize the ISBE-established restricted indirect cost rates for state and federally funded grant programs administered by other state agencies. Therefore, LEAs do not need to take any further action in order to establish or utilize an indirect cost rate for any state or federally funded grant program administered by any state agency

Not-for-profit agencies, community/faith-based organizations, and for-profit entities may utilize the statewide average indirect cost rate calculated by ISBE for all state and federal grant programs administered by ISBE. Colleges and universities will be restricted to a maximum indirect cost rate of 8 percent or other indirect cost rate calculated by their cognizant federal agency, whichever is less, for state and federal grants administered by ISBE. However, these entities must negotiate a separate indirect cost rate or select another indirect cost rate option through the State of Illinois Centralized Indirect Cost Rate System (linked below) in order to claim an indirect cost reimbursement for state

and federally funded grant programs administered by other state agencies.

# Notice of State Award and Grant Agreement Pages in eGMS - NEW

All FY 2017 state and federal grants in the electronic Grants Management System will incorporate the new Notice of State Award (NOSA) and Grant Agreement pages. Specific conditions are reflected in the NOSA as a result of the Fiscal Internal Control Questionnaire (ICQ) and Program Risk Assessment grantee responses. Per the requirements of GATA, please be advised that a required component prior to FY 2017 grant execution is grantee acceptance of the specific award conditions as well as the terms, conditions, assurances, and grant exhibits in the Grant Agreement.

**IMPORTANT:** ISBE is currently reviewing the specific conditions assigned to grantees as a result of the responses from the ICQ and Program Risk Assessments. ISBE is meeting with other state agencies to discuss the appropriate course of action to implement specific conditions in the NOSA, including evaluation of grantee risk and the necessity of imposing additional specific award conditions. Your organization will be kept advised of the decisions, adoption of administrative rules, and ISBE's implementation plan in this regard. Depending on the specific condition, you will be notified how you can provide evidence of your organization's corrective actions to ISBE or your state cognizant agency according to the timeframe indicated in the NOSA. If you have questions regarding the specific conditions and ISBE's implementation plan, please contact your grant consultant. All other inquiries can be directed to GATA@isbe.net.

Grantees completing their GATA registration should have received an automated notification to complete the ICQ. Separately, each grantee was also required to login via the ISBE IWAS portal and complete the Programmatic Risk Assessment. If specific conditions are not present in the NOSA section, this indicates that either the ICQ and/or Program Risk Assessment has not been submitted and/or approved. As reminder, each grantee must complete the following:

- 2. Fiscal Internal Control Questionnaire (ICQ) After completion of the registration process, an automated email will provide a link to access the grantee's State of Illinois ICQ form, which must be completed and submitted.
- 3. Program Risk Assessment Access via the IWAS login portal and choose the GATA Risk Assessment System. A DISTRICT ADMIN-level user must submit the GATA Risk Assessment. The GATA Risk Assessment application link will not be available to all users. Users with district-level accounts should request access to the system internally from their administrator. Grantee registration and submission of the ICQ and Program Risk Assessment are required to be completed one time by each grantee and are good for one year. Please refer to the following data elements in the GATA Grantee Status report:

# Feedback Requested Regarding Supplement not Supplant Regulations

On Sept. 6, the U.S. Department of Education posted notice of proposed rulemaking regarding <u>supplement</u> <u>not supplant regulations</u>. The intention of these rules is admirable, but the methodology will not help -- and may, in fact, hurt -- the students the proposed regulations are intended to benefit. Quality, types, and amount of resources are not considered compared to dollars spent. There is a lack of flexibility or

consideration for state and local control that is in contrast to the intention of the Every Student Succeeds Act. ISBE is beginning an in-depth analysis into the implications of these rules and needs your help.

# **Applications Sought for U.S. Senate Youth Program and Hearst Scholarship**

The program's first phase brings two students from each state to Washington, D.C., from March 4-11, 2017, to participate in the U.S. Senate Youth Program. The William Randolph Hearst Foundation will pay all expenses for the week, including transportation, hotel, and meals. The second phase awards both recipients a \$10,000 college scholarship. The Hearst Foundation requires that to obtain scholarship funds, a student must participate in the Washington Week program and use the funds within four years of enrollment at an accredited U.S. college or university. The student is also encouraged to take courses in history, political science, or related subjects as part of his or her undergraduate program.

# FY 2017 NSLP Equipment Assistance Grant RFP Released

The Illinois State Board of Education has released a Request for Proposals (RFP) for the FY 2017 National School Lunch Program (NSLP) Equipment Assistance Grants. These grants will provide \$1,127,625 in total to approved School Food Authorities (SFA) on a reimbursement basis to assist in purchasing equipment to serve healthier meals that meet the updated meal pattern requirement, improve food safety, and expand access.

Each SFA participating in the federally funded NSLP is eligible to submit an application for schools under its jurisdiction. An SFA is defined as a governing body that is responsible for the administration of one or more schools and has the legal authority to operate the NSLP therein. Although all NSLP SFAs are eligible to apply, priority will be given to schools 1) that have higher percentages of students eligible for free and reduced-price meals. (If needed, refer to the FY 2016 eligibility listing posted at

2) that did not receive equipment assistance grants since FY 2009 (If needed, refer to the "Previously Funded" listing at

www.isbe.net/nutrition/htmls/nslp\_grant.htm.); 3) that demonstrate high need, i.e., are able to show they are in an underserved area, have limited access to other resources/funding to purchase equipment, or have equipment that is is outdated, nonfunctioning, or nonexistent; 4) that demonstrate how these funds will improve the quality of school meals; 5) that commit to implementing strategies for adopting smarter lunchrooms; 6) that participated in the School Breakfast Program (SBP) in SY 2015-16; and 7) that are self-prep and/or satellite meals to other schools participating in NSLP. Refer to "Review Criteria."

The grant period will begin no sooner than Jan. 1, 2017, and will extend from the execution date of the grant agreement until June 30, 2018. All funds must be expended by the end of the grant period and the final Claim for Reimbursement for NSLP Equipment Assistance Grant funds, including invoices, must be received no later than July 31, 2018.
