Congratulations to Dr. Jason Henry, superintendent of Sesser-Valier Community Unit District 196, for being named the 2017 Illinois Superintendent of the Year by the Illinois Association of School Administrators! Dr. Henry has been an educator for 22 years; he previously served as a high school math teacher, elementary and junior high principal, and superintendent of Zeigler-Royalton Community Unit School District 188. Dr. Henry's commitment to community engagement serves as a model for us all. His accomplishments at Sesser-Valier include partnering with Monsanto to provide students with enriched STEM opportunities and implementing a privately funded "LIFE 101" curriculum to help students develop skills such as personal financial management and budgeting. Under Dr. Henry's leadership, the district's co-teaching program at the junior high and high school – which matched a special education teacher with a regular education teacher in English, language arts, and math classes – helped reduce the percentage of students identified as needing Individualized Educations Plans from 21 percent to 14 percent. Dr. Henry, thank you for your service!

ISBE Hosting Informative Webinar Nov. 30

The steps we take toward preparing all students for college and career must include trying new approaches to unlocking each student's potential. ISBE recently launched a call for applications for the Competency-Based High School Graduation Requirements Pilot. The pilot will allow up to 12 innovative school districts to replace high school graduation requirements with a competency-based learning system of the district's design. In competency-based learning, educators assess and advance students based on demonstrated mastery of specific skills, abilities, and knowledge rather than on time in the classroom. Reminder From DCFS Regarding Suspensions and Expulsions

Illinois Department of Children and Family Services (DCFS) Guardianship Administrator Debra Dyer-Webster would like to remind all Illinois school districts of their obligation to notify her when children committed to her guardianship face possible suspension or expulsion. If youth in care have a serious discipline issue that involves suspension or expulsion, she can be notified by faxing a written report to the Office of the Guardian, School Discipline Division at (312) 793-3546. If the discipline involves

police or law enforcement, the Office of the Guardian should be called immediately at (312) 814-8600.

Charter Schools

Charter Schools Program Quality School Options Grant

In September 2015, the Illinois State Board of Education was awarded a federal Charter Schools Program Quality School Options Grant in the amount of \$42 million for a five-year term. These funds are intended to provide financial assistance to new charter schools for allowable activities during the program design phase and start-up costs in the first two years of operation. This competitive grant will be awarded through multi-cohort competitions throughout the term of the grant. The second cohort Request for Proposal will be released in January 2017. High-quality applications may be awarded up to \$950,000 for up to three years for the design and implementation of a new charter school.

Charter schools can provide a necessary choice for schoolchildren and their parents across the entire state. Often it is a lack of funding that impedes the best-designed plans, and these funds could provide a crucial source of funding for the start-up of a new school.

District administrators, teachers, parents, community members, and local leaders are encouraged to have a conversation as to whether a charter school would provide a valued option for schoolchildren in their community.
