Hello,

As a former superintendent, I know that certain anxieties tend to develop this time of year when you're waiting for state funding and policy changes as you plan for the new school year. I want to do all I can to help ease those concerns, starting with information on when ISBE intends to release fiscal year 2020 Evidence-Based Funding (EBF) distribution

amounts. As you know, EBF calculations utilize a wide range of data sets that must be processed before distributions are made. Now that statewide enrollment and other numbers are finalized, calculations will be posted the week of Aug. 5. We anticipate the first EBF payment will be provided on Aug. 10.

We are also developing resources to help address concerns regarding the teacher shortage. There are currently various bills that are making their way through the legislative process. ISBE will continue to keep the field updated on the status of these bills and provide information on how this may affect teacher licensure candidates. ISBE is also developing an online tool and guidance documents on flexibility in teacher assignability offered in current rules. Look for that information to be released in the next few weeks as well.

A reminder to superintendents: Any time you have a question or concern, don't forget that ISBE senior staff are always just a phone call away. The Superintendents-Only Support (SOS) Line is active, ready to assist with any questions or concerns superintendents may have throughout the workday. Superintendents will receive an email with additional details regarding the SOS Line. Don't hesitate to give the SOS Line a call.

Illinois Virtual School Teacher Shortage Support

The Illinois Virtual School (IVS) has supported more than 2,000 enrollments from close to 25 partner schools across Illinois with its Full-Class Implementation Model over the past two years. Many of the partners enrolled large numbers of students in a virtual course due to an unexpected teacher vacancy or because of the challenges precipitated by the current teacher shortage.

IVS, which was established in 2001, is ISBE's statewide virtual school. It exists to complement the needs and goals of Illinois' public, private, and homeschool students. IVS recognizes the shared responsibility across the state to commit to equity and to ensure all students are college and career ready and have access to effective educators. More than 90 percent of the IVS instructors hold master's degrees, including the majority who are subsequently employed full time at local public or private high schools across Illinois. IVS can work with any district or school that anticipates a staffing shortage in a particular subject area or course to offer a custom learning solution that meets those needs. The program will deliver CTE conferences in two different geographical locations of the state to include conference activities that align with the statewide definition of career and technical education, ISBE's Board goals and equity principles, the Every Student Succeeds Act State Plan, the Perkins V: Strengthening Career and Technical Education for the 21st Century Act, and the Illinois Workforce Innovation Opportunity Act. This joint contract, through the EPP, allows for ISBE to certify education purchasing contract(s) in which educational entities, including school districts, cooperative entities made of up of school districts, Regional Offices of Education, and charter schools, may purchase supplies, materials, equipment, or services **without** the necessity of engaging in bid solicitation at the local level. This translates to purchasing power for school districts.

Reminder: Radon Testing and Reporting

Sections 10-20.48 and 34-18.39 of the Illinois School Code recommend that school districts test their school buildings for radon levels every five years. For more information regarding radon testing and to learn more about the harmful effects of high radon levels, please contact the Illinois Emergency Management Agency's Radon Program at (217) 782-1325. School code requires that results of radon testing of a public school building be transmitted to ISBE. They may be mailed to the Illinois State Board of Education, School Business Services, 100 North 1st Street, Springfield, Illinois 62777. Reminder: Quartile Rankings for FY 2020 Administrative Costs Now Available

Quartile rankings for the Fiscal Year 2020 Limitation of Administrative Costs Worksheet have been completed and can be found on the [ISBE Limitation of Administrative Costs page](/Pages/Limitation-of-Administrative-Costs.aspx) (/Pages/Limitation-of-Administrative-Costs.aspx).

School districts with administrative expenditures in the 25th percentile or below, commonly called the 4th quartile, may waive the limitation following a public hearing and with the affirmative vote of at least two-thirds of the members of the school board. An eligible district that realizes that its Limitation of Administrative Costs budgeted for FY 2020 is going to increase greater than 5 percent can plan to hold a

hearing to waive the limitation on the same day as the hearing to adopt the FY 2020 budget. The district may approve the administrative cost waiver at the same meeting as it approves its FY 2020 budget. Alternatively, this hearing could also be held on the same day as any regularly scheduled or special board meeting.

Districts are welcome to use the sample resolution located at the above referenced webpage for the 4th quartile administrative costs waiver.

Any district waiving the limitation shall notify ISBE within 45 days after such action is taken. Districts can accomplish this by sending a copy of the approved and signed board resolution as an email attachment to finance1@isbe.net (mailto:finance1@isbe.net).

2019 REPORT CARD

Report Card Open Forum/Superintendent Signoff Details – Aug. 6

Join members of the Report Card team from **10-11:30 on Aug. 6** to discuss the new function in the Data Review and Verification Tool (DRVT) that allows superintendents to certify their district Report Card data. Certification is required for ALL districts and is due on Sept. 9, 2019. The certification feature will go live in the DRVT on Aug. 17, giving superintendents just over three weeks to review their Report Card metrics and certify their accuracy.

Additionally, representatives from the Employment Information System, Student Information System, and assessment teams will be on hand to answer any questions about the Report Card process.
