Message From State Superintendent Christopher A. Koch

It was a very busy year for education in Illinois. We made major progress in moving forward with what I believe are among the most important reforms in education in decades, while at the same time battling budget uncertainty and an uncertain political climate as competitive statewide elections were contested that will directly impact our classrooms this coming year and into the future.

Many of us were focused on Illinois' efforts to secure Race to the Top funding for the students of Illinois. By all accounts, we put together one of the best applications, but we fell short. I am disappointed that we did not receive the funding, but I am not disappointed with the efforts we invested to prepare the application. The benefits from your efforts will drive education in Illinois for years to come. Thank you.

The state's budget difficulties continued to be a problem for all of us. The backlog of bills in the Comptroller's office was regularly more than \$1 billion, forcing all of us to make some difficult decisions. As a result, some good programs suffered. We were forced to think differently about how we did business, looking to save time and money wherever possible. The budget woes are likely to continue into the future, but despite the challenges we faced and still face together, 2010 turned out to be a great year for our students.

In the News	

- Illinois State Board of Education adopts new learning standards: In June 2010, Board members approved new K-12 Common Core State Standards in English and math. These new benchmarks provide "fewer, clearer and higher" standards that will better prepare Illinois students for success in college and the work force in a competitive global economy.
- Illinois leads efforts to create new student assessment system: Illinois is one of 11 states serving on the Partnership for the Assessment of Readiness for College and Careers' governing board. These 26 states are pooling resources for an internationally benchmarked assessment system that will greatly increase the number of graduating students who are ready to succeed. The new assessments will be ready for states to administer by the 2014-15 school year.
- State testing trends show improvement: The overall average score for all state tests increased to 76.4 in 2010, up from 75.5 the previous year. Students in grades 3-8, who take the Illinois Standards Achievement Test, boosted the overall ISAT score to 80.9 from 79.8. And students with disabilities who take the Illinois Alternative Assessment also showed a combined increase, 68.6 in 2010, up from 66.5 in 2009.
- Illinois' Class of 2010 ACT scores leads all universal ACT states: Of the eight states that test at least 90 percent of their students, Illinois was No. 1 with a composite ACT score of 20.7. In addition, while the national average composite score has seen a slight dip in the past five years, Illinois has seen a slight increase, from 20.5 in 2006 to 20.7 in 2010.

- Record number of Illinois students take AP exams: The sixth annual AP Report to the Nation not only showed a record number of Illinois students taking AP exams among all categories (gender, ethnicity and economic status), but also showed the state in the upper half of the nation (18th) for the number of high school seniors who scored a 3 or higher on an AP exam.
- Illinois among 11 states to pilot 12th grade NAEP; students led the pilot in reading: Illinois volunteered to take part in a National Assessment of Educational Progress (NAEP) pilot in reading and math at grade 12 as we implement the more rigorous Common Core Standards to better prepare students for college and career. Results showed that Illinois 12th graders performed at the national average in math but scored higher than the national average in reading. Out of the ten other states that received scores, only one state, Florida, had similar demographics and size as Illinois. In both math and reading, Illinois performed better than Florida.
- New, rigorous teacher and principal evaluations: The Performance Evaluation Reform Act of 2010 implements new teacher and principal evaluations statewide that must incorporate measures of student growth and professional practice. The Performance Evaluation Advisory Council is now working to advance these changes, develop a state template, and develop an evaluator training program.
- Independent alternative teacher and principal preparation programs: Gov. Quinn signed a bill into law that amended the School Code to allow for alternative certification programs to be offered by either institutions of higher education, not for profit entities, or a combination of higher education and not for profits. All entities, both higher education and not for profits must meet the same standards and be approved by the State Board of Education.
- Overhaul of the state's principal preparation and certification requirements: A new law provides that, beginning on July 1, 2014, the general administrative endorsement shall no longer be issued and instead individuals completing approved programs shall be issued a principal endorsement. All current programs must be redefined to meet new requirements and be approved by the State Teacher Certification Board and the State Board. No new candidates may be enrolled in current programs after Sept. 1, 2012. Highlights include more rigorous selection criteria and assessments and internship requirements as well as increasing the number of years teaching required prior to attaining principal endorsement.
- Illinois awarded second grant for Longitudinal Data System: The agency was awarded a second competitive grant to continue development of the Illinois Longitudinal Data System. The grant has four major goals: establish a statewide transcript system for middle and high school students, integrate student-level data with teacher and administrator data, continued expansion and development of postsecondary education data system, expansion of the early childhood data collection system.
- Illinois recognized for collaborative efforts to build student data system: The Data Quality Campaign singled out Illinois and its education leaders for work toward ensuring the state builds a pre-K through college data system to better prepare students for success after graduation.
- Illinois takes on education leadership roles at the national level: In November, State Superintendent of Education Christopher A. Koch was named president of the Council of Chief State School Officers, and Deputy Superintendent Susie Morrison was named to the CCSSO Deputies Leadership Commission, giving Illinois seats at the table during a crucial time of examining education policy across the country. In addition, ISBE Board Chairman Jesse H. Ruiz was picked to serve on a national panel to make policy recommendations on federal education legislation, and Board Vice Chair Dr. Christopher J. Ward and Board Secretary Dr. Vinni M. Hall were named to national task forces on key educational issues.
- Illinois celebrates the 25th anniversary prekindergarten program: ISBE marked 25 years since the establishment of the state's Prekindergarten Program for Children at Risk of Academic Failure. The nationally-recognized program has offered services to more 800,000 3- and 4-year-olds across the state through the years and remains a top priority.

- Illinois leads nation in bilingual services for Pre-K: The Illinois State Board of Education approved rules requiring language support services for English language learners in public preschools. The rules stem from a 2009 law that requires bilingual education extend to preschool. Illinois is the first to mandate such services to better prepare English Language Learners for success in school and help bridge the achievement gap.
- School Improvement Grant helps pave the way: Illinois, which secured \$146 million to help carry out interventions in its lowest-performing schools, is a leading state in a partnership with Mass Insight Education and Research Institute to identify and implement strategies to turn around struggling schools.
- Nearly 1,000 schools recognized on Illinois Honor Roll: ISBE recognized 975 high performing schools on the annual Illinois Honor Roll. The Spotlight Schools award went to 425 high-poverty, high-performing schools that are showing gains in overcoming the achievement gap. Academic Excellence awards went to 438 schools that have maintained high-performance over at least three years. And 147 schools were honored for showing substantial gains over three years, earning the Academic Improvement award.
- Agency distributes nearly \$1.5 billion additional federal funds: The agency distributed more than \$1.34 billion in funding to schools from the American Recovery and Reinvestment Act during 2010, bringing the total additional funds distributed by the agency under ARRA to \$3 billion. In addition, staff distributed almost \$120 million to schools through the Education Jobs Fund Program.

2010 was a great year and even though it has just started, I have high hopes for 2011. Thank you for all you do every day for our students. Their success is yours.

Mandatory Period of Silence Found Constitutional

On Oct. 15, 2010, the U.S. Court of Appeals for the Seventh Circuit reversed the decision of the U.S. District Court and determined that Section 1 of "The Silent

Reflection and Student Prayer Act" (the "Act") is, on its face, constitutional. On Dec. 30, 2010, after denying the Plaintiff's Petition for Rehearing, the Seventh Circuit issued its mandate, which requires the District Court to lift the injunction on the Act's implementation. It is anticipated that the District Court will lift the injunction this week, at which time the Act will retake effect. ISBE will send notice via IWAS when the injunction is lifted.

Section 1 of the Act states: "In each public school classroom the teacher in charge shall observe a brief period of silence with the participation of all the pupils therein assembled at the opening of every school day. This period shall not be conducted as a religious exercise but shall be an opportunity for silent prayer or for silent reflection on the anticipated activities of the day."

While Section 1 does not define the length of the period of silence, the Seventh Circuit pointed approvingly to an example of one district that, when the law was in effect, made a school-wide morning announcement that there would be a brief period of silence, and then, after fifteen (15) seconds had passed, the announcer would begin the Pledge of Allegiance.

The Court's apparent approval of this example does not mandate that the brief period of silence must be implemented in that way, and — unless presented with any evidence that the Act is being implemented in an unconstitutional manner — the State Board of Education has no intention to limit Illinois school districts' flexibility to implement in a manner that works best for the district and its students.

demonstrate the qualifications defined in the RFSP. The successful bidders for this solicitation may be contracted for these services in one of two ways:

- Directly by an LEA that has successfully competed for a School Improvement Grant pursuant to Title I, Section 1003(g) of the Elementary and Secondary Act of 1965 or;
- Directly with ISBE to support LEA activities or as part of a direct state intervention. This work will include working with ISBE, the LEA, and the school.

A separate Request for Proposals (RFP) will be used to identify LEAs with eligible Tier I and Tier II schools that will receive Section 1003(g) School Improvement Grants [SIG 1003(g)] in spring 2011 for FY 2012. Recalculation of FY 2011 GSA

On Nov. 19, 2010, the General Assembly voted to override Governor Quinn's veto of SB 2499, making the bill law as Public Act 96-1480. The law requires that beginning in FY 2011, for purposes of calculating General State Aid (GSA) for districts subject to the Property Tax Extension Limitation Law "tax caps" and that span more than one county, the limiting rate and operating tax rate used in the calculation must be the rates of the county where the majority of the district's Equalized Assessed Value is located.

This change resulted in a larger payment for district(s) subject to the law and will require a minor proration to all districts' GSA payments. ISBE staff has finalized the change in payments. The total statewide reduction of payments is \$260,407.24, resulting in prorated payments equal to 99.994 percent of each district's claim amount. The effect of this proration will be applied to the final GSA payment scheduled for June 20, 2011, and is now reflected in the GSA and FRIS Inquiry systems.

All Federal Grants Moving to Reimbursement Model in FY 2012

The Code of Federal regulations at 34 C.F.R. § 80.21 prescribes the basic standard and the methods under which Federal payments are made to subgrantees. The basic standard is that the "method and procedures for payment shall minimize the time elapsing between the transfer of funds and disbursement by the grantee or subgrantee Reimbursement shall be the preferred method when the [advance funding] procedures are not met."

Due to recent audit findings issued by the Federal Office of Inspector General regarding ISBE's Federal cash management procedures and excessive cash balances identified at local education agencies (LEAs), an agency policy decision has been made that beginning with Federal grants approved for FY 2012, ISBE will move to a reimbursement model because it is the "preferred method when the [advance funding] procedures are not met."

MAJOR CHANGES

- LEAs will enter cumulative (i.e. year-to-date) expenditures for reimbursement on a cash basis as Federal funds are needed. LEAs will be reimbursed for actual costs as expenditures are reported for approved grants.
- LEAs are still required to submit quarterly expenditure reports within 20 days following the end of each quarter (i.e. Sept. 30, Dec. 31, March 31 and June 30) but have flexibility to submit interim reports to request Federal funds at the LEA's discretion. LEAs must submit a completion report within 20 days after the project end date.
- LEAs will not be allowed to submit outstanding obligations except on the completion report submitted at the end of the project year (e.g. June 30, Aug. 31 etc.). The current 90 day period is still in effect to liquidate and report outstanding obligations.
- Monthly payment schedules will be removed from Federal grant applications.
- Funding and Disbursement Services staff will voucher more frequently (e.g. once a week) instead of once a month, to ensure the latest submitted expenditures are paid in a timely manner. Federal funds are not delayed and are normally received by the LEA 3-5 business days from the ISBE voucher date.

LEA BENEFITS

- Improves Federal cash management procedures and eliminates LEA excess cash on hand.
- Provides flexibility for LEAs to submit expenditures when reimbursement is needed.
- Eliminates federal interest calculations.
- Eliminates check returns for federal programs.

Rules and Waivers

JCAR, Board Agree to Remove Proposed Changes to Superintendent Employment

On Dec. 14, 2010, the Joint Committee on Administrative Rules (JCAR) and the State Board of Education agreed to remove proposed changes from rules governing the employment of school district superintendents (see

http://www.isbe.net/board/meetings/2010/oct/rules.pdf). Although the rules were revised based on public comment to allow for limited part-time employment and the use of interim superintendents in emergency situations, JCAR believed that the State Board lacked statutory authority to set criteria for employment and recommended the agency seek legislative changes in Section 10-21.4 of the School Code to define what is meant by the requirement "to employ a superintendent."

Therefore the rules (23 III. Adm. Code 1.310) will remain unchanged. Unless and until Section 10-21.4 of the School Code is amended, the State Board will not be enforcing its long-held prohibition against a district's use of interim, or retired, superintendents. Regional offices of education will no longer be monitoring for compliance in this regard, and districts contracting with interim or retired superintendents will see no change in their

recognition status. The State Board is not seeking, and at this time has no intention to seek, a statutory change to the School Code to address this issue.

Illinois Energy Now Special Lighting Sale Runs until April 15

The State Energy Office at the Illinois Department of Commerce and Economic Opportunity (DCEO) is announcing a special lighting sale for public sector buildings through its Illinois Energy Now program.

The federal government has mandated that T12 lamps be phased out of production in 2012. Approximately 30 percent of all fluorescent lamps sold in the U.S. are still T12 technology. As a result of the T12 phase out, 70 percent of all T12 fluorescent lamps sold in the U.S. will be phased out by July 2012. This means all public facilities will eventually have to upgrade all of their T12 lighting.

To help the public sector and public schools, the State's Illinois Energy Now program is offering its best incentives to upgrade to high-efficiency T8 or T5 lamps. DCEO's Illinois Energy Now special sale is open to municipalities, park districts, fire districts, public k-12 schools, public universities, community colleges and state and federal facilities within ComEd and Ameren electric service areas.

The Illinois Energy Now special sale is from Dec. 13, 2010, to April 15, 2011. Applicants seeking the Illinois Energy Now Special must submit an addendum along with the standard application and follow the Public Sector Electric Efficiency Program Guidelines and specifications posted at http://www.IllinoisEnergy.org (follow the Illinois Energy Now link). Incentives cannot exceed 100 percent of project cost.

The Illinois Energy Now program offers a portfolio of electric efficiency programs to achieve targeted annual energy savings goals. The Energy Efficiency Portfolio Standard was signed in to law August 2007, giving Illinois among the most ambitious energy efficiency standards in the nation. This initiative required Illinois utilities to reduce overall electric usage by 0.2 percent of demand in 2008, climbing to 2 percent by 2015. This

portfolio creates a substantial budget for programs and incentives to reduce electric energy usage and demand for customers of ComEd and Ameren.

Webinar on Whole Grains for Healthy School Meals Scheduled for Feb. 10

According to the Whole Grains Council, 40 percent of American teenagers do not eat any whole grains. Through a USDA Team Nutrition Training grant, the Illinois Nutrition Education and Training (NET) Program is teaming up with the Whole Grains Council to help schools increase the number of whole grain foods offered to students by providing a free webinar on whole grains from 2-3 p.m. Thursday, Feb. 10, 2011.
