## Message From State Superintendent Christopher A. Koch

Happy New Year! I know this is a hectic time for all of us as we try to meet some very tight timelines, but I hope you were at least able to get some time for yourself, to spend with family and friends, over the holiday break.

The quarterly jobs reporting for the American Recovery and Reinvestment Act of 2009 is due tomorrow. The federal Office of Management and Budget issued clarifying guidance late last month that I know has been communicated to you already. More information about that guidance follows later in this Weekly Message. I ask you to please review this and submit your report to us as soon as possible.

We are in the process of preparing Illinois' Race to the Top (RT3) application, which is due in Washington on Jan. 19, 2010. As part of the evaluation process, the U.S. Department of Education will consider the commitment of local districts to participate in RT3 and whether that commitment will allow for the State's reform plan to have sufficient impact. As part of this application process, we are asking you to sign a Memorandum of Understanding to show your district's willingness to partner with us, which we will in turn submit to Washington with our application.

At a minimum, the Superintendent for each district must sign on. But we will receive additional consideration if local board presidents and local union leaders sign on as well. We are asking that you return the signed and completed MOU's to <a href="mailto:rt3mou@isbe.net">rt3mou@isbe.net</a> by Jan. 11, 2010. We know this is a very tight timeline and may require you to call a special board meeting this week to review the MOU. Please know that I, along with several other state school chiefs, asked for additional time from the feds, but were denied.

I want to thank those of you who joined us for the Race to the Top Webinars on Dec. 18. Several hundred of you were able to go over the application and MOU in greater detail. For those of you who were unable to participate, you can review the Webinars at <a href="http://www.isbe.net/racetothetop/">http://www.isbe.net/racetothetop/</a>. Whether or not to sign the MOU is a local decision. But as many of you have already noted to the reforms are ones

not to sign the MOU is a local decision. But as many of you have already noted to me, most of these reforms are on to which we as an education community have already committed. The additional RT3 funding simply allows us to move much more quickly to implement them.

The Race to the Top is a highly competitive grant process open to all states. Secretary Arne Duncan has said most states will not receive funding in this first round. However, we are still developing an application because if we're not initially successful, we will gain valuable feedback for a second round application.

If selected, Illinois could receive in excess of \$400 million, half of which would be distributed to participating districts and the other half would be retained by ISBE for implementation of statewide reforms. RT3 funds may only be used for those purposes specifically spelled out in our application and may not be used for other purposes such as General State Aid.

Have a great 2010! Remember to date all checks and other documents with the new year.

# **Quinn Appoints New Members As Joyce Karon Completes Term**

James Baumann of Lake Bluff, Steven Gilford of Evanston and Melinda LaBarre of Springfield were appointed last month to the Illinois State Board of Education by Gov. Pat Quinn. They fill two vacancies on the board and replace board member Joyce Karon.

Baumann is the president and chief executive officer of American Recreation Products Inc. He has served on the Board of Directors for the Golden Apple Foundation since 1992, a non-profit organization that honors and supports excellence in teaching.

Gilford is a senior partner in the Litigation and Dispute Resolution Department, co-head of the Insurance Recovery and Counseling Group, and head of the Chicago office of Proskauer Rose. He served as a member of Evanston Township District 202 School Board from 1993 to 2005, including a term as president from 1996 to 1998.

LaBarre started as a teacher in Springfield District 186, where she went on to serve as a principal for two schools in the district and later as a consultant for the Ball Education Foundation. LaBarre served as a member of the Springfield School Board from 2003 to 2009.

The governor appointed Karon to the P-20 Council, an advisory panel that will make recommendations to Quinn about strengthening Illinois' education system, including working on Race to the Top. Karon was appointed to the Illinois State Board of Education in 2003.

# American Recovery and Reinvestment Act

#### Dec. 31 ARRA Reporting Deadline Jan. 5

All local education agencies (LEAs) must report American Recovery and Reinvestment Act (ARRA) data for the period ending Dec. 31, 2009, on or before Tuesday Jan. 5, 2010.

Reporting must be completed for all LEAs that have applied for and/or received ARRA funds. Required ARRA data includes two primary elements: the number

of jobs created/retained reflected as full-time equivalent and any vendor payments that were \$25,000 or more. ARRA data must be reported regardless of whether any jobs were created/retained or a payment was made to a vendor of \$25,000 or more.

Significant modifications have been made to ARRA reporting through the Electronic Expenditure Reporting System since Sept. 30. Please read the updated detailed instructions and procedures which can be accessed at <a href="http://www.isbe.net/arra/pdf/arra\_reporting\_inst.pdf">http://www.isbe.net/arra/pdf/arra\_reporting\_inst.pdf</a>.

The two major changes include:

ARRA data can be reported separately from expenditure data. This modification allows LEAs to submit quarterly ARRA data only without having to prepare and file expenditures at the same time. LEAs have the option of submitting ARRA data and expenditures at the same time if they are prepared to do so. But expenditures are not required to be submitted by the five calendar day deadline following the end of the reporting period. If the LEA elects to file ARRA data only, an expenditure report must be submitted within 30 days from the end of the reporting period (i.e. Dec. 31 expenditures due Jan. 31, 2010).

ARRA data can be submitted even if ARRA funds have not been received. LEAs that have applied for ARRA funding but are waiting for final approval of their grant can report ARRA data. LEAs that may have hired/retained a staff person and/or made a vendor payment of \$25,000 or more with local funds in anticipation of the ARRA funding can report this information prior to actually receiving funds. This capability is only available for ARRA grants contained within the electronic Grants Management System (i.e. Title I and IDEA Part B Flow Through and Preschool).

#### **Other Important ARRA Reminders**

The American Recovery and Reinvestment Act of 2009 (ARRA) is an unprecedented effort to stimulate the economy in the short term and invest in education and other essential public services to ensure the long-term economic health of our nation. Illinois will receive over \$3 billion in stimulus funds for education. State and local education agencies are charged with ensuring that all ARRA funds are spent prudently with an extraordinary level of transparency. With that in mind,

please be mindful of the following information and critical issues:

**ARRA Allocations and Disbursements:** ISBE updates ARRA allocations as they are determined. Disbursements are updated each month.

Proper Segregation: All ARRA funds must be accounted for separately on the revenue and expenditure side of the ledger. All Federal grant programs, including ARRA programs, are assigned a unique Catalog of Federal Domestic Assistance number (CFDA). In accordance with ARRA requirements, ISBE has assigned a unique four digit revenue code for all ARRA funds. A summary of all ARRA programs, total grant award, ISBE revenue code and CFDA number can be found on our ARRA home page at

http://www.isbe.net/arra/default.htm. Expenditures by all local education agencies (LEAs) must be documented by Fund, Function, Object and ARRA Revenue Code. LEAs are required to follow Part 100 administrative regulations (Requirements for Accounting, Budgeting, Financial Reporting, and Auditing) which can be accessed at

Cash Management: Federal regulations prescribe basic standards and methods under which Federal payments are distributed from the Illinois State Board of Education to LEAs. Although reimbursement is the preferred method, federal regulations allow for LEAs to be paid in advance as long as the time elapsed between the receipt of the federal funds and actual expenditures at the LEA are minimized. It is imperative that all LEAs examine the monthly payment schedules on their Federal grant programs to ensure that the receipt of Federal funds correspond as closely as possible to anticipated expenditures to avoid excess cash. While this standard applies to all Federal programs, it is especially important for LEAs as ARRA funds are received. If the LEA

anticipates that receipt of Federal funds will exceed anticipated expenditures, please contact the Division of Funding and Disbursement Services at 217-782-5256 for procedures on making a payment schedule adjustment.

Salaries and fringe benefits are normally expended in equal intervals and should be projected in this manner. When teachers are paid on a 12-month salary basis and the project period is for nine months, the three months' salaries and related fringe benefits paid after the project ends (and after the service has been rendered/activity has occurred) should be included in the last project payment. Equipment, supplies, contracted services and in-service activities should have the payment requested in the month for which the expenditure is anticipated. Expenditure reports are required to be submitted for each Federal program on a quarterly basis. Excess cash is determined when expenditures plus outstanding obligations are less than the funds received through each quarter. Any positive balance will be frozen from the next scheduled payment(s) for the LEA until a subsequent expenditure report is submitted with a zero or negative balance.

Accumulated Interest: In addition, Federal regulations address requirements when interest is earned on Federal cash advances. Specifically, the regulation states: "[G]rantees and subgrantees shall promptly, but at least quarterly, remit interest earned on advances to the Federal agency. The grantee or subgrantee may keep interest amounts up to \$100 per year for administrative expenses."

It is recommended that LEAs create a separate account specific for the receipt of Federal funds. Per the Federal rule, if interest is earned greater than \$100, a check must be remitted "promptly, but at least quarterly". ISBE is implementing a procedural change in returning Federal interest checks. Effective immediately, all interest checks must be remitted to: Illinois State Board of Education, Division of Funding and Disbursement Services, 100 N. First St., Springfield, IL 62777.

ISBE will return the aggregate amount of all interest checks received to the appropriate Federal agency.

Timely Reporting: Section 1512 of ARRA requires reports on the use of ARRA funding by each agency that awards ARRA funds (e.g. ISBE) no later than the 10th day after the end of each calendar quarter. Due to the short timeline, LEAs must transmit ARRA data within five calendar days to ISBE from the end of each quarter so that the ten day submission requirement is met. Reports not submitted on or before the five day calendar deadline will result in a freeze of future scheduled payments for the respective ARRA program. ARRA reports are aimed at providing transparency and accountability for the use of these funds. In addition to the normal collection of quarterly grant expenditures, ARRA requires that LEAs include the following detailed information:

- The number of jobs created or retained reflected as full-time equivalent (FTE);
- Vendors that receive a payment of \$25,000 or more.

Central Contractor Registration Requirement: Each LEA receiving ARRA funds must register with the Central Contractor Registration (CCR) site. CCR is the primary registrant database for the U.S. Federal Government. CCR collects, validates, stores and disseminates data in support of agency acquisition missions. There is no cost to registrants. LEAs must secure a D-U-N-S number prior to registering with CCR. # School Level Expenditure Report Requirement

A new school level expenditure report is being required per the American Recovery and Reinvestment Act of 2009 (ARRA) for local education agencies (LEAs) that are entitled to funds under Title I, Part A of the Elementary and Secondary Education Act (ESEA) provided under ARRA (i.e., LEAs that are entitled to ARRA Title I funds calculated under the Targeted Grant and Education Finance Incentive Grant formulas). Such LEAs are required to report school-by-school expenditures from state and local funds for the 2008-09 school year for all of their schools (not just Title I schools). The U.S. Department of Education states that they will use these data to examine the extent to which school-level education resources are distributed equitably within and across LEAs.

To facilitate this required reporting, we are creating a new IWAS application. While the application is not yet available, we did want to alert school districts to this new reporting requirement. Our intent is to have this system available in January, as the report of this data is due to the Department of Education by March 31.

This specific report is focused on only state and local fund expenditures for Regular K-12 instruction, within four categories:

- Personnel salaries at the school level for all school-level instructional and support staff.
- Personnel salaries at the school level for instructional staff only.
- Personnel salaries at the school level for teachers only.
- Non-personnel expenditures at the school level (if available).

An Excel worksheet will be available for download and completion. The specific function and object codes, per Part 100 Requirements for Accounting, Budgeting, Financial Reporting and Auditing, will be provided to assist in the calculation of reporting data per school.

School level expenditures to be excluded from this report include those:

- From federal program funds.
- From special education funds.
- Not associated with regular K-12 programs, such as preschool and adult education.

- That serve students from more than one school attendance area, such as summer school.
- Expenditures for employee benefits.

# **Estimated Best Three Months Average Daily Attendance IWAS Application**

The annual "Estimated Best Three Months Average Daily Attendance" application is available on IWAS. We request that the estimate be provided to the Illinois State Board of Education on or before Jan. 15. The figure you will report is the estimated best three months average daily attendance for the 2009-10 school year.

The estimates you provide will be used as a resource by the General Assembly to determine the General State Aid (GSA) appropriation level for the 2009-10 claim year payable during Fiscal Year 2011. Accurate estimates are critical for district level budget purposes, as projected GSA entitlements will be based on these estimated figures.

## New Census Estimates Released for FY11 Title I Low Income

The U.S. Department of Education has released the Small Area Income and Poverty Estimates (SAIPE) for income year 2008. These estimates will be used to calculate FY11 Title I Allocations. A file of 2008 Poverty Data, by Local Education Agency (LEA) is provided in an alphabetical listing of LEAs, Poverty Count, 5-17 Population, Poverty Percentage and Total Population at <a href="http://www.isbe.net/funding/excel/census\_poverty.xls">http://www.isbe.net/funding/excel/census\_poverty.xls</a>.

With this data, LEAs can determine their potential eligibility for Basic, Concentration, Targeted and Education Finance Incentive Grants (EFIG).

**Basic Grant eligibility:** An LEA must have at least 10 poverty children and the number of poverty children must be greater than 2 percent of the LEA population of children ages 5-17.

**Concentration Grant eligibility:** An LEA must have at least 6,500 poverty children or the number of those children exceeds 15 percent of the total 5-17 population.

**Targeted and EFIG grant qualifications:** An LEA must have at least 10 poverty children and that number must be at least 5 percent of the 5-17 population.

The following link to the Census Bureau, <a href="http://www.census.gov/hhes/www/saipe/index.html">http://www.census.gov/hhes/www/saipe/index.html</a>, provides various aspects of the SAIPE count. We will be using the 2008 data to calculate SY 2010-11 Title I, Part A allocations because they are the most recent available data.

Superintendents, business managers and Title I directors should carefully examine the data for their LEA as this will be the first indication as to whether your LEA may be gaining or losing in eligibility for Title I funds in FY11. ISBE neither controls nor generates the data.

Note that this preliminary data does not include other non-census information, such as foster, neglected or delinquent counts that may be used to calculate Title I allocations.

# School Bus Communication Device Changes – Public Act 96-0818

Senate Bill 0932 was recently signed into law as Public Act 96-0818 with an effective date of Nov. 17, 2009. This Public Act makes changes to the Illinois Vehicle Code regarding pre- and post-trip school bus inspections and school bus driver communication devices.

A number of inquiries have been received regarding the new provision in Section 12-813.1(e) of the Vehicle Code [625 ILCS 5/12-813.1(e)], which requires school buses to contain and utilize two-way radios while the bus is in possession of a school bus driver. Inquiries have focused on whether this two-way radio requirement can be satisfied by the bus driver's possession and utilization of a cellular radio telecommunication device that has digital two-way radio service capability.

In light of these inquiries, ISBE staff members have reviewed the new requirement in consultation with Illinois Department of Transportation. Based on legislative intent and given that the changes to this Section do not modify or eliminate the permissibility of cellular radio telecommunication devices with digital two-way radio service capabilities, we have concluded that school buses that contain and utilize such cellular devices with two-way radio capabilities will be in compliance with the new requirement.

Unfortunately, more than 100 entities did not submit data, which creates a problem for the Illinois State Board of Education (ISBE) in terms of required federal reporting and other data uses.

ISBE has therefore re-opened the fall data collection through midnight Jan. 8. Entities that have not yet submitted MUST do so by this new (and final) deadline. We ask that you submit as soon as you can and not wait until the last day.

#### **Guide Offers Ways to Prevent and Respond to School Violence**

The Office of Justice Programs' Bureau of Justice Assistance (BJA), in coordination with the International Association of Chiefs of Police, published a new edition of its "Guide for Preventing and Responding to School Violence." Designed to assist local communities, the

guide describes the roles of the school, community, families, law enforcement and justice system in working together to take effective action to address school violence. # Top Rankings Awarded to Illinois Schools With School-based Health Centers

For the third year in a row, the U.S. News and Report has ranked the nation's best high schools and included 70 Illinois schools. Of the 30 Illinois high schools who received the Bronze ranking, three have school-based health centers (SBHCs) and of the 37 Illinois schools with a Silver ranking, two host SBHCs. Evanston Township High School and Lake View High School in Chicago received the Silver ranking and South Beloit High School, Carbondale High School and Urbana High School received the Bronze ranking. Nearly 300 Illinois high schools were eligible for full analysis.

U.S. News analyzed how schools educate all their students; how schools educate their disadvantaged students; and finally, how schools educate their college bound students. Analyses are based on statewide test scores, Advanced Placement tests and International Baccalaureate tests.

It is an undeniable fact that a healthy child is a teachable child, and, today, students are facing a myriad of health challenges that compromise academic potential, such as obesity, asthma, risky sexual behaviors, substance abuse and lack of access to health care.

School-based health centers (SBHCs) function like a doctor's office in a school and provide quality health-care services like immunizations, asthma care and mental health services to students on school grounds or in close proximity to a school. They are predominantly located in communities where student populations experience both health and educational disparities. There are 58 SBHCs in Illinois. Forty school-based health centers reported serving 98 schools in 15 counties across Illinois.

It's no wonder that SBHCs would be present in the list of schools awarded U.S. News' top rankings. They play an integral role in the overall well-being and academic success of students, their families, their schools and their communities. They increase school-connectedness for students and create a learning friendly environment.

#### Food Allergy Guidelines Committee – Public Act 96-0349

By July 1, 2010, the Illinois State Board of Education, in conjunction with the Illinois Department of Public Health, shall make available to each school board guidelines for the management of students with lifethreatening food allergies developed by an ad hoc committee. By Jan. 1, 2011, each school board shall implement policy based on these guidelines. Also, at least every two years, an in-service training program for school personnel who work with students must be conducted by persons with expertise in anaphylactic reactions and management.

Sets forth the process to determine whether sufficient funds are available to serve second-year principals in the mentoring program; allows only second-year principals to be served if funds are insufficient to serve all first-year principals; and makes numerous other changes to update and streamline the program.

#### Part 145 (Temporary Relocation Expenses)

Requires school districts to consider other resources and in-kind contributions when estimating both their ability to repay a temporary relocation loan and the expenses they anticipate incurring because of the relocation; provides for annual renewal applications; and makes other procedural requirements necessary for program accountability and management.
