Teacher Certification

Evaluation of Principals

Public Act 94-1039 requires Illinois public school districts (except those serving cities of 500,000 or greater) to establish a principal evaluation plan in accordance with the law and to conduct principal evaluations by February 1 of each year if the principal is covered by a single-year contract or by February 1 of the final year of the contract if the principal is covered by a multi-year contract. The effective date of the legislation requires that principals with a single-year contract must be evaluated by February 1, 2007.

The evaluation must include a description of the principal's duties, responsibilities, and the standards to which the principal is expected to conform. The evaluation must be performed by the district

superintendent, the superintendent's designee, or (in the absence of the superintendent or designee) an individual appointed by the school board who holds a registered Type 75 State administrative certificate. The evaluation must be in writing and must at least 1) consider the principal's specific duties, responsibilities, management, and competence as a principal, 2) specify the principal's strengths and weaknesses, with supporting reasons, and 3) align with the Illinois Professional School Leader Standards or research-based district standards. The evaluation must be included in the principal's personnel file and the principal must be provided with a copy.

Failure by the district to evaluate a principal and provide a copy of the evaluation to the principal at least once during the term of the principal's contract will be considered evidence that the principal is performing in a satisfactory manner and will automatically extend the principal's contract for a one year period beyond the contract expiration date.

English Language Learning

Assessing English Language Learners (ELLs): A Collaborative Invitation for Educators

As part of a collaborative project, the ISBE Divisions of Assessment and English Language Learning (DELL) and the Center for Applied Linguistics (CAL) are seeking the assistance of local educators to suggest improvements for the ACCESS for ELLs ® Kindergarten ACCESS for ELLs and Kindergarten W-APT test. Specifically, we will be adapting the current tests to the new Pre K-K WIDA standards.

Local educators are invited to facilitate future test development in any of the five ways described below.

- Respond to a survey on how you currently use the K-WAPT test, what you use it for, and your reaction to individual items and to administration procedures.
 This information will guide us in framing the next version of the K-WAPT and maximize use for teachers and administrators. (The survey should take approximately 10 minutes to complete.)
- 2. Allow a representative of ISBE/CAL to view the administration of the Kindergarten ACCESS for ELLs during the IL test window opening January 15, 2007. This will allow us to gather observational data about the strengths and weaknesses of the current test administration protocol and record test samples. This option will require local districts to obtain parental release forms for the recordings. A brief interview with the kindergarten teacher(s) administering ACCESS will follow the observation.
- 3. Serve as an item writer for the new instruments. While the level of effort may vary, CAL will reimburse experienced kindergarten teachers for their time at \$30.00 per hour. In addition to item writing, participating kindergarten teachers will participate in one-day training to be held in Illinois at a time and date still to be determined.

- 4. Serve on an item basis and content review panel in early April 2007. This will be a day long effort held at a still to be determined location. Transportation and per diem expenses will be paid by CAL and the effort will qualify for professional development units
- 5. Allow ISBE Student Assessment/CAL to field test the new test instruments in your district schools during May 2007. These tests will be conducted by staff from CAL.

Legislative Update

Fall Veto Session

The fall Veto Session of the 94th General Assembly wrapped up on Thursday, November 30, 2006. The legislature resumed Sunday, January 7, 2007 to finish final business for the 94th General Assembly. On January 10, new members of the General Assembly will be sworn in and the 95th General Assembly will officially begin.

Veto Session Update

The following legislation passed in Veto Session and is now awaiting further action:

SB 380 –Allows Lincoln-Way Community Unit School District 210 to increase its general obligation bond debt limitation above the statutory allowance; allows Ford Heights School District 169 the authority to levy a supplemental tax for three years without voter referendum that will provide the district with a total of \$3.2 million; amends the definition of "public infrastructure" in the Municipal Code to include public school buildings in the Village of Forsyth, thereby allowing the village to impose referenda-approved sales taxes in order to fund school construction and maintenance; permits Oak Park River Forest Community High School District, Oak Park School District 97 and River Forest School District 90 to withdraw from the jurisdiction and authority of the Proviso and Cicero Township Trustees of Schools and Township School Treasurer. This would be allowed to be done by School Board Resolution, not by referenda, as is currently required - Vetoed by Governor; Senate voted to override; awaiting vote in House on override motion

The following legislation passed the General Assembly in Veto Session and has gone to the Governor for action:

- <u>SB 1856</u> Repeals obsolete and duplicative sections of the School Code
- <u>SB 2762</u> The statute on physical education was amended a couple of years ago to allow a school board to excuse students in grades 9 through 12 from physical education if that time was needed to receive special education services. SB 2762 expands the grade range from grade nine to grade three3 and states that it is not a school board determination that the parents or guardian must agree. It also sets up parameters for situations where there is no agreement between the school and parent/guardian.
- <u>SB 2796</u> Makes changes to Due Process Hearing Procedures for Special Education

This legislation has been enacted into law:

• SB 2477 (Public Act 94-1071) - Changes the definition of "municipal corporation" until July 1, 2011 to include a school district that (i) was organized prior to 1860, (ii) is located partly within a city originally incorporated prior to 1840, and (iii) entered into a lease with a Public Building Commission prior to 1993, and its board of education. The Governor amendatorily vetoed this bill in July. During Veto Session, the General Assembly overrode the veto and it has now become law.

Register weather radios

21st Century Community Learning Centers Request for Proposals

The Federal Grants and Programs Division announces the release of the Fiscal Year (FY) 08 21st Century Community Learning Centers program Request for Proposals (RFP) that can be accessed at http://www.isbe.net/21cclc. The FY 08 grant will provide funds in the amount of \$12 million for quality, out of school programming for Illinois students attending low performing, high poverty schools.

These centers provide students with academic enrichment opportunities, as well as artistic, cultural, and recreational activities to complement their regular academic programs. Eligible applicants include local education agencies, charter schools, area vocational centers; community based organizations, including faith-based organizations; or other public and private entities. ROEs/ ISCs may apply for funds to coordinate and carry out activities for LEAs, participating organizations, or a consortium of eligible applicants. Proposals are due March 16, 2007 by 5 p.m.

Current grantees from FY 04, 05 and/or FY07 cohorts may apply for new funds if the funds will be used to expand or enhance current activities, e.g., to serve additional grade levels or establish programs in schools within the district that are not now participating in the program. Current grantees (FY 03 cohort) in their fifth year of funding may apply for funds as if they were a new applicant provided that the proposed use of funds meets the requirements of the program.

Abraham Lincoln Presidential Library and Museum Teacher Workshop Series

The Education Department of the Abraham Lincoln Presidential Library and Museum (ALPLM) announced its calendar of complimentary workshops for educators. Created in conjunction with the upcoming temporary exhibit on Mrs. Lincoln, "Meet Mary Todd Lincoln" will be held on Wednesday, March 7 from 3:30 p.m. to 5:30 p.m. This workshop will explore the fascinating life of Mary Todd Lincoln from her childhood, her courtship with Lincoln, their marriage, family life and the joys and sorrows of life as the wife of a famous politician and president, during one of the most dramatic eras in our nation's history. Examine primary documents and artifacts, read her letters and step into her world. Classroom activities addressing Illinois Learning Standards will be presented.

On Wednesday, March 28, from 3:30 p.m. to 7:30 p.m. and on Saturday, April 14, from 9 a.m. to 1 p.m. the Education Department will offer its "Teacher Orientation" workshop. This four-hour workshop will introduce educators to the resources available at the Abraham Lincoln Presidential Library and Museum. Educators will learn how to schedule a tour, how to prepare their class for a visit and methods for making the most of a school trip to the Museum. In addition, participants will find out how to access digital resources from the Library collections, how to utilize the Library for research and other opportunities for professional development and classroom activities available through the ALPLM Education Department.
