## Message From State Superintendent Christopher A. Koch

Most schools are now back in full swing after the winter holidays and extremely cold weather.

The New Year also provides an opportunity to reflect on the successes we've accomplished together in 2014. Working together, we are improving outcomes for students and our success is being noticed. What follows is a list of just a few of the accomplishments we can celebrate together. Please feel free to share within your school communities.

**Illinois receives flexibility waiver**: In April 2014, the U.S. Department of Education approved our waiver to many aspects of the No Child Left Behind Act of 2001. The wavier went into effect this school year (2014-15) and outlines the state's plan to ensure all students are on track to succeed in college and careers

through differentiated accountability, informative data, strong leaders and instructors and support for the neediest schools.

**Illinois recognized for improving preparation and licensure of school principals**: The Education Commission of the States recognized Illinois in July with its Frank Newman Award for State Innovation for our work to improve the preparation and licensure of school principals. The Illinois School Leader Task Force, established in 2007, brought together leaders from pre-K-12 schools, higher education, business and state agencies to develop policy recommendations. As a result of the task force's work, the legislature passed Public Act 096-0903 in 2011, which mandated that universities redesign their programs to align with policy recommendations aimed at increasing the quality and effectiveness of school leader preparation programs. All of this work will lead to higher quality candidates for P-12 principal preparation programs, and ultimately develop more instructional leaders who create powerful teaching and learning environments for educators and students.

**Illinois Report Card ranks best in the nation for accessible accountability reports**: In May, the Education Commission of the States identified Illinois as having the best report card out of all 50 states and the District of Columbia for its accessible accountability reports, according to both researchers and parents. The research report, "Rating States, Grading Schools: What Parents and

Experts Say States Should Consider to Make Accountability Systems Meaningful," measures the accessibility, ease of understanding and adequacy of the data. Illinois was chosen as the clear winner. The 2014 Report Card was released in October with new metrics and capabilities that build on the functionality and enhanced features of the redesigned Report Card, which was introduced last fall. **Revamp underway for arts and social studies standards**: In August, we launched a review of the state's arts and social studies education standards to build on our work to update the Illinois Learning Standards and better prepare students for success after graduation. Two committees were formed to study the current standards, review the standards of other states, and make recommendations for improvements. This latest review follows the Board's approval to implement new learning standards for math, English language arts, physical education and science. (www.isbe.net/news/2014/aug27.htm)

**Illinois students participate in pilot tests to prepare for new PARCC assessments**: Students in nearly half of Illinois schools participated last spring in a limited amount of field testing to prepare for this year's new, more rigorous Partnership for Assessment of Readiness for College and Careers (PARCC) assessment system. These practice tests helped them become familiar with the new exams in English language arts (ELA) and mathematics and provided state policymakers and educators with valuable feedback before the tests were finalized. **Illinois' ACT score ranks among the best**: The Class of 2014 achieved a composite score of 20.7 on the ACT, giving Illinois the second-highest score among the 12 states that tested 100 percent of their graduates. In addition, the percentage of students meeting all four of ACT's College and Career Readiness Benchmarks increased to 26 percent from 25 percent last year. (www.isbe.net/news/2014/aug20.htm)

**Illinois closes equity gap for Latino students on AP exams**: According to the 10th Annual AP Report to the Nation, the percent of Latino graduates who took the rigorous Advanced Placement exams during high school surpassed the total percent of Latino graduates statewide, continuing a decade-long trend of continued Latino participation in these accelerated college-prep courses. **Illinois students' participation and performance on AP exams continues to show gains**: Illinois Hispanic and African American student participation in Advanced Placement tests exceeds the national average, helping a new and more diverse generation of students move into more advanced classes in their postsecondary institution or gain college credit – or both, according to the 2014 College Board Program Results. Illinois ranked 13th in the nation for the percentage of 2013 graduates – 21.5 percent – who scored at least a 3 on an AP exam during their high school career. The national average is 20.1 percent. **State Board approves 'Seal of Biliteracy'**: In September, the State Board of Education moved forward with an initiative that aims to promote mastery in two or more languages. The state is among the first in the country to allow school districts to award a State Seal of Biliteracy for students who demonstrate a high level of proficiency in one or more languages, in addition to English. The seal would be placed on a student's academic transcript and diploma. (www.isbe.net/news/2014/sept2.htm)

**Illinois leads the Midwest in the USDA's HealthierUS School Challenge**: Illinois leads the Midwest region in the number of schools that have earned federal certification for programs and practices that promote healthy habits, primarily physical exercise and nutrition. As of December, 266 schools in Illinois had earned certification through the HealthierUS School Challenge and another 31 were awaiting final notification from the USDA on the national level. **Illinois among five states selected to work with CEEDAR Center**: This past spring, a panel of education experts selected Illinois as one of five states to work with the Collaboration for Effective Educator Development, Accountability, and Reform, or the CEEDAR Center, to better prepare educators to serve Illinois public school students with disabilities and ensure those students are ready to succeed in college and the workforce. **Teacher of the Year and Those Who Excel in education recognized**: More than 230 educators and school staff members were recognized Oct. 25 at ISBE's 40th annual Those Who Excel banquet in Normal. The award ceremony included the announcement of Steven Elza, an automotive technology teacher at William Fremd High School in Palatine, as the 2015 Illinois Teacher of the Year. **Award-winning educators recognized**: The Illinois State Board of Education, along with the Illinois Federation of Teachers (IFT) and the Illinois Education Association (IEA), honored educators from across the state at the fourth annual Exemplary Teacher Recognition Award Luncheon on June 11. The educators were recognized for receiving awards from various professional education organizations during the 2013-14 school year. (www.isbe.net/news/2014/jun11.htm)

**Illinois school named a U.S. Department of Education Green Ribbon School**: Woodland Primary School in Gages Lake was named a Green Ribbon Schools award winner by the U.S. Department of Education. Woodland was one of three Illinois Green School award winners. Also named as Illinois Green Schools were Oak Lawn-Hometown Middle School in Oak Lawn and Evanston Skokie School District 65 in Evanston. (www.isbe.net/news/2014/apr23.htm)

**More than 200 Illinois schools participating in Fresh Fruit and Vegetable Program**: For the sixth year, the Illinois State Board of Education is administering the U.S. Department of Agriculture's Fresh Fruit and Vegetable Program (FFVP). In the last five school years, Illinois has seen FFVP funds increase steadily from \$3.34 million in 2010-11 to this year's \$5.18 million. ISBE approved 218 schools to participate in the program this school year. (www.isbe.net/news/2014/sept10.htm)

**Illinois to receive grants to bolster school safety**: On Oct. 2, it was announced that Illinois will receive nearly \$2 million in federal grants that aim to improve safety in the classroom through both emergency management and comprehensive prevention efforts that address students' social and emotional needs. The funds, funneled through two U.S. Department of Education grants, reflect ongoing state and national efforts to better prepare for school emergencies as well to improve methods of discipline and support for struggling students. **Illinois receives \$1.9 million to increase mental health awareness and responses**: The State Board of Education will expand its efforts to help schools better identify and respond to mental health issues among youth through a \$1.9 million federal grant program called "Project AWARE." A large portion of the funds will be shared among three Illinois school districts to build relationships with their community health providers to better serve students with behavioral health issues. **State superintendent selected to serve on board of national organization of state education leaders**: The Council of Chief State School Officers (CCSSO) selected me to join its Board of Directors. The Council, made up of public K-12 education officials from around the country, works with federal and state agencies as well as Congress on national education policy development and decisions. **State Board of Education member receives national award**: The National Association of State Boards of Education (NASBE) presented Dr. Vinni M. Hall, Board secretary, with the NASBE 2014 Distinguished Service Award on Oct. 17. #### Final 2013-14 IDEA Room and Board Claim Payment Information

The 2013-14 Individuals with Disabilities Education Act (IDEA) Room and Board program is now complete.

Final 2013-14 school year claims exceeded the amount of IDEA Room and Board funds available. Proration was calculated at 71 percent of the final claims. Claims reimbursed from federal IDEA Part B grant funds have been escalating at a rate beyond the set aside amounts the agency retains from our annual IDEA Part B award. The final 2013-14 school year voucher was processed by ISBE on Dec. 22 and released by the Office of the Comptroller on Dec. 29.

**2014-15 School Year**: Due to the projected increase of claims and available IDEA funds for the 2014-15 school year, the estimated proration will be approximately 77 percent; therefore, to avoid potential overpayment, submitted monthly claims will be paid at 60 percent during the year. Once all claims are

finalized in December 2015, final claims and proration will be calculated and paid at that time.

#### Federal Interest Income – Quarterly Reminder

The Code of Federal Regulations, Title 34-Education, Part 80 Uniform Administrative Requirements for Grants and Cooperative Agreements to State and Local Governments, Subpart C-Post Award Requirements, Section 80.21 Payment, requires grantees and subgrantees to promptly, but at least quarterly, remit interest earned on advances to the appropriate federal agency. The grantee or subgrantee may keep actual interest amounts up to \$100 per year gained on federal deposits per bank account, if applicable, for administrative purposes. Grant recipients have discretion to set up account(s) that are non-interest bearing to avoid returning interest.

To ensure compliance with federal administrative requirements, local education agency fiscal officials should develop internal controls and a sound methodology to calculate and return, at least quarterly, interest earned in excess of \$100 on federal program funds. Interest calculation methodologies must be based on actual, not estimated, interest earnings on federal funds. Further details as to how federal interest should be calculated and remitted can be found on Pages 10-12 of the State and Federal Grant Administration Policy and Fiscal Requirements and Procedures, which is online at

Interest should be returned using the following guidelines:

- Checks for interest earned should be made payable to the Illinois State Board of Education.
- Checks should not include the return of unexpended disbursements from ISBE. Even though unexpended disbursements and interest payments are made payable to ISBE, separate checks should be issued for both.

• Checks should be accompanied by a statement identifying the program and the program year from which the interest was earned.

# New Census Estimates Released for Fiscal Year 2016 Title I Low Income

The U.S. Department of Education has released the Small Area Income and Poverty Estimates (SAIPE) for income year 2013. These estimates will be used to calculate fiscal year 2016 Title I Allocations. A file of 2013 Poverty Data by Local Education Agency (LEA) is provided in an alphabetical listing of LEAs, Poverty Count, 5-17 Population, Poverty Percentage and Total Population online at www.isbe.net/funding/excel/fy16preliminaryeligibility.xlsx.

With this data, LEAs can determine their potential eligibility for Basic, Concentration, Targeted and Education Finance Incentive grants (EFIG).

**Basic Grant eligibility**: An LEA must have at least 10 poverty children and the number of poverty children must be greater than 2 percent of the LEA population of children ages 5-17.

**Concentration Grant eligibility**: An LEA must have at least 6,500 poverty children or the number of those children exceeds 15 percent of the total 5-17 population.

**Targeted Grant and EFIG qualifications**: An LEA must have at least 10 poverty children and that number must be at least 5 percent of the 5-17 population.

The following link to the Census Bureau, <u>www.census.gov/did/www/saipe/index.html</u>, provides various aspects of the SAIPE count, including the data sources and methodology used to prepare these data. We will be using the 2013 data to calculate school year 2015-16 Title I, Part A allocations because they are the most recent available data. Superintendents, business managers and Title I directors should carefully examine the data for their LEA as this will be the first indication as to whether your LEA may be gaining or losing in eligibility for Title I funds in FY 2016. ISBE neither controls nor generates the data. The challenge period for the 2013 estimates ends March 17. Refer to the Census Bureau link at

Note that this preliminary data does not include other non-census information, such as foster, neglected or delinquent counts that may be used to calculate Title I allocations.

#### Applications for Summer Migrant Education Services Funding Available

The Division of English Language Learning is accepting applications for fiscal year 2015 federal Migrant Education Program funding for summer school programs in districts with qualifying migrant children under Title I, Part C of the No Child Left Behind Act. The application is available at www.isbe.net/bilingual/pdfs/20-37A-migrant-summerapp.pdf. The application deadline is Friday, March 20.

Students who are 21 years old or younger and have not graduated from high school may be eligible if they have moved within the past three years across state or school district lines with a parent or guardian or on their own to seek or obtain temporary or seasonal work in agricultural production, fishing or food processing industries. A certified recruiter must document that children qualify as migrant students.

#### District Preschool Program Plan For Serving English Learners

A recent amendment to administrative rules provides districts with additional time – until July 1, 2016 – to ensure that individuals assigned to provide instruction in English as a Second Language (ESL) and/or instruction in a student's home language in a preschool setting to meet the applicable requirements for bilingual education teachers and ESL teachers (23 III. Adm. Code 228.35 (a) & (b)).

Staffing is one significant component of establishing Transitional Bilingual Education (TBE) or Transitional Programs of Instruction (TPI) to serve preschool English learners, as required under part 228 since July 2010.

In order to ensure that preschool English learners are receiving language support services and districts are making progress toward development of their TBE/TPI preschool programs, districts that have any attendance centers that offer preschool programs and currently do not meet the staffing requirements under 228.35 (a) & (b) have to submit a plan to ISBE's Division of English Language Learning (DELL), pursuant to 228.35(c)(3).

The District Preschool Plan is available on the DELL website at <u>www.isbe.net/bilingual/htmls/preschool-</u> <u>ells.htm</u>. As part of the plan, district must address various required components. Districts are encouraged to use the "Service and Staff Template" to satisfy this requirement, which is also available on the DELL website. Plans should be developed and completed in collaboration with the preschool administrator.

This plan, including all required components, must be submitted electronically to DELL by **Jan. 30, 2015**. Completed plans can be submitted to <u>dell@isbe.net</u>.

#### Illinois 5Essentials

#### Third Annual 5Essentials Survey Set For Today through March 13

From today through March 13, the Illinois State Board of Education (ISBE) will conduct its third annual survey of learning conditions, the Illinois 5Essentials Survey. The 5Essentials Survey, a diagnostic tool developed by researchers at the University of Chicago, provides schools with fine-grained data on five leading indicators for school improvement: Effective Leaders, Collaborative Teachers, Involved Families, Supportive Environment and Ambitious Instruction. Twenty years of University of Chicago research has shown that schools that were strong on at least three of the 5Essentials were 10 times more likely to make substantial gains in reading and math.

All district schools, including alternative schools that fall under the district's domain, are required by legislation to participate in the survey at least every other year. In 2015, only districts participating in Race to the Top and those that did not participate in the survey last year will be required to participate by ISBE. Chicago District 299 will also require its schools to participate. All districts will have the option to participate and are strongly encouraged to do so.

Survey results will be released in May to principals and superintendents. A summary of the 5Essential results will be reported publicly on the State School Report Card website at <u>http://illinoisreportcard.com</u>. Detailed survey reports will also be publicly released. Survey results for 2014 and beyond will be normed using the 2013 statewide results so that all schools can demonstrate progress over time on the survey measures.

Several projects are underway to further improve the implementation of the Illinois 5Essentials Survey. These include a pilot in 62 districts to enhance survey security through use of teacher rosters. This year all 6-12 students throughout the state whose districts are registered for the 2015 administration of the 5Essentials will be rostered.

#### Update on KIDS: Illinois' Statewide Observational Assessment for Kindergarten

Illinois is in the process of rolling out implementation of the Kindergarten Individual Development Survey (KIDS). The survey is an important statewide initiative that will provide Illinois with new information about school readiness. In 2010, ISBE convened a group of educators, advocates and experts to participate in a planning initiative for a statewide kindergarten readiness assessment process. After hearing from national experts and administrators in other states and engaging in much research and discussion, the Kindergarten Readiness Stakeholder Committee recommended the Illinois KIDS process. The survey is an observational assessment process aimed at understanding children's abilities and learning across multiple developmental domains through frequent teacher observation and documentation. KIDS is not a test. Observations are conducted during instruction, so children are not pulled out to be assessed. Done well, KIDS will have major benefits for students, teachers, families, districts and the state:

- Families can share documentation with teachers to help build a shared understanding of the child's skills, culture, language or ethnicity.
- Teachers can use the assessment information to guide their instructional planning and report to parents.
- Districts will have concise classroom, school and district-level reports about where their kindergartners are across domains. As part of a comprehensive, balanced assessment system, KIDS can inform professional development, curriculum development, instructional strategies, resource allocation and continuous improvement.
- State education leaders will have uniform statewide data to better design educational pathways for children.

Illinois is now in its third year of implementing KIDS, preceded by two pilot years. Teacher and administrator feedback from the pilot has been utilized to customize, restructure and simplify the KIDS instrument, training and implementation process. This fall, 1,243 kindergarten teachers from 441 schools and 210 districts used the developmentally appropriate KIDS assessment to enter data on 26,544 children. At least 2,303 teachers, administrators and support staff have been trained to date. As outlined in the Illinois Administrative Code 1.420, each school district in Illinois is currently scheduled to administer KIDS beginning in the 2015-16 school year.

To guide the state with recommendations, ISBE established a KIDS Advisory Committee in 2011. At the committee's Dec. 2, 2014, meeting, discussion included feedback from teachers, administrators and local school districts. With less than a year until statewide implementation, there is concern that many districts are not fully prepared. The committee encouraged ISBE to have flexibility with the timeline to plan professional development that allows districts to train administrators and teachers and put supports in place to effectively use KIDS. Districts also need time to inventory existing assessments in relation to KIDS, eliminate those that are duplicative and crosswalk those that complement and inform KIDS.

The state superintendent has heard this feedback and is currently working with stakeholders and implementing districts to revise the state's KIDS Implementation Plan to allow additional time to support districts in building their capacity. A new plan is expected this month. Updated information will be provided on the website and through this bulletin.

As districts prepare to implement KIDS, there are a range of resources – including half-day administrator trainings, tutorials and webinars, and an administrator implementation checklist – at

www.illinoiskids.org/content/kids-administratorschecklist. Teacher trainings continue throughout the school year and summer around the state. Additional guidance on aligning assessments to KIDS and how KIDS reports could be used as report cards will also be forthcoming.

#### PARCC Infrastructure Trial Week Scheduled for This Week

Districts participating in the online Partnership for Assessment of Readiness for College and Careers (PARCC) test are <u>highly encouraged</u> to conduct an infrastructure trial.

This "dry run" will test the school's network as well as provide practice for every group involved in testing (test coordinators, test administrators, technology coordinators and students) by creating a practice environment (complete with practice tests) that is as real as possible. The infrastructure trial can be done at any time prior to testing, but Illinois is putting special emphasis on this week as a way to stress Pearson's system and identify any potential problems in advance of testing.

#### **Assessment Inventory**

The tool supports a process by which districts evaluate assessments students are currently taking; determine the minimum amount of assessment information necessary for essential diagnostic, instructional and accountability purposes; and work to ensure that every assessment is of high quality and is supported by structures and routines that ensure assessment results are used to benefit students. # DCFS Accepting Applications for 2015 Scholarship Program

The Department of Children and Family Services is currently accepting applications for the 2015 DCFS Scholarship Program.

The scholarship program provides a minimum of 53 scholarships each year, four of which are awarded to children of veterans. Those eligible to apply are: youth who the department has court-ordered legal responsibility for, youth who aged out of the department's care at age 18 or older, youth who the department had legal responsibility for prior to the youth's adoption being finalized and youth who are in the Subsidized Guardianship or KinGap Program.

Scholarship recipients receive up to five consecutive years of tuition and academic fee waivers to be used at participating Illinois state community colleges and universities, a monthly grant and a medical card. Youth who graduated from high school in previous years or youth who are currently enrolled in college are eligible to apply for the department scholarship, as long as they will be under the age of 21 on March 31, 2015.

Scholarship recipients will be selected on the basis of their scholastic record and aptitude, community and extracurricular activities and interest in higher education. Note: Tuition and fee waivers are provided only to scholarship recipients that attend an Illinois state community college or university. Scholarship recipients that attend private Illinois or out-of-state colleges or universities do not receive tuition and fee waivers.

Scholarship applicants are required to submit their applications to the Office of Education and Transition Services (OETS) no later than March 31, 2015. Applications postmarked after that date will not be eligible for consideration. Incomplete applications will be ineligible for consideration and will be returned to the applicant. If time permits, the applicant can resubmit the complete application packet. Applications submitted by facsimile will be ineligible for consideration.

Research was also conducted to establish schools with strong hospitality enrollment and influence in their community. Additional criteria for those selected for the Elite 50 included an original recipe with photos or a restaurant management design; two essays from students on the topic "Why I want to pursue a career in hospitality" and video, brochure and additional information about the school's program. Further considerations were given to schools that operate a restaurant or offer catering service, etc. as part of culinary/hospitality training.

#### **Pregnancy Rights Notice Requirement**

Public Act 98-1050 amends the Illinois Human Rights Act to make changes regarding pregnancy and pregnancy accommodations. It also requires employers in Illinois to post a notice about pregnancy in the workplace and an employer's obligation to accommodate pregnancy.

#### Taiwan Ministry of Education

#### Chinese Language Recruitment Program Available to Illinois School Districts

Taiwan's Ministry of Education invites district superintendents in Illinois to participate in the 2015 Chinese Language Teacher Recruitment Program. Assistance is available for school districts and schools planning to recruit a Chinese teacher from Taiwan to select potential candidates with interviews.

The Ministry of Education will provide one round-trip ticket to the recruited teacher, and the hiring school will provide the salary and benefits to the recruited teacher as a full-time teacher in the school. The Ministry of Education will assist the recruited teacher to apply for the J-1 visa in Taiwan; however, the hiring school will need to provide the necessary hiring documents (e.g., contract, etc.) and share the processing fee for the DS-2019 document with the recruited teacher. The recruited teacher will follow the hiring school's calendars/regulations to give his/her instruction.

Those districts interested in participating should send a plan outline to hire a Chinese language teacher(s) from Taiwan. Please include information such as the name and contact information of superintendents and principals wishing to take part in the interview; how many teachers sought; what qualifications the district is looking for; the teaching load they will be expected to fulfill (e.g., number of courses, hours per week); and what salaries and benefits are provided commensurate with qualifications.
