Weekly Message from State Superintendent Randy Dunn

Good afternoon.

As I referenced a week ago yesterday, I spent all of the past week in the Chicago office and had a great time making new—and renewing existing—professional friendships and attending a number of events. Of course, that week on the road was followed by the three-day weekend honoring Dr. King.

So, today, I'm paying the price for all of that time out of the Springfield office—while also finalizing preparations for the monthly meeting of the State Board which convenes here in town tomorrow and Thursday.

Simply put, I'm behind—and getting behind-er as the day goes on.

I had hoped to spend some time today discussing teacher induction, including the topic of mentoring as a subset of that larger policy issue. 

Legislation encourages Summer

Food Service Programs

As part of the Childhood Hunger Relief Act (Public Act 93-1086), the General Assembly recognized the importance of the Summer Food Service Program



(SFSP) as an effective measure to be widely implemented to ensure more adequate nutrition for Illinois children. Although a mandate for SFSP was **not** implemented, it is strongly encouraged that each school where at least 50 percent of the students are eligible for free or reduced-price school meals operate a Summer Food Service Program or identify a non-profit or private agency to sponsor a Summer Food Service Program within the school district's boundaries.

The Summer Food Service Program was instituted to provide nutritious meals to children during the summer months when school is not in session. The program is funded by the United States Department of Agriculture and administered by the Illinois State Board of Education. SFSP is the single largest Federal resource available for local sponsors who want to combine a feeding program with a summer activity program. School food safety inspections reminder

Beginning with the 2005–2006 school year, all schools participating in the National School Lunch or School Breakfast Programs are required to obtain a minimum of two food safety inspections each school year. Previously, participating schools were required to obtain a minimum of one food safety inspection per school year or comply with the frequency required by local standards. This is a result of the passage of Section 111 of the Child Nutrition and

Women, Infants, and Children (WIC) Reauthorization Act of 2004 (Public Law 108-265).

The required inspections must be conducted by a State or local governmental agency responsible for food safety inspections. More frequent inspections may still be required by State or local governments. In addition, schools must post, in a publicly visible location, a report on the most recent food safety inspection, and provide a copy of the food safety inspection report to a member of the public upon request. Illinois *Team Nutrition* schools top 1,000 mark

Exactly 1027 Illinois schools have enrolled in USDA's *Team Nutrition Initiative* since its inception in 1995. These schools have been focusing their attention on the important roles of nutritious school meals, nutrition education, and a health-promoting school environment play in helping students learn to enjoy healthy eating and physical activity.

New *Team Nutrition* schools will receive a resource kit (while supplies last) of materials to help plan and carry out activities for students and their families.

Two of Illinois' most promising high school seniors from Illinois will receive a full scholarship to attend a three-week summer camp. Scientists from across the nation who work on some of the most provocative topics in science today present lectures and hands-on research projects and seminars and linger to interact informally with student delegates.

The delegates will participate in two overnight expeditions into the Monongahela National Forest and a visit Washington, D. C. The National Youth Science Camp is offered at no cost to its selected participants; the scholarship will cover all educational and recreational programming, meals, lodging, and round-trip air passage. Illinois EPA announces annual competition for fifth and sixth grade students

Fifth and sixth grade writers and artists are invited to participate in the Poster, Poetry and Prose Contest, annually sponsored by the Illinois Environmental Protection Agency (IEPA) to increase awareness of environmental issues.

This year's theme focuses on the importance of clean water and the conservation of our drinking water, with *Water: Conserve it, We Deserve It!* as the event's theme. Special emphasis is given to air, land or water on a rotating basis.

Each school can enter up to 12 (six posters and six written) works. Entries must be postmarked and sent in to the Illinois EPA by February 17. An in-house panel from the IEPA judges all entries to select the finalists, whose entries are then judged by an outside panel of authorities to determine the top 12 winners.

All finalists, together with their families and teachers, are invited to an awards ceremony and reception that will be held on Saturday, April 8 at the Abraham Lincoln Presidential Library in Springfield. In addition, the top 12 finalists will be given special recognition and will each receive a \$50 U.S. savings

bond and an environmental reference book for his or her school library.

Following the awards ceremony and reception, these entries will be on exhibit in the atrium of the Illinois EPA's Springfield headquarters from April 10 through May 10, and the top winners will be featured on the IEPA's homepage at http://www.epa.state.il.us.

Hurricane Education Recovery Act deadline January 26

The United States Department of Education (USED) posted the Hurricane Education Recovery Act (HERA) notice in the Federal Register on January 12, 2006. School districts must submit applications to the Illinois State Board of Education no later than Thursday, January 26.

Nonpublic schools and parents of nonpublic school children should send their completed forms to the public school district in which the nonpublic school is located, <u>not</u> to ISBE. ISBE strongly recommends that public school districts <u>designate a staff member or specific point of contact</u> to receive these submissions from nonpublic schools and parents and use their best efforts to inform nonpublic schools of the relevant contact information.

Public school districts should mail the original copy of their completed, signed HERA applications to:
