Message From State Superintendent Christopher A. Koch

I hope you enjoyed the Martin Luther King holiday. Today we submitted our Race to the Top application to the U.S. Department of Education. I want to thank all of you for your assistance over the past few months in developing our proposal. Your feedback was invaluable.

When we started this process last summer I said that I didn't want to put together a Race to the Top application simply to get additional federal funds. I wanted to put together an application that was a blueprint for where the State Board of

Education and our education community felt we needed to move over the next decade and, if we received Rt3 funding, it would accelerate us on our course. Looking back at where we were this summer when we started the process and where we are today, I am proud of our application and the future direction that you have charted for our students.

Last week the Board voted on their budget recommendation for FY 2011. It is a level budget from the previous year. While we refer to it as a level budget, it calls for an additional \$1 billion in state funding. The state utilized federal stimulus funds during FY 2009 and 2010 to make General State Aid payments and those federal funds are gone in FY 2011.

In order for education to receive level funding during FY 2011, members of the General Assembly will either need to raise at least that much in new revenues or will have to reduce that much from other areas of government. I am hopeful that we will be

level funded, but I think everyone must acknowledge the possibility of a substantial decrease in funding for this year. In order to reduce such a large amount of funds, GSA and Mandated Categoricals would be impacted.

I would urge you to communicate with your legislators about the needs of your district — how much your district is currently owed and what your needs will be for next year. We certainly communicate this information to legislators; however, nothing means as much to a legislator as hearing directly from a constituent.

These are tough times financially, but I honestly believe the best years for education are in our future. I was amazed by the response we had from districts when we asked them to partner with us on Race to the Top. 366 districts representing nearly 75 percent of our student enrollment submitted a signed Memorandum of Understanding. Whether we win a Race to the Top award or not, that type of support is encouraging.

Required 'Study of School Level Expenditures' Application on IWAS

A school level expenditure report for the 2008-09 school year is being required per the American Recovery and Reinvestment Act of 2009 (ARRA) for local education agencies (LEAs) that are entitled to funds under Title I, Part A of the Elementary and Secondary Education Act (ESEA) provided under ARRA (i.e., LEAs that are entitled to ARRA Title I funds calculated under the Targeted Grant and Education Finance Incentive Grant formulas). Such LEAs are required to report school-byschool expenditures from state and local funds for the 2008-09 school year for all of their schools (not just Title I schools). The U.S. Department of Education states that they will use these data to examine the extent to which school-level education resources are distributed equitably within and across LEAs.

To facilitate this required reporting, we have created a new IWAS application, "Study of School Level Expenditures." To access the application, log on to IWAS, and under System Listing, it is located under "Reporting."

This specific report is focused on only state and local fund expenditures for Regular K-12 instruction, within four categories:

- Personnel salaries at the school level for all school-level instructional and support staff.
- Personnel salaries at the school level for instructional staff only.
- Personnel salaries at the school level for teachers only.
- Non-personnel expenditures at the school level (if available).

An Excel worksheet is available for download and completion, which can be accessed at http://webapps.isbe.net/expstudy/download/schoolworks heet.xls. The specific function and object codes, per Part 100 Requirements for Accounting, Budgeting, Financial Reporting and Auditing, are provided to assist in the calculation of reporting data per school. It is highly recommended that a separate spreadsheet be completed and maintained for future reference and review for each of your schools. These spreadsheets are not to be submitted to ISBE, but used as a tool for assist in arriving at the totals necessary for this report. The four totals calculated for each school, as well as the number of hours necessary to arrive at the data for each school, are the components that must be entered in the "Study of School Level Expenditures" report.

A "calculate and save" feature is available on the "Details" page of the report, to allow multiple sessions of entry of the data. Once all data has been entered, the document author must submit to the district administrator in IWAS. It is the district administrator that submits to ISBE. You will receive IWAS messages when each step is complete.

School level expenditures to be excluded from this report include those:

- From federal program funds.
- From special education funds.
- Not associated with regular K-12 programs, such as preschool and adult education.
- That serve students from more than one school attendance area, such as summer school.
- Expenditures for employee benefits.

The report of this data is due Friday, Feb. 26.

School District Reorganization Feasibility Study Funding Available

Interested school districts may still take advantage of School District Reorganization Feasibility Study funding in FY 2010. Feasibility studies are a tool to be used by school districts wanting to investigate the advantages and/or disadvantages of reorganization options. Interested school districts should submit a proposed agreement with an independent contractor(s) to their Regional Office of Education (ROE). The ROE will submit the agreement to the Illinois State Board of Education for approval.

Each study will be funded on a base tier according to the number of school districts involved in the study. Studies will be funded an additional tier based on the combined enrollment of the districts involved in the study. Studies are funded between \$4,500 and \$8,000 based on the procedure listed above. Funds are available on a "first-come, first-served" basis. In order to receive reorganization feasibility study funds in FY 2010, agreements must be approved by both ROE and ISBE, and studies must be completed and approved for payment no later than June 30.

English Language Learning

Migrant Supplemental Education Services Funding Applications Available

The division of English Language Learning is accepting applications for migrant supplemental education services funding for the summer of 2010 in districts with qualifying migrant children under Title I, Part C of the No Child Left Behind Act. The application is available at http://www.isbe.net/bilingual/htmls/migrant.htm. The application deadline is March 15.

Eligibility: Students who are under the age of 22 and have not graduated from high school may be eligible if they have moved (within the past three years due to economic necessity) across state or school district lines with a parent or guardian or on their own to obtain temporary or seasonal work in agricultural production,

fishing or food processing industries. A certified recruiter must document that children qualify as migrant students.

Innovation and Improvement

Conference on No Child Left Behind to be Held in Chicago Next Month

This year's Statewide No Child Left Behind Conference, "From Hope to Progress: Shaping Change in Illinois Schools," will take place Feb. 9-11 in Chicago. This conference brings together several thousand K-12 educators who learn about approaches to improving teaching and learning in our classrooms.

The conference will focus on four specific areas: rigorous and high-quality standards and assessments; data systems that support instruction; development of great teachers and leaders; and intervention in the lowest-performing school and districts.

Other sessions will address No Child Left Behind policy, legal matters, and programs, school safety and violence prevention issues, professional development, assessment and data-driven decision making, and other topics. This year, the conference will also provide three special expert panels on current issues. The sessions are: School Restructuring, Response to Intervention, and Eradicating Violence and Empowering At Risk Youth and the Learning Community. Panels, sessions and workshops, several led by Illinois State Board of Education consultants, will provide participants with updated information about the educational priorities of the nation and the state.

School Breakfast Program Mandate – UPDATE

Public Act 96-0158 requires each school district to implement and operate a School Breakfast Program in

the next school year in accordance with federal guidelines in each school building within its district in which at least 40 percent or more of the students are currently eligible for free or reduced-price lunches. If a school is seeking an exemption from this mandate, they must petition their Regional Office of Education (ROE) by Feb. 15 of each year. By March 15, the ROE must have convened a public hearing in accordance with the Open Meetings Act and informed the school district and Illinois State Board of Education (e-mail: cnp@isbe.net) of his/her decision in writing.
