### Message From State Superintendent Christopher A. Koch

Gov. Bruce Rauner was inaugurated last week and he has named James Meeks to chair the Illinois State Board of Education. Meeks is a former state senator, who will bring a wealth of experience to the position. He replaces the outgoing chairman, Gery Chico, who had guided the Board since June 2011.

This week the Board meets in Springfield. The primary focus will be on its fiscal year 2016 budget recommendation to the Governor and members of the General Assembly. I will be making a recommendation to the Board that includes funding General State Aid at the statutory Foundation Level of \$6,119. This will require a significant increase over the current level of funding; however, the Board has made GSA a focus of its budget requests and has expressed a desire to eliminate proration. In addition, I'll recommend other increases to specific line items, including early childhood education, regular/vocational transportation, bilingual and other areas. I am also recommending that we seek capital funding to meet district technology infrastructure needs.

The Board meeting will begin at 9 a.m. on Wednesday, Jan. 21, and will be audiocast via the agency website at <a href="www.isbe.net">www.isbe.net</a>. This was originally to be a two-day meeting, but because of scheduling conflicts it has been changed to a one-day meeting.

Finally, we want to help you engage your school communities and provide you with some additional tools to assist educators, students and parents as they prepare for the new Partnership for Assessment of Readiness for College and Careers (PARCC) assessments. Our staff has developed resources aimed at familiarizing all participants with the test and packaged these resources for schools in a turnkey event called the "PARCC Primer." The PARCC Primer is designed to be informal and fun and should create a welcoming environment for families to learn more about this spring's assessment and current teaching and learning strategies in English language arts and math. Participants will get a chance to take some sample PARCC test items.

### School District Annual Financial Report Review Process Notification

All district superintendents should have received an email broadcast asking them to review their preliminary Financial Profile Report and verify the Operating Expense Per Pupil (OEPP)/Per Capita Tuition Charge (PCTC) by no later than Feb. 6.

District administrators may submit comments regarding their district's finances that will be published along with their Financial Profile Report (500 characters maximum). The comments must be submitted no later than Feb. 6.

The email included links to the memorandum, instructions and definitions to assist with the review process. These documents are also available in <a href="IWAS">IWAS</a>

and on the <u>School District Financial Profile Score & OEPP/PCTC Verification Information webpage</u>.

The email broadcast and the Superintendent's Weekly Message will be the only notices sent to the district. If you have not received the email, please contact ISBE at (217) 785-8779. If you have given another person authority to review these reports, please forward the email to them. Since the financial profile designation will be approved and publicly released by the Illinois State Board of Education (ISBE), it is crucial that districts review their financial profile data and score. Any district that wishes to include comments that support the Financial Profile Report may do so directly in IWAS beneath the report. Although comments are optional, they are encouraged; this is an opportunity for districts to explain significant financial circumstances.

The deadlines and instructions are important in completing the OEPP/PCTC verification process because once the deadline passes, changes to the 2014 Annual Financial Report (AFR) data are not permitted.

The financial profile will be adjusted to incorporate the deduction of last year's mandated categorical aid payments due to school districts that were not paid by June 30, 2013; all payments were made by June 30, 2014.

# Guidance on Equitable Educational Access for English Learner Students

The U.S. Departments of Education and Justice have released joint guidance reminding states, school districts and schools of their obligations under federal law to ensure that English learner students have equal access to a high-quality education and the opportunity to achieve their full academic potential.

The departments have also released additional tools and resources to help schools in serving English

learner students and parents with limited English proficiency:

- A fact sheet in <u>English</u> and in <u>other languages</u>
   about schools' obligations under federal law to
   ensure that English learner students can participate
   meaningfully and equally in school.
- A fact sheet in <u>English</u> and in <u>other languages</u> about schools' obligations under federal law to communicate information to limited English proficient parents in a language they can understand.
- A toolkit, prepared by the Education Department's Office of English Language Acquisition, to help school districts identify English learner students. This is the first chapter in a series of chapters to help state education agencies and school districts meet their obligations to English learner students.

This is the first time that a single piece of guidance has addressed the array of federal laws that govern schools' obligations to English learners. The guidance recognizes the recent milestone 40th anniversaries of Lau v. Nichols and the Equal Educational Opportunities Act of 1974 (EEOA), as well as the 50th anniversary of the Civil Rights Act. The EEOA, similar to Lau, requires public schools to take appropriate action to help English learner students overcome language barriers and ensure their ability to participate equally in school.

The guidance explains schools' obligations to:

- identify English learner students in a timely, valid and reliable manner;
- offer all English learner students an educationally sound language assistance program;
- provide qualified staff and sufficient resources for instructing English learner students;
- ensure English learner students have equitable access to school programs and activities;
- avoid unnecessary segregation of English learner students from other students;
- monitor students' progress in learning English and doing grade-level class work;
- remedy any academic deficits English learner students incurred while in a language assistance program;
- move students out of language assistance programs when they are proficient in English

- and monitor those students to ensure they were not prematurely removed;
- evaluate the effectiveness of English learner programs; and
- provide limited English proficient parents with information about school programs, services and activities in a language they understand.

## Final 2013-14 IDEA Room and Board Claim Payment Information

The 2013-14 Individuals with Disabilities Education Act (IDEA) Room and Board program is now complete.

Final 2013-14 school year claims exceeded the amount of IDEA Room and Board funds available. Proration was calculated at 71 percent of the final claims. Claims reimbursed from federal IDEA Part B grant funds have been escalating at a rate beyond the set aside amounts the agency retains from our annual IDEA Part B award. The final 2013-14 school year voucher was processed by ISBE on Dec. 22 and released by the Office of the Comptroller on Dec. 29.

2014-15 School Year: Due to the projected increase of claims and available IDEA funds for the 2014-15 school year, the estimated proration will be approximately 77 percent; therefore, to avoid potential overpayment, submitted monthly claims will be paid at 60 percent during the year. Once all claims are finalized in December 2015, final claims and proration will be calculated and paid at that time.

### Federal Interest Income – Quarterly Reminder

The Code of Federal Regulations, Title 34-Education, Part 80 Uniform Administrative Requirements for Grants and Cooperative Agreements to State and Local Governments, Subpart C-Post Award Requirements, Section 80.21 Payment, requires grantees and subgrantees to promptly, but at least quarterly, remit interest earned on advances to the appropriate federal agency. The grantee or subgrantee may keep actual interest amounts up to \$100 per year gained on federal deposits per bank account, if applicable, for administrative purposes. Grant recipients have discretion to set up account(s) that are non-interest bearing to avoid returning interest.

To ensure compliance with federal administrative requirements, local education agency fiscal officials should develop internal controls and a sound methodology to calculate and return, at least quarterly, interest earned in excess of \$100 on federal program funds. Interest calculation methodologies must be based on actual, not estimated, interest earnings on federal funds. Further details as to how federal interest should be calculated and remitted can be found on Pages 10-12 of the State and Federal Grant Administration Policy and Fiscal Requirements and Procedures, which is online at <a href="https://www.isbe.net/funding/pdf/fiscal\_procedure\_handbk.p">www.isbe.net/funding/pdf/fiscal\_procedure\_handbk.p</a> df.

Interest should be returned using the following guidelines:

- Checks for interest earned should be made payable to the Illinois State Board of Education.
- Checks should not include the return of unexpended disbursements from ISBE. Even though unexpended disbursements and interest payments are made payable to ISBE, separate checks should be issued for both.
- Checks should be accompanied by a statement identifying the program and the program year from which the interest was earned

### New Census Estimates Released for Fiscal Year 2016 Title I Low Income

The U.S. Department of Education has released the Small Area Income and Poverty Estimates (SAIPE) for income year 2013. These estimates will be used to calculate fiscal year 2016 Title I Allocations. A file of 2013 Poverty Data by Local Education Agency (LEA) is provided in an alphabetical listing of LEAs, Poverty Count, 5-17 Population, Poverty Percentage and Total Population online at <a href="https://www.isbe.net/funding/excel/fy16preliminary-eligibility.xlsx">www.isbe.net/funding/excel/fy16preliminary-eligibility.xlsx</a>.

With this data, LEAs can determine their potential eligibility for Basic, Concentration, Targeted and Education Finance Incentive grants (EFIG).

**Basic Grant eligibility**: An LEA must have at least 10 poverty children and the number of poverty children must be greater than 2 percent of the LEA population of children ages 5-17.

**Concentration Grant eligibility**: An LEA must have at least 6,500 poverty children or the number of those children exceeds 15 percent of the total 5-17 population.

**Targeted Grant and EFIG qualifications**: An LEA must have at least 10 poverty children and that number must be at least 5 percent of the 5-17 population.

We will be using the 2013 data to calculate school year 2015-16 Title I, Part A allocations because they are the most recent available data

Superintendents, business managers and Title I directors should carefully examine the data for their LEA as this will be the first indication as to whether your LEA may be gaining or losing in eligibility for Title I funds in FY 2016. ISBE neither controls nor generates the data. The challenge period for the 2013

Note that this preliminary data does not include other non-census information, such as foster, neglected or delinquent counts that may be used to calculate Title I allocations.

# DCFS Accepting Applications for 2015 Scholarship Program

The Department of Children and Family Services is currently accepting applications for the 2015 DCFS Scholarship Program.

The scholarship program provides a minimum of 53 scholarships each year, four of which are awarded to children of veterans. Those eligible to apply are youth who the department has court-ordered legal responsibility for, youth who aged out of the department's care at age 18 or older, youth who the department had legal responsibility for prior to the youth's adoption being finalized and youth who are in the Subsidized Guardianship or KinGap Program.

Scholarship recipients receive up to five consecutive years of tuition and academic fee waivers to be used at participating Illinois state community colleges and universities, a monthly grant and a medical card. Youth who graduated from high school in previous years or youth who are currently enrolled in college are eligible to apply for the department scholarship, as long as they will be under the age of 21 on March 31, 2015.

Scholarship recipients will be selected on the basis of their scholastic record and aptitude, community and extracurricular activities and interest in higher education. Note: Tuition and fee waivers are provided only to scholarship recipients that attend an Illinois state community college or university. Scholarship recipients that attend private Illinois or out-of-state colleges or universities do not receive tuition and fee waivers.

Scholarship applicants are required to submit their applications to the Office of Education and Transition Services (OETS) no later than March 31, 2015. Applications postmarked after that date will not be eligible for consideration. Incomplete applications will be ineligible for consideration and will be returned to the applicant. If time permits, the applicant can resubmit the complete application packet. Applications submitted by facsimile will be ineligible for consideration.
