Message from Interim State Superintendent Christopher Koch

Good afternoon,

Last week, the State Board of Education held its monthly meeting in Chicago and approved a Fiscal Year (FY) 2008 budget to be recommended to the Governor and General Assembly. The Board's recommendation reflects an increase of \$801 million over FY 2007 funding levels, with priorities in General State Aid and Mandated Categorical Grants, and emphasis on Special Education Personnel Reimbursement Grants. The recommendation includes a \$299 million increase to General State Aid, a \$338.8 million increase to Mandated Categorical Grants, and \$209.2 million for Special Education Personnel Reimbursement.

Other increases include \$69.3 million for Early Childhood (Preschool for All), \$20 million for Tech for Success, \$9.6 million for educator recruiting, mentoring and professional development programs, \$8.4 for Bilingual Education, \$6 for Truant Alternative and Optional Education, \$3.9 million for standards, assessments and accountability and \$3 million for work to help prepare for implementation of a Growth Model Assessment in Illinois.

As I alluded to in last week's message, the State Board's recommendation also includes a 12 percent increase in the number of agency staff from the 499 limit under which we currently work. As many of you are keenly aware, ISBE's staffing is down to just 468 employees. Since 2003, the ISBE general operating budget has decreased by nearly \$10 million or 30 percent. Coinciding with these diminished Agency resources, there has been a markedly increased emphasis on accountability in elementary and secondary at both the State and Federal levels. The Agency has been called on to monitor, distribute and provide technical assistance for funding increases of \$1.3 billion, a 26 percent increase. I thank the State Board for their leadership in recommending increased Agency staffing to fulfill our existing statutory obligations. Our staff has worked diligently to identify the most effective way to enhance the Agency services, and has identified existing Federal funding to cover 30 percent of the cost of increased Agency staffing.

We have delivered the State Board's recommendations for the FY 2008 budget to the Capitol. The next steps of the budget process will include Governor Blagojevich's Budget Address on or before March 7.

We thank each of you who participated in the State Board Budget hearings over the last several months and pledge to you that we will work diligently throughout the Budget Process this Spring to continue to increase the level of funding support for Illinois schools.

Teacher Certification

January 31 deadline to demonstrate highly qualified status for Federal report

Districts with numbers of not highly qualified teachers listed on the NCLB Highly Qualified Report downloaded from the Teacher Service Record (TSR) need to take quick action to correct errors in reporting on the TSR. Teachers who have not added missing highly qualified (HQ) data to the Educator Certification System (ECS)

need to do so quickly. ISBE must report at the end of January those districts with large numbers of not highly qualified teachers, the subjects where we most frequently find teachers who are not highly qualified, the impact of not highly qualified teachers on poor and minority students and the reasons why teachers are not highly qualified.

Consequently January 31 is the final date before we report to the federal government when you can modify your district's highly qualified teacher information on the TSR and ECS and have that information reflected in the report. After that date ECS will still be available for teachers to add data, but changes will not be reflected on the federal report.

Districts that are reporting a high number of not highly qualified teachers as a result of errors on the TSR need to take quick action to correct these errors and teachers who have not completed the HQ process on the ECS system will be counted in the report as being not highly qualified. Teachers who are missing HQ data on ECS need to add the missing data quickly. Teachers who are not HQ will have this year and next, to become highly qualified and the district must have a district plan to move its teachers to the HQ status filed with its regional superintendent; each not highly qualified teacher must have a plan to become highly qualified filed with the district. Districts are expected to provide resources to the teachers to assist them in their efforts. The federal requirements include a district plan in place to ensure poor and/or minority students are not taught at a higher rate by inexperienced or not highly qualified teachers than are other students.

Teachers must implement their plans this year, make progress in completing them and must have completed their plans by becoming highly qualified by the start of the 08-09 school year. If you have any questions about this information, please contact your regional superintendent.

Advanced Placement Course Audit update

The following information is being circulated by the College Board and AP Central to publicize the upcoming need for all AP teachers and schools to submit materials to substantiate their claim that a course should be recognized as worthy of the Advanced Placement designation. Failure to meet the requirements of this audit will nullify that claim. Direct all questions regarding this procedure to the College Board and the email address designated at the end of this article or through the website at AP Central.

As scheduled, the AP Course Audit process will officially open later this month. AP teachers, principals, coordinators and district representatives will receive instructions on how to access the AP Course Audit website and submit materials during the fourth week in January. Instructions will also appear on AP Central.

The AP Course Audit provides clear guidelines on the course content and resources typical of college-level classes, and helps colleges and universities better interpret courses marked "AP" on student transcripts. Schools have until June 1, 2007 to submit materials as part of the AP Course Audit. Prior to the opening of the AP Course Audit website, the College Board encourages AP teachers to review the course audit information and resources available on AP Central at http://apcentral.collegeboard.com/courseaudit, which include:

As always, schools develop their own curriculum for courses labeled "AP." The AP Course Audit simply specifies core elements colleges and universities expect to see within the curriculum you develop for collegelevel AP courses. You will see when reviewing the AP Course Audit requirements that they do not in any way constitute a mandated curriculum, and provide schools with tremendous flexibility in development of curricula for courses labeled "AP." Courses that meet or exceed these expectations will be authorized to use the "AP" designation.

The AP Course Audit deliberately does not base its outcomes on student exam grades, because doing so would put pressure on teachers to avoid taking risks on students less certain to succeed in an AP course. Because the AP Course Audit requirements were established by professors from several hundred of the nation's top colleges and universities, it is our hope that even experienced AP teachers with high-performing students will benefit from the opportunity the AP Course Audit provides to reflect on their own curriculum and how they are meeting or, in many cases, exceeding the most recent set of expectations voiced by college and university faculty.
