### Message From State Superintendent Christopher A. Koch

People across our state will go to the polls tomorrow to cast their votes for the candidates they feel most appropriate to lead our state. Free elections and the wave of democracy that followed our Independence are among our nation's greatest global legacies.

I think of each election as a teachable moment; whether it's to show the differences between parties, how vast ideological differences can be debated and transitions of power can take place peacefully, or just how casting a ballot is part of the civic responsibility bestowed upon the citizens of this great nation. I urge you to work with your teachers to incorporate the primary election into your lesson plans.

In many cases, throughout Illinois, our schools will serve as polling places. We need to all think long and hard about who we want to face these challenges, because there are going to be no easy decisions. The choices we make at the ballot box will have direct repercussions on the Illinois education community for years to come.

On a lighter note, the Colts and Saints will play for the NFL championship on Sunday. The Super Bowl is more than a sporting

event — it is part of American culture. It is a phenomenon that is watched by more than a hundred million people. Please, encourage students and staff to celebrate safely. Possibly consider hosting a party at your school — at least there you know they'll be safe.

# Data Analysis and Progress Reporting

### Winter 2010 Reduction in Force Survey

Later this month, the Illinois State Board of Education will be surveying districts, special education cooperatives and regional offices of education and intermediate service centers that operate regional programs regarding the number of layoff notices/nonrenewal notifications they have issued and/or anticipate issuing by March 15. These data are being collected to assist the State Board in assessing the potential impact of FY 2011 State budget constraints on public school students.

The Winter 2010 Reduction in Force Survey IWAS system will be open for data entry Feb. 16-26. The survey will request the number of layoff notices/nonrenewal notifications for the following categories of personnel: tenured teachers, non-tenured teachers, administrators, school service personnel (school counselors, nurses, psychologists and social workers), and non-certified staff.

### Final Guidance on Special Education Eligibility in an Rtl Framework

ISBE is pleased to announce that "Illinois Special Education Eligibility and Entitlement Procedures and Criteria within a Response to Intervention (RtI) Framework: A Guidance Document" is available in final form at <a href="http://www.isbe.net/spec-ed/Default.htm">http://www.isbe.net/spec-ed/Default.htm</a> (see "What's New").

The guidance document is designed to provide Illinois districts and schools with a framework for using RtI to determine a student's eligibility for and entitlement to special education services. Beginning in the 2010-11 school year, districts must use a process that determines how a child responds to scientific, research-based interventions as part of the evaluation procedures to determine special education eligibility under the category of specific learning disability (SLD), in accordance with 23 Illinois Administrative Code 226.130 (<a href="http://www.isbe.net/rules/archive/pdfs/226ark.pdf">http://www.isbe.net/rules/archive/pdfs/226ark.pdf</a>). While this requirement is specific to SLD, districts also have the option of using such a process as part of the evaluation procedures for other disability categories. The guidance document also aligns directly with the Illinois

(<a href="http://www.isbe.net/pdf/rti\_state\_plan.pdf">http://www.isbe.net/pdf/rti\_state\_plan.pdf</a>) and sets the stage for Illinois schools to approach special education eligibility and entitlement decisions from a broader context of quality instruction, intervention, and assessment to address the learning and behavioral needs of all students.

The guidance document was developed and reviewed through an extensive collaborative effort of the Committee on Special Education Eligibility and Entitlement in an RtI Framework and ISBE. The Committee was charged with examining the federal regulations and state rules for special education, as well as informational and guidance materials from Illinois and other states, to develop the comprehensive content of the document. In finalizing the document, the committee also reviewed questions and suggestions received from the field during stakeholder review of the initial draft document. As a result, the committee incorporated changes within various sections of the final guidance document and developed a Frequently Asked Questions supplement, which will be posted at the first link above within the next two weeks.

To support implementation of the process outlined in the guidance document, a series of training events will be conducted in the next several months. Further details, including dates and locations, will be forthcoming. ISBE will also be developing one or more "professional practice" supplements to expand on basic information contained in the guidance document. For example, a supplement providing greater detail related to addressing the needs of English Language Learners (ELL) within an RtI framework will be developed in the near future through a collaborative effort of ISBE and ELL practitioners. ### **Announcement Made on Discontinued Use of 700 MHz Wireless Microphones**

The Federal Communications Commission (FCC) has announced that all wireless microphones that broadcast in the 700 MHz frequency band must cease operating no

later than June 12, 2010. This includes all microphones that operate on any frequencies between 698 MHz and 806 MHz.

The FCC seeks to prevent unlawful interference with public safety entities and commercial users that operate on the 700 MHz band following completion of the Digital Television transition last June and to prevent users from receiving interference while using their microphones.

If a microphone does not operate on frequencies within the 700 MHz band, no action is required.

Wireless microphones currently operate in a variety of different frequency bands, including many frequencies outside of the 700 MHz band. Only those wireless microphones using the 700 MHz band must cease operating. Some wireless microphones that operate in the 700 MHz band can be successfully retuned to operate in frequencies other than 700 MHz. If the wireless microphone operates only in the 700 MHz frequency band, it will need to be replaced.

# Funding and Disbursement Services

#### FY 2010 General State Aid Finalized

Fiscal Year 2010 General State Aid (GSA) calculations have been finalized. Final computations and claim information can be accessed in GSA Inquiry at <a href="http://webprod1.isbe.net/gsainquiry/asp/default.asp">http://webprod1.isbe.net/gsainquiry/asp/default.asp</a>. The GSA appropriation was almost \$18.9 million short of the final computed cost, so according to the GSA statute, the Supplemental GSA (Poverty Grant) must be prorated to 98.3 percent of the eligible reimbursement. The last FY 2010 GSA payment will reflect the prorated amount.

Two bills passed late in the legislative session contributed to the shortfall since their cost was not included in the FY 2010 GSA projections. PA 96-0300 requires that a year newer Corporate Personal Property Replacement Tax be used in the GSA calculation and resulted in an increased cost of just under \$9 million. The second law, PA 96-0152, required an alternate Property Tax Extension Limitation Law (PTELL) adjustment in the GSA formula for districts that passed a referendum to increase the limiting rate. This law resulted in an increased cost of \$10.5 million. In addition, errors discovered in some district tax rates and average daily attendance also delayed the final calculation of GSA.

Please note that the remaining GSA payments will not be loaded in the Final Reimbursement Information System (FRIS) Inquiry until after the American Recovery and Reinvestment Act (ARRA) State Fiscal Stabilization Fund (SFSF) – Education payments are vouchered in GSA in the next couple of months. We anticipate that three out of four GSA payments will be made with SFSF Education payments in February and March. Further information will be forthcoming.

#### Reminder: New Cellular Laws in 2010

Please be aware of two new cellular laws that took effect Jan. 1. Illinois is now among 19 states that have outlawed texting while driving to reduce the number of crashes and fatalities. On Aug. 6, Gov. Pat Quinn signed into law House Bill 71 and House Bill 72, which took effect on

Jan. 1. Motorists are impacted in three ways according to the two new laws: 1) no motorist will be allowed to compose, send or read messages or access the Internet while driving; 2) no motorist will be allowed to talk on a cell phone while driving through a construction zone or a school zone (There are exceptions for a person engaged in highway construction or maintenance, emergencies and when the phone is in voice-activated mode.); and 3) no motorist under the age of 19 can use a cell phone at all while driving. The ban includes personal digital assistants and portable or mobile computers.

#### **Green Cleaning Schools Act Reminder**

The Green Cleaning Schools Act is the Illinois law that requires green cleaning in Illinois schools. The act requires Illinois elementary and secondary schools, both public and non-public, to purchase and use only environmentally sensitive cleaning supplies. Schools are required to purchase and use six categories of green cleaning supplies;

- Bathroom Cleaners: glass, window and mirror cleaners
- Carpet Cleaners: hand cleaners and hand soaps
- General Purpose Cleaners: paper products used for cleaning

Schools were required to begin purchasing and using environmentally sensitive cleaning supplies as of May 9, 2008.

The Green Cleaning Schools Act allows individual schools to forego green cleaning if to do so would not be economically feasible. Any school in such a circumstance may complete an application to provide written notification to the Illinois Green Governments Coordinating Council. ## Lawn Care Products Application and Notice Act

On Aug. 18, 2009, Senate Bill 1769 was signed into law by the Governor as Public Act 96-0424 amending the School Code [105 ILCS 5], the Child Care Act of 1969 [225 ILCS 10] and the Lawn Care Products Application and Notice Act [415 ILCS 65].

In summary, language was added to the School Code, Child Care Act and the Lawn Care Products Application and Notice Act requiring:

- each school district and the Chicago Board of Education to adopt a procedure to comply with the requirements of the Lawn Care Products Application and Notice Act (which requires written or telephonic notification at least four business days before application of the lawn care product) and the Structural Pest Control Act (which maintains the requirement of written notification at least two business days before application of the pesticide), along with designating a staff person who is responsible for compliance with the requirements of these Acts.
- the owners and operators of licensed day care centers to ensure that lawn care products will not be applied to day care center grounds when children are present at the center or on its grounds, and to ensure that proper notice as is given to parents and guardians before applying pesticides or having pesticide applied to the day care center grounds,

### **USDA Farm-to-School Tactical Teams Prepare to Visit Schools**

The Tactical Team is comprised of individuals from the U.S. Department of Agriculture (USDA) Food and Nutrition Service (FNS) and the Agricultural Marketing Service (AMS). This Tactical Team will work together to assist schools in purchasing more local foods.

USDA's Farm-to-School Tactical Teams will soon begin touring America's school cafeterias to identify challenges and opportunities to help them transition to purchasing more locally grown foods. In 2010, the Tactical Team will conduct visits at nine schools that represent varied demographics and characteristics. During these site visits, the team will seek to learn about the school

district's Farm-to-School efforts including, but not limited to, how the activities first began, the relationship between growers and the school district, what obstacles exist or were faced along the way, and the effects the activities have had on the school and the community.

### First-Graders Through 12th-Graders Eligible for Youth Internet Safety Contest

The Illinois State Board of Education, Attorney General and Governor's offices are sponsoring the Youth Internet Safety Contest. The contest is open to all students in grades first through 12th and encourages students to help spread the word to their peers about Internet safety.

Students are asked to create a poster, video, podcast or slideshow addressing Internet safety, and specifically cyberbullying. Many schools have taught online safety for years. But starting with this school year, districts are required to incorporate Internet safety at least once each school year in grades from third through 12th. The full text of the law can be found in the School Code, Section 27-13.3 (http://tiny.cc/m9ymS).

Each local school district can determine how to incorporate the lessons into curriculum. But some recommended topics include safe and responsible use of social networking Web sites, chat rooms, bulletin boards and other means of communication on the Internet. It is also recommended that instruction includes information on recognizing, avoiding and reporting online solicitation by sexual predators; recognizing and reporting online harassment and cyberbullying; and knowing the risks of transmitting personal information on the Internet.

# Science Educators in Illinois Teaching at Grades 6-12 Eligible for Award
