Message From State Superintendent Christopher A. Koch

This latest blast of wintry weather is a strong reminder that winter does not officially end until March 20. The system that went through last week impacted a huge portion of our state with snow, ice and extreme temperatures. I hope you have been able to dig out and get your operations back to somewhat normal.

Dealing with wintry weather is never easy and cancelling class is a difficult decision. It can be a scheduling nightmare for everyone involved, but conditions such as we had last week can be life threatening. It's always better to error on the side of caution.

Many schools were out for multiple days last week. Add to that days that may have been canceled in January and December, and many of you may need to closely examine your school calendar.

Each district is required to schedule at least five emergency days. These emergency days may be used at the discretion of the district, but they must be made up prior to the end of the school year. Any unused emergency days must be taken off prior to submitting the final school calendar.

Once a district uses all of its proposed emergency days, if they must close the district due to a weather emergency or other condition beyond the control of the district that poses a hazardous threat to the health and safety of students, they may request approval for an Act of God day or to modify their calendar to

schedule additional days at the end of the school year. Approved Act of God days do not have to be made up and do not negatively affect the school calendar or General State Aid.

Teachers Retirement System 2010-11 Employer Contribution Rates Adjusted

The Employer TRS (Teachers Retirement System) contribution on federally-funded salaries has been adjusted due to Public Act 96-1511. The Teachers Retirement System was required to recertify the appropriation amount to TRS from the state of Illinois for fiscal year 2011. The required 2010-11 state funding rate recertified by the TRS Board of Trustees is 23.10 percent. As a result, the employer TRS contributions on salaries paid from federal funds for the 2010-11 school year has changed from 25.12 percent to 23.10 percent. This change is retroactive to July 1, 2010.

2009-10 Federal Grants (FY 2010)

Local education agencies (LEAs) with approved 2009-10 Federal grants need to revise their FY 2010 final expenditure reports submitted to the Illinois State Board of Education if the following conditions exist:

- 1. The federally-funded TRS rate was paid for those salaries AFTER July 1, 2010, and
- 2. The higher rate was charged to the grant and reported on the final Fiscal Year 2010 expenditure report.

Please send an e-mail to the appropriate contact person listed below in the Division of Funding and Disbursement Services and request that they remove the final expenditure report indicator so that a revision can be transmitted due to the TRS rate change. The reduction will result in a greater carryover amount into FY 2011 projects that allow carryover. Please include in the email, the Project Number (fiscal year, program code AND the Region-County-District-Type code).

2010-11 Federal Grants (FY 2011)

LEAs with approved 2010-11 Federal grants may have to submit an amendment if the difference of the TRS rate is needed for another expenditure and the additional expenditure is greater than the allowed variance of 20 percent or \$1,000, whichever is greater. An amendment is NOT required if the only change is to adjust the rate as described in the breakdown/budget details.

School District Annual Financial Report Review Process Under Way

All district superintendents should have received an email broadcast asking the district to review their preliminary Financial Profile Report. If district administration wants to submit comments regarding their district's finances that will be published along with their Financial Profile Report, the comments must be submitted no later than Tuesday, Feb. 15, 2011.

The broadcast included links to the memorandum, instructions and definitions to assist with the review process. These documents are also available in IWAS and on the School District Financial Profile Score Information webpage.

The e-mail broadcast and this notice will be the only ones sent to districts. If you have not received the broadcast, please contact ISBE at 217-785-8779. If you have given another person authority to review these reports, please forward the e-mail broadcast to them. Since the financial profile designation will be approved and publicly released by ISBE, it is crucial that districts review their financial profile data and score. Any district that wishes to include comments that support the Financial Profile Report may do so directly in IWAS beneath the report. Although comments are optional, they are encouraged; this is an opportunity for districts to explain significant financial circumstances.

The financial profile will be adjusted to incorporate mandated categorical aid payments due to school districts that were not paid by June 30, 2010.

Any district applying for federal Title III funds must submit applications by this deadline to be considered for federal Title III funding.

Students who are 0-21 years old and have not graduated from high school may be eligible if they have moved within the past three years due to economic necessity across state or school district lines with a parent or guardian or on their own to obtain temporary or seasonal work in agricultural production, fishing or food processing industries. A certified recruiter must document that children qualify as migrant students.

FY 2011 Final Title III Allocation Amendments

Final allocations (including carry-over funds from the previous year) for FY11 Title III Language Instruction Programs for Limited English Proficient Students (LIPLEPS) have been posted. School districts awarded initial LIPLEPS funding through the FY11 Consolidated ELL Application must now revise their budgets to reflect these amounts. Please note that carry-over funds and prepayments will only show up when an amendment is created in IWAS.

Districts with returned applications must revise the LIPLEPS budget to include the entire amount shown on the allotment.

Districts with approved applications must create and submit an amendment.

Please be certain to revise the Payment Schedule, the Proposed Program Activities and all other relevant sections of the application to ensure that they align with the amended budget.

Data Analysis and Progress Reporting

Administrator and Teacher Salary and Benefits – School Year 2011 Report

Sections 10-20.47 and 34-18.38 of the School Code [105 ILCS 5/10-20.47 and 5/34-18.38] require school districts to report administrator and teacher salary and benefits to the Illinois State Board of Education:

"Each school board shall report to the State Board of Education, on or before July 1 of each year, the base salary and benefits of the district superintendent [or the general superintendent of schools or chief executive officer] and all administrators and teachers employed by the school district. For the purposes of this Section, "benefits" includes without limitation vacation days, sick days, bonuses, annuities, and retirement enhancements." To comply with this law, school districts are required to submit to ISBE the following data for each individual employed as an administrator and/or teacher during school year 2011:

- Name: Legal last name, first name, and middle name
- **Position:** Main position, i.e., District Administrator, Other Administrator, or Teacher
- **Title:** Title for main position (optional)
- **Base Salary:** Dollar amount of base salary for all positions combined
- **FTE (Full-Time Equivalency):** FTE for all positions combined, counted in hundredths
- Vacation Days: Number of vacation days awarded this school year
- Sick Days: Number of sick days awarded this school year
- **Bonuses:** Dollar value of bonuses
- **Annuities:** Dollar value of employer-provided qualified and nonqualified annuities
- **Retirement Enhancements:** Dollar value of employer-provided retirement enhancements
- **Other Benefits:** Dollar value of other benefits provided by employer

The data must be submitted via the "Administrator and Teacher Salary and Benefits" system in IWAS. The system will be open for school year 2011 data entry starting Thursday, June 16, and the deadline to submit is Friday, July 1 (11:59 p.m.). The salary and benefits data you report are to include known payments through June 30, 2011, on all forms of compensation received by an individual.

District administrators and other authorized users can access the system March 1 through June 15 to visit a "Preparing for Submission" page. The page contains specific information about the data to be submitted and the required file upload process. ISBE strongly suggests downloading and using the Excel spreadsheet template that includes the proper headers and cell formatting required for your file to upload. You can use the Excel spreadsheet to gather and compile your data. After saving as a CSV file, you can upload to ISBE once the system opens for data entry.

Deadline Coming Up to Submit New Technology Integration Plan

Several federal and state funding programs for schools and districts in the state of Illinois require an approved Technology Integration Plan (TIP). The Illinois State Board of Education serves as the approving entity of Technology Integration Plans for public schools and/or districts outside of the city of Chicago.

Schools and/or districts with a Technology Integration Plan expiring June 30, 2011, have until 11:59 p.m. Monday, Feb. 28, 2011, to submit a new three-year Technology Integration Plan for FY11 approval. Plans will only be accepted for approval if submitted online, via the proper Illinois Interactive Report Card (iirc) template, available online at <u>http://iirc.niu.edu</u>, by the deadline. Districts that are not able to submit a plan by the deadline due to extenuating circumstances must request an extension, in advance of the deadline, by contacting Marica Cullen at <u>mcullen@isbe.net</u>.

Special Notice to Schools and Libraries applying for E-Rate reimbursements and/or discounts only: "Beginning with FY2011, technology plans are required only for Priority 2 services (Internal Connections and Basic Maintenance of Internal Connections)."

Assessment

Amendments to Rules Governing the State Assessment (23 III. Adm. Code 1.30)

The Illinois State Board of Education has amended its rules governing the State Assessment to define "grade 11" for the purpose of administering the Prairie State Achievement Examination (PSAE) or the Illinois Alternative Assessment (IAA). The text of the revised rule is presented below; ISBE anticipates the rule becoming effective on Jan. 20, 2011.

Section 1.30(b)(4) Districts shall administer the Prairie State Achievement Examination (PSAE) or the Illinois Alternate Assessment (IAA), if applicable under subsection (d) of this Section, to students in grade 11. (See Section 2-3.64 of the School Code.) For the purpose of this subsection (b)(4), "grade 11" means the point in time when a student has earned the number of credits necessary for enrollment in grade 11, as determined by his or her school district in accordance with Sections 1.420(b) and 1.440 of this Part. A district shall not promote a student to grade 12 status until that student has taken either the PSAE or IAA, as applicable.

Guidance for Spring 2011 Testing:

- For the 2011 Spring PSAE and IAA administration only, home school districts are not required to pull back (reclassify) grade 12 students who have already been promoted to grade 12 prior to the administration of the PSAE or IAA. However, any students who take the PSAE or IAA in spring 2011 will be counted as grade 11 for the purposes of computing Adequate Yearly Progress for participation and performance, as appropriate.
- Home School Districts are allowed to promote a student to grade 12 if the student was exempt from the state assessment while in grade 11 (Exemptions include: Medically Exempt, Homebound Exempt, In Jail/Locked Facility, Out of State/Country [See 2010-2011 Guidance PSAE and Receipt of a Regular High School Diploma]). These exempt students would be eligible for a regular high school diploma, even though they would not take the PSAE or IAA.
- Home School Districts are allowed to maintain a student as grade 12 if the student was exempt from state assessment while in grade 12 (Exemptions include: Medically Exempt, Homebound Exempt, In Jail/Locked Facility, Out of State/Country, Non-Regular Diploma Recipient, or New to IL Public School in Grade 12). These exempt students would be eligible for a regular high school diploma, even though they would not take the PSAE or IAA.
- 4. For the 2011 Spring IAA administration only, Home School Districts are allowed to maintain a student as grade 12 if the student was IAA eligible and absent from the assessment while in grade 11 or were IAA eligible last year but not tested due to error. These students would be eligible for a regular high school diploma. However, upon the effective date of the new rule, students for whom the IAA is the appropriate state assessment may not be promoted to grade 12 status until they take IAA.
- 5. Home School Districts are allowed to maintain a student as being in grade 12 if they are new to the school and had achieved grade 12 status in their previous school that is a non-public school or is located out of the state or country. These transfer students would be eligible for a regular

high school diploma, even though they would not take the PSAE or IAA.

- 6. Students who have completed all coursework but must take the PSAE in the spring to fulfill the PSAE Diploma Requirement should continue to be enrolled in the Student Information System until May 13, 2011, to ensure their inclusion in the Assessment Correction file.
- 7. Students who are classified by the district as being in grade 11 multiple years (due to credit status) must participate in the state assessment each spring that they maintain grade 11 status.

Over the summer, the Department of Education conducted a National Youth Listening Tour, meeting with more than 1,800 middle and high school students across the country. The day-long summit will address many of the key issues that were raised during the tour, including family engagement, high quality teaching, mentors and school climate.

Educator Certification

Division's Initiatives Put Technology to Use and Improves Efficiency

ISBE's Educator Certification Division has made giant strides in recent years to eliminate paper and make better use of technology. Under the leadership of division administrator Linda Jamali, the division has eliminated the need for many filing cabinets with the scanning of paper applications and corresponding documentation. All applications are currently scanned at the point of intake. Prior to this, original paper copies filled many file cabinets which have all now been scanned and documents have been archived. This achievement has never before been accomplished in certification. This has helped to streamline the process, provide additional work space for evaluators, and remove a backlog in processing applications. In 2004, the division had an 18-month backlog, which had been as much as 3 years in prior years and currently most processing is completed in less than 60 days.

The division also implemented a new phone system to better handle the hundreds of calls they receive each day, eliminated mailing new certificates when endorsements are added which has reduced mailing costs, and have worked with higher education so that they would support adding endorsements rather than individuals requesting evaluations directly from the ISBE. This last initiative is an effort to move staff from evaluating transcripts to becoming providers of support and guidance to institutions. Since requirements are based on standards, institutions have a strong understanding of what courses meet specific standards rather than evaluators having to study course catalogs, review transcripts and make decisions based on course titles.
