Message From State Superintendent Christopher A. Koch

Last week I met with a group of stakeholder to discuss the Special Education Certified School Nurse rules. Complying with the rules is proving to be a challenge for districts as they face both shrinking resources and additional mandates from the state and an insufficient supply of CSNs.

My goal during the meeting was for both sides to come together and gain a better understanding of what they were trying to accomplish, what issues they face with implementation and if they could attain a common ground to benefit all students.

I have asked my staff to put together a plan that would be the starting point for a discussion that would ensure that student medical needs are considered fully in the IEP process, while also allowing districts the ability to meet those needs for all students in a way that takes into consideration the supply of CSNs and the reality of our state's financial situation. I believe if all parties work together we can develop additional training that can be delivered efficiently online or via webinar to nurses currently serving within school districts so that we are able to meet student needs during the IEP process.

I believe both sides in this issue want what is best for our students and I am confident we will be able to find common ground as we move forward.

I also want you to be aware that I am bringing before the Board later this month the rules that define special education and general education class size limits. Our current rules go beyond federal law and I have always been of the mind that the state should not dictate limits on class size.

Class size is an issue that is best addressed locally. We are no longer under the Corey H. settlement agreement and our data shows that these artificial limits are actually keeping students with disabilities out of general education classrooms. It is limiting these special education students' access to the curriculum and instruction they deserve and need to be successful. I understand that there are those who will not agree with me; however, I do believe it's what's best for all students.

After about one week of opening the 5Essentials Survey we have approximately 3 percent of students and 17 percent of teachers responding. Many districts are expressing concerns about the parent survey data going public this year. Given the concerns about security, we will not be sharing parent surveys publicly during this first year, but will leave it up to local administrators to determine if they want to share the data publicly. We have developed a Common Core survey targeting feedback from classroom teachers. It's designed to provide a snapshot of Illinois' level of readiness for common core implementation and to identify resources and support for

Needs Assessment of Illinois Statewide System of Support Getting Under Way

The Illinois Center for School Improvement is planning a needs assessment of the current Illinois Statewide System of Support (SSOS). The needs assessment, titled SSOS Audit, will engage educators and SSOS partners across the state in a needs assessment to identify strengths and gaps in the current system. The SSOS Audit findings will be used to inform strategies to move the system forward, aligning services to the Eight Essential Elements and

preparing future services for the new differentiated accountability system.

The SSOS Audit includes four phases: data collection, analysis and reporting, triangulation of data (co-interpretationTM), and action planning. The data collection phase of the project will occur during February and March. Following data collection, an audit team will prepare a set of data reports, and participants from across the state will be involved in a co-interpretationTM of the data to produce prioritized findings of the current status of the SSOS. Co-interpretation participants will then use these findings to begin action planning for the future of the system. The Center for School Improvement will

disseminate a final report of the SSOS Audit process, findings, and recommendations before the beginning of the 2013–14 school year.

In the next few weeks, Illinois Center for School Improvement staff at American Institutes for Research will be contacting selected participants from SSOS areas, regional offices of education and intermediate service agencies, districts, and schools to schedule interviews. Also, in the upcoming weeks, the Illinois Center for School Improvement will issue additional information regarding details of data collection and the SSOS Audit process.

Applications for Summer Migrant Education Services Funding Available

ISBE's Division of English Language Learning is accepting applications for FY13 federal Migrant Education Program funding for summer school programs in districts with qualifying migrant children under Title I, Part C of the No Child Left Behind Act. The application is available at http://www.isbe.net/bilingual/htmls/migrant.htm. The application deadline is Friday, March 15, 2013.

Students who are 21 years old or younger and have not graduated from high school may be eligible if they have moved within the past three years due to economic necessity across state or school district lines with a parent or guardian or on their own to obtain temporary or seasonal work in agricultural production, fishing or food processing industries. A certified recruiter must document that children qualify as migrant students.
