## Message From State Superintendent Christopher A. Koch

I want to extend my congratulations to Homewood-Flossmoor Community High School. They have been singled out in the AP Report to the Nation as the top school in the country for having the greatest number of African American students from the class of 2009 score a 3 or better on the AP Psychology exam. Good job!

We saw a record number of students take AP exams in Illinois in 2009, and we continue to see a more diverse pool of students taking and passing these exams. We saw an increase of 9 percent in the overall number of students taking the exams, with nearly 11 percent more African American students and 16 percent more Hispanic students taking these exams. Additionally, we saw a 25 percent increase in African American students receiving a 3 or above, a 21 percent increase in Hispanic students scoring a 3 or above and an 8 percent increase in the number of overall students receiving a 3 or above.

The numbers confirm the strides many of you have already seen – more and more students, and a much greater diversity of students, are taking these rigorous courses to better prepare themselves for college and careers. This rigorous coursework will pay dividends for students and schools as we continue our progression toward internationally benchmarked standards.

We are working with the College Board to get more information out to schools about how they can increase their participation in AP courses. The General Assembly's spring legislative session is in full swing. Members have been meeting in Springfield the past two weeks and are scheduled to be returning each week until the end of March when they will recess for two weeks.

What will likely demand the most attention will be the budget. Gov. Quinn is set to present his budget March 10. The Board has made its budget recommendation and will meet this week when they may make a minor modification to their budget recommendation dealing with an increase to Mandated Categoricals.

There are already all sorts of rumors floating around about what may or may not end up being in the final budget, but at this point those are only rumors. My advice to you is to review what the Board is recommending, what your district needs are and communicate those needs. Communicate them to your constituents and your elected representatives. Tell them what your district needs are and what the consequences to your district may be if those needs are not provided. Lawmakers need to hear this and the public needs to hear this and hear it from you.

Finally, I know some of you are anxious to know when you need to begin developing your scope of work as part of participation in Race to the Top (RT3). We will not receive notification from the feds until April as to whether or not we will be funded under RT3. If we receive notification that we are one of the states selected we will send out a

notification via IWAS. Once you receive that notification, you will have 90 days to develop those plans and provide them to ISBE. We will have more specifics at that time.

#### Reminder: 2008-09 Study of School Level Expenditure Report Deadline Coming Up

A school level expenditure report for the 2008-09 school year is being required per the American Recovery and Reinvestment Act of 2009 (ARRA) for local education agencies (LEAs) that are entitled to funds under Title I, Part A of the Elementary and Secondary Education Act (ESEA) provided under ARRA (i.e., LEAs that are entitled to ARRA Title I funds calculated under the Targeted Grant and Education Finance Incentive Grant formulas). Such LEAs are required to report school-by-school expenditures from state and local funds for the 2008-09 school year for all of their schools (not just Title I schools). The U.S. Department of Education states that they will use these data to examine the extent to which school-level education resources are distributed equitably within and across LEAs.

To facilitate this required reporting, we have created a new IWAS application, "Study of School Level Expenditures." To access the application, log on to IWAS, and under System Listing, it is located under "Reporting." This specific report is focused on only state and local fund expenditures for Regular K-12 instruction, within four categories:

- Personnel salaries at the school level for all school-level instructional and support staff.
- Personnel salaries at the school level for instructional staff only.
- Personnel salaries at the school level for teachers only.
- Non-personnel expenditures at the school level (if available).

An Excel worksheet is available for download and completion which can be accessed at http://webapps.isbe.net/expstudy/download/schoolworks heet.xls. The specific function and object codes, per Part 100 Requirements for Accounting, Budgeting, Financial Reporting and Auditing, are provided to assist in the calculation of reporting data per school. It is highly recommended that a separate spreadsheet be completed and maintained for future reference and review for each of your schools. These spreadsheets are not to be submitted to ISBE, but used as a tool for assist in arriving at the totals necessary for this report. The four totals calculated for each school, as well as the number of hours necessary to arrive at the data for each school, are the components which must be entered in the "Study of School Level Expenditures" report.

A "calculate and save" feature is available on the "Details" page of the report to allow multiple sessions of entry of the data. Once all data has been entered, the document author must submit it to the district administrator in IWAS. The district administrator submits the report to ISBE. You will receive IWAS messages when each step is complete.

School level expenditures to be excluded from this report include those:

- From federal program funds.
- From special education funds.
- Not associated with regular K-12 programs, such as preschool and adult education.
- That serve students from more than one school attendance area, such as summer school.
- Expenditures for employee benefits.

# Report of Administrator and Teacher Salary and Benefits

Public Act 096-0266 added Sections 10-20.46 and 34-18.37 to the School Code [105 ILCS 5/10-20.46 and 5/34-18.37]. The two new Sections contain identical language requiring school districts to report administrator and teacher salary and benefits to the Illinois State Board of Education, effective Jan. 1, 2010:

"Each school board shall report to the State Board of Education, on or before July 1 of each year, the base salary and benefits of the district superintendent and all administrators and teachers employed by the school district. For the purposes of this Section, "benefits" includes without limitation vacation days, sick days, bonuses, annuities, and retirement enhancements."

To comply with this new law, school districts will be required to submit to the Illinois State Board of Education (ISBE) in late June the following data for each individual employed as an administrator and/or teacher during the 2009-10 school year:

• Name: Legal last name, first name and middle name

- **Position:** Main position, i.e., District Superintendent, Other Administrator, or Teacher
- **Title:** Title for main position (optional)
- **Base Salary:** Dollar amount of base salary for all positions combined
- **Full-Time Equivalency (FTE):** FTE for all positions combined, counted in hundredths
- Vacation Days: Number of vacation days awarded this school year
- Sick Days: Number of sick days awarded this school year
- **Bonuses:** Dollar value of bonuses
- **Annuities:** Dollar value of employer-provided qualified and nonqualified annuities
- **Retirement Enhancements:** Dollar value of employer-provided retirement enhancements
- **Other Benefits:** Dollar value of other benefits provided by employer

These data will be reported via IWAS, in a new Administrator and Teacher Salary and Benefits system that will be separate from the Teacher Service Record system. The new system will be open for data entry June 16-30, with the salary and benefits data that is to be reported based on known payments through June 30, 2010. Questions about the new system may be directed to the ISBE Data Analysis and Progress Reporting Division at 217-782-3950.

How should FTE be calculated? FTE should be calculated as the total number of hours worked through June 30, 2010, divided by the number of hours in a fulltime schedule through June 30, 2010. Consider the total number of hours worked during the school year as equivalent to 1 FTE even if the period is less than 12 months if a teacher is working pursuant to a contract regarded as full time. A teacher working in excess of a full-time contract would be counted as more than 1 FTE (e.g., a teacher who is working 12 months of the year and receiving additional compensation for working during the summer months). That teacher's FTE should be determined by how many hours the teacher worked in relation to the number of hours in the normal full-time contract.

# **Curriculum and Instruction**

### Illinois Advanced Placement Fee Reduction Program for 2010

Illinois will participate in the Advanced Placement Federal Fee Reduction Program for the 2010 testing sessions. High school students in Illinois are eligible to participate in the program if they qualify for the Federal Lunch Program (either free or reduced levels) and are identified as such in the state's Student Information System.

To participate in the program, the school's AP coordinator must complete the following steps:

- Complete the grid on each eligible student's answer booklet indicating the exam qualifies for the Fee Program;
- Complete the online invoice at the College Board Web site indicating the number of qualifying Fee Program exams;
- Mail a copy of the online invoice to Marica Cullen, Illinois State Board of Education, 100 N. First Street, C-215, Springfield, IL 62777 no later than June 15, 2010; and
- 4) Mail a copy of the online invoice with any payment due to the College Board no later than June 15, 2010.

#### Deadline Coming Up to Submit New Technology Integration Plan

Several federal and state funding programs for schools and districts in the state of Illinois require an approved Technology Integration Plan (TIP). The Illinois State Board of Education serves as the approving entity of Technology Integration Plans for public schools and/or districts outside of the city of Chicago.

Schools and/or districts with a Technology Integration Plan expiring June 30, 2010, have until 11:59 p.m. Monday, March 1, to submit a new three-year Technology Integration Plan for FY10 approval. Plans will only be accepted for approval if submitted online, via the proper Illinois Interactive Report Card (iirc) template, available online at <u>http://iirc.niu.edu</u>, by the deadline. Districts that are not able to submit a plan by the deadline due to extenuating circumstances must request an extension, in advance of the deadline, by contacting Marica Cullen at <u>mcullen@isbe.net</u>.

The FY11 Consolidated English Language Learning Programs Application for state TBE/TPI and federal Title III (LIPLEPS and IEP) funding will be completed and submitted electronically online via eGMS this school year. Please join ISBE's Division of English Language Learning staff for a training webinar that will present information on accessing and completing Submission Part I of the new electronic consolidated application. The FY11 eGMS Consolidated English Language Learning Application is divided into two submissions, Part I The ELL Enrollment Summary and Ceiling Calculator and Part II The ELL Program Service Plan and Budgets.

1. The ELL Enrollment Summary and Ceiling Calculator was scheduled to be available online by Feb. 8, and data submissions are due to ISBE by March 15. An announcement will go out to districts on IWAS informing them that the system is available for data submission.

2. The ELL Program Service Plan and Budgets is scheduled to be posted online by May 2010 and data submissions due to ISBE by June 30. Only those districts that complete the ELL Enrollment Summary and Ceiling Calculator will be eligible to apply for FY11 funding by submitting the ELL Program Service Plan and Budgets. The FY11 application submission and approval process will all be completed online. The Excel-based consolidated application forms used in previous years will no longer be available on the ISBE website.

To assist school districts with the eGMS application, a technical assistance workshop via Webinar for Part I has been scheduled from 9:30 to 11:30 a.m. Feb. 17. A second Webinar for the Part II submission is scheduled for 9:30 to 11:30 a.m. May 12. Both sessions will be recorded and posted on the DELL Web site, <u>http://www.isbe.net/bilingual</u>. With this being the first year of implementation; we strongly encourage anyone responsible for the submission of the application, including program coordinators and directors, to participate in this training.

### Food Allergy Guidelines Committee – Public Act 96-0349

By July 1, 2010, the Illinois State Board of Education, in conjunction with the Illinois Department of Public Health, shall make available to each school board guidelines for the management of students with lifethreatening food allergies developed by an ad hoc committee.

By Jan. 1, 2011, each school board shall implement policy based on these guidelines. Also, at least every two years, an in-service training program for school personnel who work with students must be conducted by persons with expertise in anaphylactic reactions and management.

The committee will hold its second meeting on Feb. 22, 2010, via video-conference in Springfield and Chicago. ## Annual Book Grant Program Gearing Up

The Illinois School Library Media Association/Library Book Selection Service Fund will issue its third annual book grants this year. Public and private school libraries as well as public libraries registered in any of the Illinois Readers' Choice awards programs — the Monarch Award, the Bluestem Award, the Rebecca Caudill Young Readers Book Award and the Abraham Lincoln Illinois High School Book Award — are eligible to apply.

Grant recipients will be awarded one set of the 2011 reading campaign books for the award program indicated on their application. The titles in each book award set are determined by the individual committees in charge of the reading award programs. Sets include one copy each of the 20 or 22 books, depending on the award program selected.

Funds for the endowment fund were received by the Illinois School Library Media Association when the nonprofit Library Book Selection Service was dissolved in June 2005. A stipulation of the agreement between LBSS and ISLMA was that the assets be invested in order to fund grants to encourage student reading of quality literature in Illinois.

Book vendors interested in bidding for the contract to provide books for this grant will find information at the same Web site. This is a competitive bid.

The ISLMA/LBSS Endowment Fund's mission is to "promote reading in Illinois." Both in 2008 and 2009, the fund awarded 160 sets of books to school and public libraries.
