### Message From State Superintendent Christopher A. Koch

The U.S. Department of Education (USEd) approved our double testing waiver last week. The waiver will allow us to provide flexibility for some schools as they field test the new Partnership for Assessment of Readiness for College and Careers (PARCC) this spring. This is a one-year waiver for selected schools that are field testing the full assessments in mathematics or English Language Arts for the PARCC assessment and an alternate assessment,

which is being developed by Dynamic Learning Maps for students with the most significant cognitive disabilities.

This specific waiver allows schools to field test the full PARCC assessments in one content area, either ELA or math, without having to also test students in that same content area with the ISAT. In addition, it will allow us to freeze the AYP status of those schools where the full assessment is being administered in at least one grade. We resubmitted our waiver request for flexibility from some requirements of No Child Left Behind but have not

received a response from the USEd .The sticking point remains our 2016-17 timeline for including student growth in teacher evaluations statewide. Illinois committed this timeline into state law, and we will not accelerate simply to appearse the federal government.

This week, we will meet with members of the General Assembly during our first legislative budget hearing for Fiscal Year 2015, and the State Board will convene for its February meeting tomorrow. I will testify with several Board members later today in front of the House Elementary and Secondary Education Committee. We'll stress the need to fully fund GSA and restore many of the cuts we've seen since Fiscal Year 2009. Last week, I met with several members of the legislature to begin laying the

groundwork and while they seem receptive to our request, it is certainly going to be a challenge.

On Wednesday, the State Board of Education will meet via videoconference from our offices in Springfield and Chicago. The Board will receive a presentation on the edTPA. The edTPA, developed by Stanford University, is an evidence-based assessment of a teacher candidate's ability to plan, deliver and assess instruction. Colleges and universities are currently piloting the edTPA and it will be required for licensure beginning Sept. 1, 2015. The edTPA is the only product on the market that assesses a teacher candidate's ability to plan, deliver and evaluate student learning and has been field tested for reliability and validity. ### Modified ISAT Testing Window Provided Due to Severe Weather Conditions

Due to the extraordinary weather conditions experienced across the state this winter, ISBE is offering the option for districts to test during the regular ISAT testing window of March 3-14 or during a modified regular testing window, March 10-21.

Testing during the modified window is entirely optional and does not require any special request as it is still considered to be a part of the regular testing window.

All materials for both the regular and modified regular schedule must be ready for pickup by Tuesday, March 25. Early pickup of material may be scheduled.

# Public Act Changes State-Level Special Education Complaint Process

Effective Aug. 16, 2013, additional regulatory language has been incorporated into the Illinois Compiled Statutes, which impacts the formal statelevel special education complaint process (see 105 ILCS, 5/14-8.02e), as follows:

A school district or other public entity shall be required to submit a written response to a complaint within the time prescribed by the State Board of Education following receipt of the complaint. A copy of the response and all documentation submitted by the respondent to the State Board of Education must be simultaneously provided by the respondent to the complainant or to the attorney for the complainant. If the complaint was filed by an individual other than a parent of a child who is the subject of the complaint (or the child if the child has reached majority or is emancipated and has assumed responsibility for his or her own educational decisions) and the complaint is about a specific identifiable child or children, then appropriate written signed releases must be obtained prior to the release of any documentation or

information to the complainant or the attorney representing the complainant.

Given these requirements, a district and/or special education cooperative will now be required to provide a copy of the written complaint response and supportive documentation to the complainant simultaneously with the submission of those materials to the State Board of Education. In the event of a complaint filed by an individual other than a parent/guardian, the district/cooperative must secure an appropriate written and signed release prior to the issue of any child-specific documentation.

Districts/cooperatives are encouraged to review the referenced citation in order to ensure full compliance.

### ISBE Invites Comments on FY 2015 School Improvement Grant Application

The Illinois State Board of Education invites comments on its FY15 School Improvement Grant (SIG) 1003(g) application to the U.S. Department of Education.

An SEA that will make new SIG 1003(g) awards through a competitive process is required to submit a "New Awards Application." A new award is defined as an award of SIG 1003(g) funds to an LEA for a school that the LEA was not previously approved to serve with SIG funds in the school year for which the funds are being awarded – in this case, the 2014-2015 school year. Illinois may make new awards with the remaining funds not already committed to grants made in earlier competitions.

# **Proposed Rule for Professional Standards for School Nutrition Programs Personnel**

A proposed rule entitled, "Professional Standards for State and Local School Nutrition Programs Personnel as Required by the Healthy, Hunger-Free Kids Act of 2010," was published in the Federal Register on Feb. 4, 2014.

The USDA will accept public comments to these proposed rules through April 7, 2014, so please take time to review and provide feedback to the USDA. This proposed rule would establish minimum professional standards for school nutrition personnel who manage and operate the National School Lunch and School Breakfast Programs. The proposed rule would also institute hiring standards for the selection of state and local school nutrition program directors and require all personnel in these programs to complete annual continuing education/training.

This proposed rule is expected to provide consistent, national standards for school nutrition professionals and staff. The principal benefit of this proposed rule is to ensure that key school nutrition personnel are meeting minimum professional standards in order to adequately perform the duties and responsibilities of their positions.

# **Shortage of Tdap Vaccine is Declared Over by State Health Officials**

All students in grades 6 and above should now be compliant with the requirement for the Tdap vaccine, a booster shot for continued protection against tetanus, diphtheria and pertussis, commonly referred to as whooping cough.

A temporary shortage of that vaccine occurred over the summer and fall when many states, including Illinois, instituted the additional requirement for that vaccine.

This shortage is now over, and there is sufficient supply of the vaccine at local health departments and physician offices.

School and district monitoring of student health records for compliance with health requirements for attendance at school (23 Ill Admin. Code 1.20) includes verifying proof of vaccination with Tdap or a valid medical or religious waiver.

# Funds Available for Round 2 of the 2014 School Maintenance Project Grant

As the 2014 School Maintenance Grant (SMG) Round 1 is nearing the end of the review and approval process of more than 600 applications, ISBE will release the remainder of funds for another round of grant awards.

The 2014 SMG (Round 2) application will open in ISBE Web Application Security (IWAS) on Monday, Feb. 3, 2014 and close on Friday, Feb. 28, 2014. All applications and required paper work must be

submitted no later than the Feb. 28 deadline, **no exceptions**. All Health Life Safety (H/LS) Amendments required for the H/LS priority level B must be submitted no later than Feb. 28, **no exceptions**.

All grant awards will be awarded to Emergency and H/LS priority first, then to the other priority levels as funding allows. All applications will be ranked and awarded first by their priority level. Within the priority level, where it is estimated that the funding will be less than the application requests, applications will be ranked and awarded by in accordance to each district's calculated need index within that priority level.

The 2014 SMG (Round 2) is a dollar for dollar state matching grant program providing awards up to \$50,000 for the maintenance or upkeep of buildings or structures. There is approximately \$18 million available for this round. As this round will have a shorter turnaround application period, some requirements have changed. # IEMA's School Security Grant Program Provides \$25 Million for Enhanced Safety

The Illinois Emergency Management Agency (IEMA) has announced the availability of \$25 million in funds for eligible public elementary, secondary and post-secondary schools to make designated safety improvements through the competitive Illinois School Security Grant Program.

The program aims to establish a baseline security level at each eligible public elementary, secondary and post-secondary school in the state.

Last month, IEMA emailed information about the grant program to the chief official for each eligible public K-12 school district, inter-district special

education cooperative, community college and university system in Illinois. The emails contained secure access information so school officials can develop and submit their grant application. Only one application from the eligible entity will be accepted.

Based on a review of national crisis situations and consultation with key security experts, Illinois has prioritized protective measures, such as installing reinforced doors, shatter-resistance glass and physical locks for the primary public entrance at schools, to protect students and staff. Schools that have achieved this baseline capability will be able to implement other security measures for public elementary and secondary school districts.

The deadline to apply is Friday, March 14. Applications will be evaluated on a number of criteria, including known hazards, threats and risks; ability of the project to enhance student safety; existence of a current Emergency Operations Plan at the facility where the project is planned; ability to complete the project within the grant period; and more.
