Message from State Superintendent Christopher A. Koch

I know that I speak for agency staff and members of the Board when I say that our hearts and prayers go out to all of the people that were touched by the tragedy of last week's shooting at Northern Illinois University (NIU). I, like so many of you, continue to be stunned at what transpired and still can't believe it occurred.

Education is a world unto itself, but a small one. So many of us work with current NIU staff or alumni, or we have family or friends who have attended or are now sending children to this university. It's one thing to see an attack like this occur half a country away, but it is quite another when it plays out in your own backyard.

As educators we are predisposed to nurture and protect; it is unthinkable that someone would step into one of our classrooms and wish to do our students harm, but it is a sad reality. These are the times in which we live.

I would urge you to please take a few moments to remember why you chose to do what you are doing today. If you are an administrator, then go spend some time in a classroom and take in the sights and sounds of our young people.

I would also urge you to spend a few moments going over your school or district emergency plans. ISBE, along with the Illinois State Police and Illinois Terrorism Task Force, sponsor the "Multi-Hazard Emergency Planning for Illinois Schools" workshops. This initiative began in December 2004 and has since trained more than 4,300 educators from 757 public school districts and 252 non-public schools. Migrant Summer School Programs

In March, the Illinois State Board of Education will release an application for funding of migrant summer school programs in districts with qualifying migrant students under Title I, Part C of the No Child Left Behind (NCLB) Act of 2001.

Students eligible for the program are children ages 0-21 who

have not graduated from high school;

- have moved within the past three years across state or school district lines;
- live with a parent or guardian or on their own;
- obtain temporary or seasonal work in agricultural production, fishing or food processing industries.

A certified recruiter must document that children qualify as migrant students. ISBE can assist districts with this process. To request assistance in identifying eligible migrant children, districts may complete the survey found at

Rules & Waivers

Green Cleaning Schools Act

The Green Cleaning Schools Act requires the use of environmentally sensitive cleaning and maintenance products in all Illinois public and non-public elementary and secondary schools with 50 or more students.

Passed into law on August 13, 2007, the Green Cleaning Schools Act will protect Illinois students, teachers and school staff from polluted indoor air that may be five to 100 times more polluted than outdoor air. This pollution is due in part to the chemicals found in everyday cleaning supplies.

The proposed rules and emergency rules for the Green Cleaning Schools Act (P.A. 95-0084) are published in the February 1 issue of the Illinois Register, available online at

http://www.cyberdriveillinois.com/departments/index/register/home.html.

This publication marks the beginning of the first 45-day notice period. During this time, the public (including Green Cleaning Schools Committee participants) may comment in writing according to the instructions published with the proposed rules. Any interested parties may submit comments, data, views or arguments concerning this proposed rulemaking. All comments must be in writing and should be addressed to:

Referenda Results

February 5, 2008, School Referenda Results

School referenda results from the February 5, 2008, election are posted on the Illinois State Board of Education's web site at:

http://www.isbe.net/research/htmls/referenda.htm.

There were 39 referenda introduced by 35 Illinois school districts in the February 5 primary election. These school referenda are sorted into three general types: tax, bond, and miscellaneous. Each type is further sorted into several more detailed categories, such as build/construct, operation/maintenance, office terms/size, school/education, boundary changes, etc. The Illinois State Board of Education has provided the school tax, bond, and miscellaneous referenda categories for easy reference.

Among the 39 referenda, 14 are tax referenda in operations/maintenance and school/education; 20 bond referenda are sorted further into three categories: 18 in build/construct and one each in financing/funding and miscellaneous. The five miscellaneous types of referenda are sorted into three categories: school/education, office terms/size, and boundary changes. A summary of results, obtained on February 6,

2008, from participating school districts and county election boards, are listed on ISBE's web site.

Accountability

FY08 Supplemental General State Aid (SGSA) Plan

Attention School Districts maintaining average daily attendance of more than 1000 students. The ISBE IWAS system is now open to file the required FY08 Supplemental General State Aid (SGSA) Plan.

With the passage of and approval of the BIMP bill, the amounts of SGSA payments for each district is now set. SGSA is included within the General State Aid payments. It is generated by the number and percentage of disadvantaged, low income, students and is calculated as part three of the districts general state aid claim. Previous to the BIMP bill's passage, the exact amounts of SGSA being distributed to the schools was unknown and the IWAS system could not accept SGSA plans prior to the due date of October 30th.

The filing of a SGSA expenditure plan for FY08 is required by the School Code for districts exceeding 1000 average daily attendance. Simply log into the ISBE IWAS system and go to SGSA Plan.

A brief narrative explaining how the SGSA expenditures will assist the district's disadvantaged students to succeed academically is required along with a SGSA expenditure budget. Please file the SGSA plans by **Sunday, March 30.**

School District Annual Financial Report (ISBE Form 50-35) Verification Process

District Superintendents received an email broadcast asking the district to verify the Operating Expense Per Pupil (OEPP), Per Capita Tuition Charge (PCTC), and the Financial Profile Report on February 5, 2008. The broadcast included links to cover letters, instructions, and definitions to assist with the verification process. These documents are also available on the IWAS website.

The email broadcast and this notice in the Superintendent's bulletin are the only notices provided to districts. If you have not received the broadcast, please contact ISBE at the number below. If you give authority to another person verifying these reports, please forward the email broadcast to them. It is important that they have the instructions and deadlines to assist them in completing the verification in a timely manner. Once the deadline passes, changes cannot be made to the 2007 Annual Financial Report data.

Since the financial profile designation will be approved and publicly released by ISBE, it is of the utmost importance that you review your financial profile data and score. Any district comments that you want included with your final financial profile report may be entered in the comment box. Although comments are optional, this is an opportunity for districts to explain financial circumstances. For further information see the following website:

Funding & Disbursements

School Safety and Educational Improvement Block Grant

Language in the Budget Implementation Bill (BIMP) allows State-recognized, nonpublic schools to qualify for the School Safety and Educational Improvement Block Grant, provided in Section 2-3.51.5 of the School Code http://www.ilga.gov/legislation/ilcs/fulltext.asp?DocNam e=010500050K2-3.51.5.

Average daily attendance (ADA) data from the prior school year is used to calculate two payments on October 30 and April 30 each year. Beginning with the second payment of this school year, which will be paid out this spring, more than 700 State-recognized, nonpublic schools will be allowed to transmit their ADA from the 2006-07 school year and participate in this program. The FY2008 budget does not include a separate appropriation for these nonpublic schools. Therefore, the \$75 million FY2008 appropriation will be divided among both public and nonpublic schools and public school districts will see an April payment that is less than the one received in October. After the nonpublic attendance data is received and the payment recalculated, you will receive notice of the adjusted payment, probably in mid-April.

Professional Development

Illinois School Leadership Task Force – Final Report Is Now Available

In August, 2006, the Commission on School Leader Preparation in Illinois Colleges and Universities submitted to the Illinois Board of Higher Education an analysis and set of recommendations for improving pre-K-12 School Leader Preparation in Illinois. Like the national reports, the Illinois report argued that principal preparation is a key component in improving student learning in schools. Upon receiving the Commission's report, *School Leader Preparation: A Blueprint for Change*, the Illinois Board of Higher Education joined with the Illinois State Board of Education and the

Governor's office to initiate a joint resolution in the Illinois General Assembly. This resolution created a task force charged with moving the *Blueprint* agenda forward.

The Illinois School Leader Task Force was formed in October 2007 to execute the following charge:

Prepare a report to the General Assembly, the Office of the Governor, the State Board of Education, and the Board of Higher Education that details an action plan for strategically improving school leadership preparation in Illinois, based on, but not limited to, the measures detailed in the report of the Commission on School Leader Preparation: Blueprint for Change.

Improving Literacy through School Libraries Program Competition

The U.S. Department of Education's (USDE) Improving Literacy through School Libraries (LSL) Program has announced its 2008 competition focused on providing funding to public local school libraries in districts with 20 percent or more family poverty.

Approximately 18.5 million dollars will be available for funding to public school districts, charter schools or state-administered schools, with an estimated 80 grants to be awarded in this competition. Funds are used to improve reading achievement through updating library collections, expansion of internet connections, purchase of new technology, professional development for library media specialists, and the extension of school library hours.
