### Message From State Superintendent Christopher A. Koch

The Board will meet tomorrow via videoconference in Chicago and Springfield and will be addressing rules regarding special education class size restrictions and principal preparation. They will also review the spring waiver report, a proposed intergovernmental agreement associated with the Early Learning Challenge and assessment contracts.

Also tomorrow, the College Board will release their AP Report to the Nation. I expect this report will continue to show

a trend of increased participation by Illinois students taking and passing AP exams. In addition, I expect that we will see improvement in closing the gaps in AP participation for low-income and minority students.

We are continuing to make available to districts EXPLORE/PLAN for all 9th and 10th graders as we move to a growth model for accountability. The high school assessment plan will provide schools and districts with a more complete picture of student progress and data for calculation of student growth through a majority of their high school years.

During the 2013-14 school year, the state will again pay for administration of EXPLORE at grade 9 and PLAN at grade 10 .We are able to expand the test administration window from Sept. 16 to Nov. 8.

Finally, we are now two weeks into the Illinois 5Essentials Survey

and so far 115,000 students, or 14 percent, and almost 43,000 teachers, about 51 percent, have completed the survey. A school must have at least a 50 percent response rate for each group in order to get a report. So far, approximately 30 percent of all schools have met that threshold for either students or teachers, or both. The survey is available for schools serving students in 6th through 12th grade and will remain open through the end of March.

#### An Important Message About the State's Child Abuse Hotline and Available Resources

School personnel play a vital role in efforts to stop child abuse and neglect in Illinois. School staff – primarily teachers and school social workers – accounted for roughly one in five reports of suspected abuse or neglect to the state's Child Abuse Hotline (1-800-25-ABUSE) during the most recent year.

Reports of suspected abuse or neglect are vital to the efforts of Illinois Department of Children and Family Services to identify victims of abuse or neglect and get them and their families the help they need to ensure every child is safe and nurtured in a loving home.

In most cases, early intervention enables children who have been mistreated to remain in their homes while DCFS provides them and their families with supportive services. In fact, of the more than 106,000 allegations of abuse investigated by DCFS last year, only about 4 percent of children were taken into protective custody. And even when allegations of abuse or neglect are unfounded, reports enable DCFS to connect families with voluntary programs and services like domestic violence counseling or drug treatment to prevent an existing risk of harm from becoming real.

The new <u>Manual for Mandated Reporters</u> developed by DCFS this fall can help answer questions about rights and responsibilities regarding child abuse investigations. Developed in partnership with educators, law enforcement and child abuse experts, the <u>DCFS Online</u> <u>Training</u> also serves as an excellent resource.

### **Center for School Improvement**

#### Needs Assessment of Illinois Statewide System of Support Getting Under Way

The Illinois Center for School Improvement is planning a needs assessment of the current Illinois Statewide System of Support (SSOS). The needs assessment, titled SSOS Audit, will engage educators and SSOS partners across the state in a needs assessment to identify strengths and gaps in the current system. The SSOS Audit findings will be used to inform strategies to move the system forward, aligning services to the Eight Essential Elements and preparing future services for the new differentiated accountability system.

The SSOS Audit includes four phases: data collection, analysis and reporting, triangulation of data (cointerpretation<sup>TM</sup>), and action planning. The data collection phase of the project will occur during February and March. Following data collection, an audit team will prepare a set of data reports, and participants from across the state will be involved in a co-interpretation of the data to produce prioritized findings of the current status of the SSOS. Co-interpretation participants will then use these findings to begin action planning for the future of the system. The Center for School Improvement will disseminate a final report of the SSOS Audit process, findings, and recommendations before the beginning of the 2013–14 school year. In the next few weeks, Illinois Center for School Improvement staff at American Institutes for Research will be contacting selected participants from SSOS areas, regional offices of education and intermediate service agencies, districts, and schools to schedule interviews. Also, in the upcoming weeks, the Illinois Center for School Improvement will issue additional information regarding details of data collection and the SSOS Audit process.

ISBE's Division of English Language Learning is accepting applications for FY13 federal Migrant Education Program funding for summer school programs in districts with qualifying migrant children under Title I, Part C of the No Child Left Behind Act. Students who are 21 years old or younger and have not graduated from high school may be eligible if they have moved within the past three years due to economic necessity across state or school district lines with a parent or guardian or on their own to obtain temporary or seasonal work in agricultural production, fishing or food processing industries. A certified recruiter must document that children qualify as migrant students.

At 11 a.m. CST on Thursday, Feb. 21, the National Assessment Governing Board will host "Lessons for All: Decades of NAEP Data From the Mega-States," a live webcast to release the results of a new report from the National Assessment of Educational Progress (NAEP).

Drawing on nearly two decades' worth of data, "Mega-States: An Analysis of Student Performance in the Five Most Heavily Populated States in the Nation" shows trends in student achievement in California, Florida, Illinois, New York, and Texas in the subjects of mathematics, reading and science at grades 4 and 8.
