## Message From State Superintendent Christopher A. Koch

Today the Board approved moving forward with our request for a waiver from some requirements of the No Child Left Behind Act (NCLB), or the Elementary and Secondary Education Act (ESEA). We have received feedback from hundreds of you throughout this process and I thank you for your willingness to work with us to shape Illinois' request.

The overarching goal of the request calls for cutting in half achievement gaps and the percent of students not making progress over the next six years. Each individual school and district will have their own targets to meet, based on the individual achievement gaps within their district or schools.

The plan also calls for the use of a Multiple Measures Index (MMI) based on four broad categories:

- 1) Outcomes
- 2) Achievement
- 3) Student progress
- 4) Educational context

Once the MMI has been calculated, schools and districts will be categorized into a five-star rating system that will align with various rewards, supports or interventions. #### PSAE Pre-ID Deadline: Feb. 24, 2012

On Friday, Feb. 24, 2012, ISBE will send the Pre-ID file to ACT for the purpose of producing PSAE Pre-ID labels. PSAE Pre-ID labels will be printed only for students listed in this file with PSAE as the "Test To Be Taken" and with a Testing School code that represents an established PSAE test site. PSAE Pre-ID labels will be shipped directly to the school identified by the Testing School code in the Pre-ID file. Schools that enroll grade 11 students in ISBE's Student Information System after Feb. 24, 2012, must still test these students, and they will automatically be added to the Pre-ID file. However, no PSAE Pre-ID label will be printed for these students, and their answer documents must be completed manually according to instructions provided in the PSAE administration manuals.

# **Driver Education Endorsement Requirements for New Instructors**

Effective Feb. 1, 2012, new driver education endorsement requirements went into effect for new driver education instructors. Please see 23 Ill. Adm. Code 242.40(a)(1) – Driver Education Personnel Requirements as well as 23 Ill. Adm. Code 25.100(n) – Endorsing Teaching Certificates for more detailed information.

# 23 Ill. Adm. Code 252.40 Driver Education Personnel Requirements

- a) Qualifications of Teachers All persons who teach a driver education course must meet the applicable standards of this subsection (a).
  - 1) A driver education instructor who teaches in a public school district shall hold a secondary teaching certificate and either have an endorsement for safety and driver education or meet the requirements of 23 Ill. Adm. Code 1.730(q) through January 31, 2012. Each individual first assigned to teach safety and driver education on or after February 1, 2012 shall be required to

hold a certificate valid for the secondary grades and an endorsement received pursuant to 23 Ill. Adm. Code 25.100(n).

# 23 Ill. Adm. Code 25.100(n) Endorsing Teaching Certificates

- n) Beginning with applications received on or after February 1, 2012, an endorsement in safety and driver education shall be issued when the applicant provides evidence of having completed 24 semester hours of college credit in the field, with at least 12 semester hours at the upperdivision or graduate level, as defined by the institution offering the coursework, distributed as follows:
- 1) 3 semester hours in injury prevention or safety;
- 2) 12 semester hours in driver education that include:
  - A) driving task analysis (introduction to driver education);
  - B) teaching driver education in the classroom;
  - C) teaching the laboratory portion of the driver education course, including:
    - i) on-street teaching under the supervision of a qualified driver education teacher;
    - ii) the equivalent of at least one semester hour's preparation in and use of driving simulation;
    - iii) the equivalent of at least one semester hour's preparation in and use of multiple-car programs; and
  - D) advanced driver education and emergency evasive driving;
- 3) 3 semester hours of first aid and cardiopulmonary resuscitation; and
- 4) 6 semester hours chosen in any combination from:
  - A) the use of technology in instruction;
  - B) safety issues related to alcohol and other drugs;
  - C) driver education for students with disabilities; and
  - D) any other safety-related area.

# FAFSA Completion Initiative Available to High Schools and Districts in Illinois

The Illinois Student Assistance Commission (ISAC) is working with school districts across the state to help identify which of their high school students have completed the Free Application for Federal Student Aid (FAFSA) in their pursuit of financial aid for college. Schools can then focus attention and support on those seniors who have not yet taken this critical step in determining how to pay for college.

The FAFSA Completion Initiative is based on work begun in 2008 with Chicago Public Schools (CPS), where FAFSA filing rates have improved by 30 percentage points since the project began. More than 50 individual high schools and three multi-high school districts across the state are now participating in the initiative.

Through this program, ISAC's research department identifies for the high school or district which of their students have completed a FAFSA, along with aggregated data such as the total number who qualify for state and federal need-based grants and the colleges to which students are sending their FAFSAs. This service is provided at no cost to high schools or school districts in Illinois and is open to any high school or district in Illinois that wishes to participate.

**Part 25 (Certification):** Addresses approval of speech-language pathology programs, and implements several pieces of recently enacted legislation.

Affected Sections: 25.115, 25.130, 25.252, 25.275, and

25.345

Effective Date: January 24, 2012

Part 375 (Student Records): Clarifies school district and nonpublic schools' requirements under the Illinois Student School Records Act [105 ILCS 10] relative to the retention, maintenance, and transfer of student records. Affected Sections: 375.10, 37.30, 375.40, 375.60, 375.70, 375.75, 375.80, 375.90, and 375.110 Effective Date: January 24, 2012

Part 425 (Voluntary Registration and Recognition of Nonpublic Schools): Amends various sections of these rules addressing initial and renewal deadlines for registered schools; retaining the status of recognized schools at the beginning of the school year; and periodic on-site visits to recognized schools.
