

# MESSAGE FROM THE SUPERINTENDENT

February 21, 2018



Hello,

**Today, Wednesday, Feb. 21, is the LAST DAY for your district to request changes to your enrollment data, which serves as the basis for fiscal year 2018 Evidence-Based Funding. We will not accept any requests for changes after 11:59 p.m. today.** If we do not hear from your district before this deadline, we will proceed with the understanding that your district's enrollment numbers are verified and correct. After this final verification period, agency staff will finalize and voucher tier funding payments.

I enjoyed sharing a few updates following the State Board meeting last week, but I wanted to add a couple more highlights here. I participated in the [Illinois 60 by 25 Network](http://60by25.org/) (http://60by25.org/)'s Annual Conference, which focused on scaling for impact using an equity lens. Equity is the path to

ensuring that at least 60 percent of all adults in Illinois have a high-quality college or career credential by 2025. I believe in the network's

approach of collaboration across districts, higher education, businesses, and communities to improve our ability to prepare students for meaningful and rewarding work after graduation. We can expand social and economic opportunity across the state by keeping equity at the center of our work.

I am grateful for the commitment to equity demonstrated by the [Illinois Alliance of Administrators of Special Education \(IAASE\)](https://www.iaase.org/) (https://www.iaase.org/). The Council of Administrators of Special Education (CASE) recognized IAASE as the national Exemplary CASE State Unit for the second year in a row. Only one state receives this honor each year. Please join me in congratulating IAASE members and leaders for this well-deserved recognition of their excellence and dedication!

I would also like to celebrate the [three educational leaders from Illinois](/Lists/News/NewsDisplay.aspx?ID=1198) (/Lists/News/NewsDisplay.aspx?ID=1198) honored by AASA, a professional organization for more than 13,000 educational leaders, at the organization's annual National Conference on Education last week. ## EVERY STUDENT SUCCEEDS ACT

Webinar on New Federal Student-Centered Funding Pilot Application Feb. 22

The U.S. Department of Education (ED) is hosting a [webinar](https://www2.ed.gov/policy/elsec/leg/essa/scfp/studentcentered.html) (https://www2.ed.gov/policy/elsec/leg/essa/scfp/studentcentered.html) **11:30 a.m. – 1 p.m. on Feb. 22** to discuss the application for the federal Student-Centered Funding Pilot. ED recently released the much-anticipated application for the federal Student-Centered Funding Pilot, with the first round of applications due **March 12**. Student-Centered Funding is also known as Weighted Student Funding (WSF) or Student-Based Allocations. The pilot, an application program authorized by ESSA, allows ED to grant additional Title I flexibilities to LEAs using (or intending to use) weighted student formulas to distribute LEA dollars. The intended webinar audience is LEAs, though other interested parties are also welcome. The webinar will clarify the opportunity interested LEAs have to apply for flexibility to implement a student-centered funding system. ## EVIDENCE-BASED FUNDING

### Reminder - Deadline to Announce Intent to Change from Half-Day to Full-Day Kindergarten is April 1

The new Evidence-Based Funding (EBF) formula creates an Adequacy Target for each district based on total average student enrollment and English Learner and low-income enrollment populations. Kindergarten students are assigned a value of 0.5 if they attend a half day and a value of 1.0 if they attend a full day. Per Public Act 100-0465, a school district may inform the State Board of Education of its intent to change from half-day to full-day kindergarten. Taking this action will convert kindergarten attendance to full day for purposes of calculating EBF in the following year. The deadline to report this information is **April 1**.

Any school district that wishes to make this change for the 2018-19 school year must provide ISBE with a board resolution expressing the intent to make the change for the next school year, as well as the minutes from the meeting when this was approved.
