# Message From State Superintendent Christopher A. Koch

This week, Board members and I will testify before the Senate Appropriations Committee with oversight of education to support the Board's Fiscal Year 15 (FY15) budget request. This will be the second in a series of formal legislative hearings in which we will provide testimony in support of the Board's budget request and work to educate legislators on various parts of the state's complex funding formula.

Last week, we testified before the House Elementary and Secondary Education Appropriations Committee. While most legislators seemed supportive, we are just one of many interests vying for a portion of state spending. In fact, one legislator asked us to provide them with a list of areas to begin cutting the education budget. Our Chairman adeptly pushed back on this type of thinking, urging committee members to instead look at the long-term economic benefits of investing in education, urging members to continue making education a priority and to try and build on last year's success of reinvestment rather than cuts from the previous years.

In addition to the formal hearings, Board members and I have had numerous one-on-one meetings with legislators and are encouraged by those who say they are willing to assist us in fighting for education and specific line items within the budget. I urge you to reach out to your local legislators and let them know about the needs within your district and the measures you have already taken in order to cope with a reduction in state spending.

Last week, the Board met in Springfield and Chicago. They approved use of the edTPA, a performance assessment developed by Stanford University, to assess a teacher candidate's ability to plan, deliver and assess instruction. The edTPA will be required for licensure in Illinois beginning Sept. 1, 2015.

The Board also forwarded to the General Assembly the Spring Waiver report. The Board had an extended conversation about the waiver requests, in particular those seeking to waive the state's daily physical education requirements. Board members, while very sympathetic that districts face funding deficits and facility issues in complying with the requirements for daily physical education, are equally concerned about the long-term detrimental effects a lack of physical education can have throughout one's lifetime. They are quite concerned about P.E. waivers that reach down into elementary and middle grades where P.E. would be offered only once per week and also those that exempt students from P.E. if they are engaged in a non-athletic activity, like band or music. They are going to note these concerns

when they transmit the requests to the General Assembly and will likely take a more critical look at these in the future.

# Public Act Changes State-Level Special Education Mediation Process

Effective Aug. 16, 2013, additional regulatory language has been incorporated into the Illinois Compiled Statutes, which impacts the state-level special education mediation process (see 105 ILCS, 5/14-8.02j) as follows:

(j) During the pendency of any administrative or judicial proceeding conducted pursuant to this Section, including mediation (if the school district or other public entity voluntarily agrees to participate in mediation), unless the school district and the parents or student (if at least 18 years of age or emancipated)

otherwise agree, the student shall remain in his or her present educational placement and continue in his or her present eligibility status and special education and related services, if any. If mediation fails to resolve the dispute between the parties, the parent (or student if 18 years of age or older or emancipated) shall have 10 days after the mediation concludes to file a request for a due process hearing in order to continue to invoke the "stay-put" provisions of this subsection (j). If applying for initial admission to the school district, the student shall, with the consent of the parents (if the student is not at least 18 years of age or emancipated), be placed in the school district program until all such proceedings have been completed. The costs for any special education and related services or placement incurred following 60 school days after the initial request for evaluation shall be borne by the school district if the services or placement is in accordance with the final determination as to the special education and related services or placement that must be provided to the child, provided that during that 60 day period there have been no delays caused by the child's parent.

Therefore, the following is now required:

- The agreement of the parties to mediate shall act as a "stay-put" on the child's placement during the pendency of the mediation. The "stay-put" placement shall be the last agreed-upon placement between the parties.
- If no agreement is reached between the parties concerning the placement, the "stay-put" placement shall remain in effect for a period of 10 calendar days following the mediation.
- If the party challenging the placement that led to the mediation request does not file a request for a due process hearing within 10 days following the unsuccessful mediation, the "stay-put" placement will expire.

Districts/cooperatives are encouraged to review the referenced citation in order to ensure full compliance.

# Public Act Changes State-Level Special Education Complaint Process

Effective Aug. 16, 2013, additional regulatory language has been incorporated into the Illinois Compiled Statutes, which impacts the formal statelevel special education complaint process (see 105 ILCS, 5/14-8.02e), as follows:

A school district or other public entity shall be required to submit a written response to a complaint within the time prescribed by the State Board of Education following receipt of the complaint. A copy of the response and all documentation submitted by the respondent to the State Board of Education must be simultaneously provided by the respondent to the complainant or to the attorney for the complainant. If the complaint was filed by an individual other than a parent of a child who is the subject of the complaint (or the child if the child has reached majority or is emancipated and has assumed responsibility for his or her own educational decisions) and the complaint is about a specific identifiable child or children, then appropriate written signed releases must be obtained prior to the release of any documentation or information to the complainant or the attorney representing the complainant.

Given these requirements, a district and/or special education cooperative will now be required to provide a copy of the written complaint response and supportive documentation to the complainant simultaneously with the submission of those materials to the State Board of Education. In the event of a complaint filed by an individual other than a parent/guardian, the district/cooperative must secure an appropriate written and signed release prior to the issue of any child-specific documentation.

The estimate you provide will be used by policymakers to determine the General State Aid (GSA) appropriation level for the 2013-14 claim, payable in Fiscal Year 2015. Please note these estimates are only used for projection purposes and will not be used in calculating your district's final GSA claim and payment.

# Heartsaver Automated External Defibrillator Fund Grant Available

The General Assembly has appropriated \$100,000 for the Heartsaver Automated External Defibrillator (AED) Fund Grant.

The program provides matching funds to schools and other public agencies to pay for AEDs. The application is available on the Department of Public Health's Electronic Grant Administration and Management System (EGrAMS) at <a href="https://www.idphgrants.com">www.idphgrants.com</a>.

Applicants must demonstrate that they have the funds to pay 50 percent of the cost of the AED, as determined by the State Master Contract or the Department. The Heartsaver AED Fund Grant award for FY 2014 is \$450 or at 50 percent of the purchased AED price if less than \$900.

The deadline to apply is Monday, April 14. Grants will be limited to one unit per recipient and will be awarded in the order received until grant money is exhausted.

All AEDs purchased between July 1, 2013, and June 30, 2014, will qualify for the grant.

An SEA that will make new SIG 1003(g) awards through a competitive process is required to submit a "New Awards Application." A new award is defined as an award of SIG 1003(g) funds to an LEA for a school that the LEA was not previously approved to serve with SIG funds in the school year for which the funds are being awarded – in this case, the 2014-2015 school year. Illinois may make new awards with the remaining funds not already committed to grants made in earlier competitions.
