## Message from Interim State Superintendent Christopher A. Koch

#### **Announcement of SEL and Mental Health Support Grants**

I am very pleased to announce that a Request for Proposals (RFP) is available for each of two new school district grant programs that are part of ISBE's implementation of the school-based recommendations contained in the Illinois Children's Mental Health Partnership (ICMHP) State Plan for which funding was appropriated in FY 07. The two grant programs are the SEL (Social Emotional Learning) Standards Grants Program for which \$500,000 is available statewide for grants up to \$10,000 each, and the Mental Health Supports Grants Program for which \$850,000 is available statewide for grants ranging from \$25,000 to \$75,000, depending on the size of the school district. The grants are being processed this year through the Illinois Violence Prevention Authority (IVPA) on behalf of ISBE and ICMHP. It is anticipated that ISBE will issue the grants directly next year. The RFP for both grant programs is posted on the ISBE website (<a href="http://www.isbe.net/spec-ed/html/grant\_info.htm">http://www.isbe.net/spec-ed/html/grant\_info.htm</a>) and the IVPA website (<a href="http://www.ivpa.org">www.ivpa.org</a>). **Due date for submission of applications is Friday, March 30<sup>th</sup>**.

ISBE has been an active partner in the Illinois Children's Mental Health Partnership and we share the Partnership's goals of implementing the Social Emotional Learning Standards and increasing schools' capacity to provide mental health supports for students, especially where early intervention could prevent more significant problems and assist

children in meeting their full learning potential. Illinois is a leader in the children's mental health field, and ISBE is proud to be a part of moving education toward teaching and responding to the whole child.

I want to recognize the tireless efforts of ICMHP leaders and advisors such as Ruth Cross and Annette Johnson, co-chairs of the ICMHP School Policy and Standards Committee, and Roger Weissberg of UIC CASEL, all of whom have provided expert leadership and assistance to ISBE and ICMHP in the development and implementation of the SEL Standards and the associated professional development plan. Thanks also to ICMHP staff and to Barbara Shaw and IVPA for collaborating with us to implement these important new schools and mental health initiatives.

#### Lowered flags honor Illinois' fallen

Governor Blagojevich ordered flags at all State of Illinois buildings to fly at half staff on Friday, March 2, to honor **Army Sgt. Pedro J. Colon**, and Tuesday, Feb. 27, to honor **Army Pfc. Ryan C. Garbs**.

**Sgt. Colon,** 25, Cicero, died February 19, 2007, in Baghdad, Iraq, from injuries suffered when his unit came under attack by enemy forces using multiple weapons. Colon was assigned to the 2<sup>nd</sup> Battalion, 8<sup>th</sup> Cavalry Regiment, 1<sup>st</sup> Brigade, 1<sup>st</sup> Cavalry Division, Fort Hood, Texas.

**Pfc. Garbs**, 20, Edwardsville, was supporting Operation Enduring Freedom when he was killed in a Chinook helicopter crash in southeastern Afghanistan on February 18, 2007. Garbs was assigned to the 3rd Battalion, 75th Ranger Regiment, Fort Benning, Ga.

Lowering of flags is at the discretion of local school administration. Information regarding gubernatorial orders to lower flags is shared at the request of Regional Offices of Education and local school districts.

#### **AYP Appeals Process**

With final AYP having been posted for high school and unit districts, school districts may appeal their district or high school status to the Illinois State Board of Education. A letter from the district superintendent to the State Superintendent of Education for consideration by the Appeals Advisory Committee, listing the issue and rationale for the appeal, begins the process. The district must submit the appeal within 30 days after receipt of state notification of status, from the State Board of Education.
