## Message From State Superintendent Christopher A. Koch

I want to thank all of you for your leadership in preparing your local education communities for our initial implementation of the Partnership for Assessment of Readiness for College and Careers (PARCC)

assessment. Next week the spring testing window officially opens for the Performance-Based Assessment portion of the PARCC, although some Illinois schools have already completed it and several others will begin this week.

Any time we have a major system change like we are implementing, there are bound to be issues. Testing has been in progress in several PARCC states for several weeks now; to date more than 525,000 tests have been started throughout the PARCC states and 348,000 have been completed. There have been some challenges, but so far testing continues with no major problems.

Last week I had the opportunity to speak with Richard Ross, superintendent of public instruction in Ohio, where

PARCC testing began last month. He said the testing was going better than they had expected, while acknowledging challenges. He did say that those districts that

- Establish an internal communication plan. Be sure that you have a protocol for test administrators who have questions during test day.
- Double check your student data.
- For online testing, set up your test sessions and add your test administrators into PearsonAccess Next.
- For paper testing, assure that all your testing materials have arrived. You can always place an additional order in PearsonAccess Next, if you need to.

## ISBE Extends 5Essentials Survey Administration Window to March 20

The Illinois State Board of Education (ISBE) has extended the administration window for its annual 5Essentials Survey to March 20.

The 5Essentials Survey, a diagnostic tool developed by researchers at the University of Chicago, provides schools with fine-grained data on five leading indicators for school improvement: Effective Leaders, Collaborative Teachers, Involved Families, Supportive Environment and Ambitious Instruction.

All district schools, including alternative schools that fall under the district's domain, are required by legislation to participate in the survey at least every other year. In 2015, only districts participating in Race to the Top and those that did not participate in the survey last year will be required to participate by ISBE. Chicago District 299 will also require its schools to participate. All districts will have the option to participate and are strongly encouraged to do so.

Survey results will be released in May to principals and superintendents. A summary of the 5Essential

results will be reported publicly on the State School Report Card website at <a href="http://illinoisreportcard.com">http://illinoisreportcard.com</a>. Detailed survey reports will also be publicly released. Survey results for 2014 and beyond will be normed using the 2013 statewide results so that all schools can demonstrate progress over time on the survey measures.

### **ACT Weather Policy Reminder**

Per ACT testing guidelines, if an emergency on test day (e.g., tornado, fire, snow) forces the termination of testing or the closing of school, school districts must notify ACT as soon as possible.

Districts should protect the security of the test materials and be especially careful if testing has started. Districts should also call ACT immediately at (800) 553-6244, ext. 2800, to explain their situation.

Decisions regarding rescheduling will be made on a case-by-case basis.

# **Grant Readers Sought for School Improvement Grant Competition**

ISBE's System of Support and District Intervention Division is seeking grant readers for the fiscal year 2016 School Improvement Grant 1003(g) competition.

Preferred grant readers should have school or district administrative experience, expertise in school improvement (transformation and reform), previous grant writing and reading experience, program management and experience working with lowperforming schools and districts serving specialized populations such as early childhood, students with special needs and linguistically and culturally diverse English Learners. Grant readers should also be familiar with the new School Improvement Grant 1003(g) final requirements as published on the U.S. Department of Education website at www.federalregister.gov/articles/2015/02/09/2015-02570/final-requirements-school-improvementgrants-title-i-of-the-elementary-and-secondaryeducation-act.

Readers will be required to participate in a half-day training that will be delivered via webinar in May and a one-day inter-rater reliability face-to-face training session. Readers are also expected to be available in the first half of June to read and score their assigned Request for Proposal (RFP) applications, which will be sent to the readers through a web-based system. Access to a computer with Internet capability and technology literacy will be necessary. An honorarium based on the number of reviews completed on time will be provided. Once selected, readers will be required to sign a confidentiality agreement, a memorandum of understanding and complete a conflict of interest questionnaire.

# **Survey Available to Collect Feedback on New Teacher Evaluation Systems**

The Performance Evaluation Reform Act (PERA) requires Illinois districts to adopt new teacher evaluation systems that address teacher performance and student growth. To assess districts' challenges in implementing their new evaluation system, ISBE and the Performance Evaluation Advisory Council (PEAC) contracted with American Institutes for Research to conduct a survey.

The purpose of the survey is to collect anonymous data from Illinois school districts on the challenges encountered during the design and implementation of their new teacher evaluation systems, in accordance with PERA requirements. Your responses will help PEAC and ISBE identify district needs and address those needs through potential resources and supports.
