Message From State Superintendent Christopher A. Koch

Last week, several members of the State Board and I testified before the Senate Appropriations Committee, which has responsibility for K-12 funding. Many members were very supportive of what you do in the field every day and recognize the impact of

the state's financial crisis on schools.

It is still early in the budget-making process, but we must remember that the temporary income tax is set to expire midway through the fiscal year. The House passed a resolution establishing an overall General Funds revenue estimate about \$950 million lower than the Fiscal Year 14 revenue estimates. In addition, there are unconfirmed reports that this could mean substantial reductions to education as other pressure areas in the budget increase. We will continue to monitor and advocate for the Board's recommended budget, but we must face the reality that this process will, again, be an uphill battle.

Recently, a number of questions have come up regarding whether or not a teacher can choose to administer the ISAT or whether a student can "opt out" of taking it. Last week, teachers at two schools in the Chicago Public Schools district said they will not administer the test, and a number of parents say they want their students to opt out. There is no opt out provision, and the ISAT will provide valuable information to educators, parents and the community, particularly during this transition year to the Partnership for Assessment of Readiness for College and Careers (PARCC) assessment. Board Chairman Gery Chico and I are very concerned about the misinformation regarding this requirement and sent a letter to the CPS Chief Executive outlining our concerns, district responsibilities and possible repercussions. Soon, we will begin our field test of the new PARCC assessment. Currently, more than 1,800 schools in about 670 districts have signed up to take this practice test. The practice tests will give students the chance to try out the new testing format before it counts and will help test designers determine the fairness, validity and accuracy of the questions and format.

We have developed a new video that will help you as you engage faculty, students, parents and the community in discussions of the new assessments. The video takes a look at the PARCC assessments and new Illinois Learning Standards. "Improving Student Assessments" explains the keys to PARCC success, which include employing innovation and measuring students' higher-level thinking abilities. Please feel free to use it in Board meetings, community forums and faculty meetings and also to share

Title Grant Administration

Consultation with Nonpublic Schools, Local Education Agencies on Title I Funds

Sec. 1120(b) of the No Child Left Behind Act and Sec. 200.63 of the Title I regulations require that timely and meaningful consultation must occur between the Local Education Agency (LEA) and private school officials prior to any decision that affects the opportunities of eligible private school children, teachers and other educational personnel to participate in the Title I program and shall continue throughout the implementation and assessment of activities.

Topics that must be discussed between the LEA and the private school officials are available here: http://www.isbe.net/grants/html/np partic.htm.

The LEA, during the consultation process, should: set up a timeline with private school officials for future meetings and for frequent visits by the LEA, plan for multiple meetings, gather input from private school representatives, have an agenda for each meeting, keep written notes and share with private school officials, maintain meaningful written assurance and plan to conduct full school year programming.

Consultation is a very important piece of the education process, and it is imperative that discussions take place in a timely manner in order for the students to benefit the most from Title I services. Start now by contacting your nonpublic schools to set this process in motion.

USDA Farm to School Grants Available To Improve Access to Local Foods

The USDA has announced the availability of three different Farm to School Grants as well as a separate funding track to support training and events.

The purpose of the Farm to School Grant Program is to help eligible entities implement farm to school programs that improve access to local foods in eligible schools. The USDA awards up to \$5 million in competitive grants annually for training, supporting operations, planning, purchasing equipment, developing school gardens, developing partnerships and implementing farm to school programs.

Planning grants are available for schools just getting started on farm to school activities. Implementation grants are available for schools seeking to augment or expand existing efforts. Additionally, eligible non-profit entities, Indian tribal organizations, state and local agencies and agriculture producers or groups of producers may apply for support service grants in order to conduct trainings, create complementary curriculum or further develop supply chains, among other activities. Proposals are due on April 30.

New in FY 2015, USDA funds will be made available to support meetings, trainings and events aimed at strengthening farm to school supply chains or providing technical assistance. The Training and Event funds range from \$15,000 to \$50,000. The USDA expects to distribute approximately \$500,000 in additional funds to support at least one statewide or regional meeting in all seven FNS regions and at least one national conference. Letters of Intent are due on April 2.

To assist eligible entities, the USDA will host a series of webinars related to the application process:

- March 12, noon Implementation Grants
- March 13, noon Support Service Grants
- March 14, noon Training and Event Funding Track

The estimate you provide will be used by policymakers to determine the General State Aid (GSA) appropriation level for the 2013-14 claim, payable in Fiscal Year 2015. Please note these estimates are only used for projection purposes and will not be used in calculating your district's final GSA claim and payment.

Public Act Changes State-Level Special Education Mediation Process

Effective Aug. 16, 2013, additional regulatory language has been incorporated into the Illinois Compiled Statutes, which impacts the state-level

special education mediation process (see 105 ILCS, 5/14-8.02j) as follows:

(j) During the pendency of any administrative or judicial proceeding conducted pursuant to this Section, including mediation (if the school district or other public entity voluntarily agrees to participate in mediation), unless the school district and the parents or student (if at least 18 years of age or emancipated) otherwise agree, the student shall remain in his or her present educational placement and continue in his or her present eligibility status and special education and related services, if any. If mediation fails to resolve the dispute between the parties, the parent (or student if 18 years of age or older or emancipated) shall have 10 days after the mediation concludes to file a request for a due process hearing in order to continue to invoke the "stay-put" provisions of this subsection (j). If applying for initial admission to the school district, the student shall, with the consent of the parents (if the student is not at least 18 years of age or emancipated), be placed in the school district program until all such proceedings have been completed. The costs for any special education and related services or placement incurred following 60 school days after the initial request for evaluation shall be borne by the school district if the services or placement is in accordance with the final determination as to the special education and related services or placement that must be provided to the child, provided that during that 60 day period there have been no delays caused by the child's parent.

Therefore, the following is now required:

- The agreement of the parties to mediate shall act as a "stay-put" on the child's placement during the pendency of the mediation. The "stay-put" placement shall be the last agreedupon placement between the parties.
- If no agreement is reached between the parties concerning the placement, the "stay-put" placement shall remain in effect for a period of 10 calendar days following the mediation.
- If the party challenging the placement that led to the mediation request does not file a request for a due process hearing within 10 days following the unsuccessful mediation, the "stay-put" placement will expire.

Districts/cooperatives are encouraged to review the referenced citation in order to ensure full compliance.

School Health Issues

2014 Statewide Suicide Prevention Conference Set for April 25 in Springfield

Registration is open for the 2014 Statewide Suicide Prevention Conference, entitled "Preventing Suicide Among Youth and Young Adults: Everyone has a Role," on April 25 in Springfield.

The conference theme acknowledges that preventing suicide involves collaborative efforts by the entire community, with a special focus on youth and young adults between 10 to 24 years of age. Featured speakers include: Dr. LaMar Hasbrouck, director of the Illinois Department of Public Health; Dr. John Draper, director of the National Suicide Prevention Lifeline; and Dr. Peter Gutierrez of the U.S. Department of Veteran Affairs.

State law requires that school personnel working with students in middle and high school grades must receive training on suicide (105 ILCS 5/10-22.39):

In-service training programs.

- (a) To conduct in-service training programs for teachers.
- (b) In addition to other topics at in-service training programs, school guidance counselors, teachers, school social workers, and other school personnel who work with pupils in grades 7 through 12 shall be trained to identify the warning signs of mental illness and suicidal behavior in adolescents and teens and shall be taught appropriate intervention and referral techniques.

Heartsaver Automated External Defibrillator Fund Grant Available

The General Assembly has appropriated \$100,000 for the Heartsaver Automated External Defibrillator (AED) Fund Grant.

The program provides matching funds to schools and other public agencies to pay for AEDs. The application is available on the Department of Public Health's Electronic Grant Administration and Management System (EGrAMS) at www.idphgrants.com.

Applicants must demonstrate that they have the funds to pay 50 percent of the cost of the AED, as determined by the State Master Contract or the Department. The Heartsaver AED Fund Grant award for FY 2014 is \$450 or at 50 percent of the purchased AED price if less than \$900.

The deadline to apply is Monday, April 14. Grants will be limited to one unit per recipient and will be awarded in the order received until grant money is exhausted.

All AEDs purchased between July 1, 2013, and June 30, 2014, will qualify for the grant.

Reminder: New ISBE Bilingual Rules and Early Childhood Teacher Preparation

In an effort to strengthen and support the academic achievement of English Language Learners in Illinois, new administrative rules went into effect in July 2010 that expanded bilingual services to preschool programs administered by a school district. In accordance with 23 Ill Administrative Code Part 228, effective July 1, 2014, preschool teachers who provide native language

or ESL instruction to ELL students must also hold the English as a Second Language (ESL) or bilingual endorsement that corresponds with the teaching assignment.
