Message From State Superintendent Christopher A. Koch

Last Thursday I had the opportunity to meet with many of you in Springfield at the Illinois Association of School Administrators Leadership Week. This was an opportunity for professional development and networking, but also time to engage legislators. I have met with many of our legislators over the past few weeks and will continue to do so as the spring session continues, but there is no substitute for local educators talking to legislators about how the decisions made in Springfield impact classrooms in their home districts.

The Illinois State Board of Education has recommended an aggressive budget request for FY 14 and we are working with a number of stakeholders to ensure each member understands the implications General State Aid proration and other cuts are having on local schools. However, we must all work together. Please continue to engage your legislators as we move through the spring and encourage your Board members and other local education stakeholders to do the same.

Today the Partnership for Assessment of Readiness for College and Careers (PARCC) is releasing two items to help us as we move forward in implementing the new learning standards and plan for the new assessments.

The first item is an Assessment Administration Capacity Planning Tool that will allow districts to plug in their own data about devices, bandwidth and enrollment and other data. This tool will generate information that provides multiple school readiness scenarios in order to administer the new assessments. PARCC has previously released the minimum and recommended specifications that devices must meet for use in the new assessments. These specs will be updated every six months based on feedback from the field.

In addition to the capacity planning tool, PARCC is releasing guidance about estimated time on task for testing. This is a test that many educators have been asking for, for a long time. It's not simply filling in a bubble, but requires students to apply knowledge and a higher level of thinking. These assessments will require some additional time than what is currently required, however, each grade level will be assessed for writing in English Language Arts and extended explanation for calculations in math which is not occurring now and they will also be broken up to include separate sessions for performance-based and end-of-year assessments instead of one single window. Estimates for testing are as follows:

- Grade 3 8 hours
- Grades 4 and 5 just more than 9 hours
- Grades 6,7 and 8 a little less than 9.5 hours
- High School a little less than 9.5 hours

There will be two four-week testing windows for test administration and the capacity planning tool will help determine how many days schools will need for testing. You can access the guidance and planning tools at www.isbe.net/assessment/parcc.htm or www.PARCConline.org.

Mathematics Curriculum Models Coming to Help Aid Common Core Implementation

The Illinois State Board of Education has been charged by the Illinois 97th General Assembly to implement Public Act 97-704. The State Board of Education is to coordinate the acquisition, adaptation and development of middle and high school Mathematics Curriculum Models to aid school districts and teachers in implementing Common Core Mathematics State Standards for all students. The Public Act required representation from statewide educational organizations and stakeholders. A committee consisting of a middle school mathematics team and a high school mathematics team has been created to address this charge. The work of the committee was scheduled to be completed by mid-February 2013 and available to the General Assembly by March 1. It will be available to districts after this date.

The team for high school mathematics has chosen to focus on the integrated approach for the Mathematics Curriculum Model. The middle school Mathematics Curriculum Model will be aligned with the high school model. The resulting product will provide districts an opportunity to examine an integrated Mathematics Curriculum Models framework. This curriculum work is designed to be an example.

The curriculum examples will be shared with districts to help them in their implementation of the Mathematics Common Core Standards. The Mathematics Curriculum Models may be seen as tools for districts to use for the implementation of the Mathematics Common Core State Standards at the middle and high school level. Districts are not required to use this curriculum framework and may adopt or adapt this curriculum as they see fit.

The Illinois Board of Education has not officially made a decision on whether the state model will be the traditional or the integrated approach at the high school level.

Deadline to Apply for HealthierUS School Challenge Grant Set for April 1

The due date for the Illinois School HealthierUS School Challenge Request for Proposal is April 1, 2013. Through USDA's 2012 Team Nutrition and Training Grant, the Illinois State Board of Education's Division of Nutrition and Wellness Programs will be awarding more than 40 schools with minigrants of \$940 to help them prepare to meet the HealthierUS School Challenge criteria.

USDA Proposed Rules on Nutrition Standards for All Foods Sold in Schools

On Feb. 8, 2013, the USDA issued "<u>Proposed Rules on Nutrition Standards for All Foods Sold in Schools that Participate in the National School Lunch and School Breakfast Programs.</u>"

In Illinois, state rules in Section 305.15 of the Illinois Administrative Code, School Food Service Rules govern what food and beverages may be sold to students in school buildings with grade 8 and below. ISBE has reviewed the USDA proposed rules and compared to the current Illinois School Food Service Rules in place since October 2006. The current state rules has an exemption for foods sold in the food service area during the meal periods for grades 8 and below. In addition, the state rules do not govern grades 9-12.

The USDA proposed rules imposes rules for ALL grade levels including 9-12 grades as well as ALL food and beverages including food in the food service area during meal periods. The USDA proposed rules would govern ALL food and beverages sold to students on the school campus during the school day, including 30 minutes at the end of the school day. The proposed USDA rules will impact a la carte offerings, vending machines and school stores.

To provide school personnel an overview of the proposed rules, the Nutrition and Wellness Programs Division hosted a webinar on Friday, Feb. 22, 2013. The webinar was recorded and will be available on our division website for schools who were unable to attend the live webinar. (Available on www.isbe.net/nutrition under What's New?) Schools were provided instructions on how to comment to the USDA on these proposed rules, preferably via www.regulations.gov. Docket ID: FNS-2011-0019. Comments are being accepted by USDA through April 9, 2013.

ISBE Division Announces Variety of Upcoming Grant Opportunities

USDA FARM TO SCHOOL GRANTS: The Healthy Hunger Free Kids Act (HHFKA) states that the USDA will make available \$5 million annually for grants, technical assistance and the federal administrative costs related to F2S Programs. This year the USDA has determined they will focus the majority of those \$5 million on grants.

There will be three different types of grants available: Planning Grants, Implementation Grants and Support Service Grants. Planning and Implementation grants are geared towards schools in the National School Lunch Program. In order to assist those thinking about applying for one of the three grants listed above, the USDA will be hosting a series of webinars related to the application process:

- March 6, 2013, Noon (CST) Implementation Grants
- March 7, 2013, Noon (CST) Support Service Grants

Annual Evaluation of Supplemental Educational Services Under Way Soon

The Center for Research in Educational Policy (CREP) at the University of Memphis conducts an annual evaluation for the Illinois State Board of Education of Supplemental Educational Services (SES).

As many of you are aware, SES is a component of the Elementary and Secondary Education Act, as reauthorized by the No Child Left Behind Act, which provides extra academic assistance for students from low-income families attending designated Title I schools (those in their second year of school improvement, in corrective action, or in restructuring status).

The evaluation conducted by CREP in Memphis assists ISBE in monitoring the effectiveness of providers approved to offer SES in the state of Illinois. The primary components of the evaluation are: SES student achievement outcomes, SES student attendance, and the perceptions of parents with children attending SES.

Parental feedback plays a critical role in the evaluation of SES providers. Increasing the level of input from parents, through increasing the survey response rate, will ensure the evaluation contains accurate, reliable information.

In April, schools that are designated SES-eligible will begin receiving boxes containing parent surveys in English and in Spanish and instructions for returning surveys.

Please alert district Title I coordinators that SES parent surveys will be arriving in April to their district's SES-eligible schools. We ask that Title I district coordinators share this information with their schools and emphasize the importance of the survey distribution and return in an effort to increase the rate of survey submissions.

Administration of the Ninth and 10th Grade EXPLORE/PLAN – Fall 2013

We are pleased to announce the continued availability of EXPLORE/PLAN for all ninth- and 10th-grade students as part of our reform agenda and move toward a growth model of accountability. The high school assessment plan will provide schools and districts a complete picture of student progress from grades 3 through 11 and provide data for the calculation of student growth.

Please Note: The opportunity to participate in these assessments will be the only state-funded path to administer the EXPLORE and PLAN in the 2013-14 school year. Test administration must take place between Sept. 16 and Nov. 8. The state will pay only for the administration of EXPLORE at grade 9 and PLAN at grade 10 during this testing window.

Request for Proposals Sought for Illinois Early Childhood Asset Map (IECAM)

The Illinois Early Childhood Asset Map (RFP) was released Feb. 19, 2013. ISBE is seeking applications from eligible entities that will maintain and further refine an Illinois early childhood asset mapping website

(IECAM) for early childhood personnel, state agency personnel and the general public.

Specifically, the website should provide online access to demographic data on young children and data on early care and education services in Illinois. Applicants must explain how they will combine up-to-date demographic information with early childhood program information from PI and PFA, Head Start, and child care. The website should use a sophisticated electronic coding/mapping function to locate early childhood programs correlated with demographic data across multiple sectors of the state. It is anticipated that the successful applicant will have access to the existing pages and resources of the current site in order to make the transition to the applicant's system and to support the site with its own infrastructure.

Application for the Exception to the 1% Cap Reminder

If more than 1 percent of your students in grades 3 through 8 and 11 are identified as significantly cognitively disabled, it is time to prepare your district's application for an exception to the 1 percent cap. If the

conditions for the exception are approved, then all "progressing" and "attaining" scores earned by students taking the Illinois Alternate Assessment (IAA) will be counted as proficient in making determinations for school, district and state AYP.

K-8 Districts: Apply after the ISAT testing is completed (March 15 for most districts).

High School and K-12 Districts: Apply after the PSAE makeup date has passed (May 8).

Reminder Regarding the Abolishment of General Assembly Legislative Scholarships

On July 11, 2012, the governor signed legislation abolishing the General Assembly scholarship program in Illinois. Public Act 97-0772 can be viewed at http://www.ilga.gov/legislation/publicacts/97/PDF/097-0772.pdf.

Previously, Illinois law provided for each member of the General Assembly to annually nominate two persons of school age and otherwise eligible, from his or her district to receive a certificate of scholarship in any state supported university designated by the member.

Public Act

PA 97-742: 5 Hours of Instruction on First and Last Day of School (Effective June 30, 2013)

Senate Bill 2850 was signed by Gov. Pat Quinn on July 5, 2012, to become Public Act 97-0742 and has an effective date of June 30, 2013. This public act repeals Section 18-8.05 (F)(2)(b) of the School Code, which allows the first and last day of student attendance to be less than 5 instructional hours. Except as otherwise provided in Section 18-8.05 of the School Code, beginning with the 2013-14 school year calendar, for Public School Calendar and General State Aid attendance calculation purposes, days of attendance by pupils, including the first and last day of pupil attendance, shall be counted only for sessions of not less than five clock hours of school work per day.
