#### Hello,

As the Mattoon High School community heals, I want to express my deep appreciation for the response of school staff and first responders. They took great care in a tough situation to protect students and staff. My thoughts are with the injured student and the student's family, the family of the suspect, and all those affected by this tragedy. Please hold the entire community in your thoughts and prayers.

I had more opportunities to meet students and educators last week. I enjoyed learning about some of the community-focused initiatives across Clinton CUSD 15, including the high school's commitment to restorative practices and strong early elementary outreach in pre-K. In Lincoln ESD 27, I observed educators' and students' seamless use of technology as a support to learning. Google named Lincoln ESD 27 a Reference District, one of a handful of

districts in Illinois selected as an exemplar of how to integrate Google

technology into instruction. A highlight of my visit to Robertson Charter School in Decatur SD 61 was watching students assist their peers and mentor younger students. The school's level of engagement, focus, and excitement energized me.

I also visited Morton District 709, where I joined a Project Lead the Way classroom at Morton High School and the CareerMaker STEM lab at Morton Junior High School. Real-world problems form the basis for all of the lessons in the Project Lead the Way class. I watched students tackle how to clean up an oil slick, generate solutions using the resources they were given, and present proposals to their teacher. The CareerMaker STEM lab is a public and private partnership between businesses and the school district. Students engage in digital and hands-on activities in various career clusters, including technology; architecture and construction; and government, law, and public service. Students gain valuable insight as they explore different career clusters to help them identify possible careers to pursue.

These schools show the powerful opportunity we have to make school more relevant to students, and high school, in particular, more relevant to the community. Competency-based learning can help link high school to the workforce and reshape the high school experience for students. Educators assess and advance students in competency-based learning based on demonstrated mastery of specific skills, abilities, and knowledge. ISBE launched the Competency-Based High School Graduation

Requirements Pilot Program (/Pages/CompetencyPilot.aspx) to spur innovation in the way high schools prepare students for meaningful careers. The Postsecondary and Workforce Readiness Act (http://www.ilga.gov/legislation/publicacts/99/099-0674.htm) established the pilot program in 2016. Last week, the 10 school districts selected to participate in the first cohort of the pilot program convened to build relationships, find points of connection, and begin moving their pilots from vision to action.

AppsCo raises funds for the school district while providing students with business education and mentorship from local business leaders.

The whole child, whole school, whole community approach encourages a different way of thinking about the opportunities offered in school. Student-centered school design explores community partnerships and integrates technology, so every child receives differentiated supports to pursue interests in authentic environments. Truly investing in the future of the state – our students – means continuing to connect the classroom to students' interests and to real-world problems.

Finally, I would like to congratulate the students selected for the 2017-18 Student Advisory Council (SAC) (/Lists/News/NewsDisplay.aspx? ID=1175). SAC members learn about education issues in Illinois, provide feedback to the State Board, select a topic to research in depth, and present to the State Board. This year's SAC members are thinking about postsecondary options and how to ensure students have the knowledge, skills, and attitudes they need to thrive in the path of their choosing after graduation. The SAC plans to explore affordability, accessibility, vocational programs, the armed forces, and pathways straight to the workforce.

# **THOSE WHO EXCEL**

### Meet Teacher of the Year Finalist Erin Miller



Erin Miller teaches fourth grade at Brimfield Grade School in Brimfield Community Unit School District 309. Her kindergarten teacher first ignited Erin's interest in becoming a teacher, but it was her fourth-grade teacher who fanned the embers into a full flame that burned brightly throughout Erin's school years.

Today Erin holds two master's degrees and is in her 20th year of teaching. Her passion for teaching grows brighter and stronger with each passing year. Her ability to engage students at all learning levels coupled with her enthusiasm for teaching and learning makes her an excellent role model to her fellow teachers and her students.

Erin is also an excellent mentor to new teachers and a strong teacher leader for her colleagues. In her nomination letter, Erin's principal wrote, "She demonstrates an authentic passion for teaching and an untiring commitment to student success and well-being. If I want something done correctly, I ask Erin."

Erin gives it 110 percent whether it is teaching, mentoring, serving on seemingly countless committees, or creating lessons that motivate and challenge students. She makes learning fun and exciting. Students are actively engaged in their learning. Erin's students gain skills that will help them continue to be successful learners for the rest of their school years and beyond. One of Erin's colleagues described her this way: "She is a role model and the impact she has on her students goes beyond the classroom. Erin teaches her students how to be positive citizens of the world."

When Erin was in fourth grade, her teacher recognized that she was struggling to learn so she began working more closely with Erin to help her succeed. Erin draws on that experience to help her students when they are having trouble. She develops strong relationships with all her students and parents. A former student shared this story about Erin's teaching: "When I was in fourth grade, I was really struggling with multiplication. Mrs. Miller brought me to the back table every study hall and helped me learn multiplication. She did such a great job with making up fun jingles and the turtlehead method to help me remember multiplication, until I was able to help other kids that were struggling like me. She could always make school fun!"

Erin believes her success in teaching comes from the relationships she builds around what she calls her "teaching table." She compares her teaching table to a family dining room table. The table can always be extended to include all her students and everyone else in their educational family. It expands to exchange ideas and share information with her colleagues. As she says, "Special moments together happen at this invisible table. It is where we laugh and cry. It is where my children grow. It is where lessons are learned and life decisions are made. It is an accepting and safe place where my school family gathers."

Erin is one of our 10 finalists for Illinois Teacher of the Year, who we will name at the Those Who Excel banquet in Normal on October 28.

# **EVERY STUDENT SUCCEEDS ACT**

### Site-Based Expenditure Reporting

The Every Student Succeeds Act (ESSA) requires all states to begin school-level expenditure reporting. All Local Education Agencies (LEAs) will report per-pupil expenditure data at the district level and at the school level, disaggregated by source of funds, beginning with school year 2018-19 data. ISBE recognizes that these new requirements and the timeline for implementation will present challenges for different LEAs and schools.

ISBE has convened a Site-Level Financial Reporting Advisory Group in order to ensure that the challenges faced by individual LEAs and schools (including charter public schools) are appropriately considered in the transition process. This advisory group, along with ISBE and facilitators, is building a multi-year implementation plan, guidance, and training to support schools and LEAs in the transition to school-level financial reporting.

## DATA ANALYSIS

### Annual District Assessment Survey Now Open

The Annual District Assessment survey (/Pages/AssessmentSurvey.aspx) requires all districts to report to ISBE information regarding the assessments they administer in their schools. This is the second administration of the survey. The legislation requiring this survey, PA 99-590 (http://www.ilga.gov/legislation/ilcs/fulltext.asp?DocName=010500050K22-82), was signed into law on July 22, 2016.

ISBE has made several changes to the survey that will improve the data quality and usability of the data collected, as well as improve the ease of use in order to reduce the burden on school districts. Changes to the survey include:

- A menu that will automatically pull up district name and RCDT as you begin typing it.
- The ability to select and enter data for more than one school at a time if the exact same assessments are given the same way (at the same time, to the same students, for the same purposes).
- The survey will pull the assessment data submitted for a school from the previous year for you to update as needed. Please review the information carefully.
- Changes to the "Assessment Purpose" section to ensure all purposes for which assessment results are used can be indicated. Note: The "Assessment Purpose" question was changed so significantly, so this information will need to be updated for all assessments.

# FUNDING AND DISBURSEMENTS

### Teachers' Retirement System – Federal Contribution Rate Adjustment – FY 2018

Please be advised that the Employer Teachers' Retirement System (TRS) contribution on federally funded salaries has been adjusted due to enactment of Public Act 100-0340. The Teachers' Retirement System was required to recertify the appropriation amount to TRS from the State of Illinois for fiscal year 2018. The employer TRS contributions on salaries paid from federal funds for the 2017-18 school year has changed from 44.61 percent to 10.10 percent. This change is retroactive to July 1, 2017. FY 2017 Federal Grant Projects - Post June 30 End Dates

Changes to the TRS rate for employees impacted by the lower amount will be accommodated by submitting a final expenditure report. If you have submitted the final expenditure report, please contact Funding and Disbursements to remove the prior final expenditure report. This will allow you to make changes and resubmit an amended expenditure report. Any unexpended funds generated from the lower expenditure report will be rolled forward as carryover into your FY 2018 project. ISBE will not permit budget amendments to your FY 2017 grant projects that ended August 31.

You may submit a budget amendment to reflect the TRS rate change via your normal process.

## SPECIAL EDUCATION SERVICES

### Special Education Data Added to Illinois Report Card

ISBE has been working to expand and improve its Illinois Interactive Report Card to provide greater access to data about Special Education programs in Illinois schools and districts. We have enhanced the 2016 Illinois Report Card to include information about educational environment, disability categories, and demographics. This information was published previously as part of each district's Special Education District Profile. The 2016 Illinois Report Card now includes additional user-friendly displays, graphics, and narrative descriptions.

ISBE will also be incorporating a new section for Special Education data into the 2017 Illinois Report Card, which will be released at the end of October.

## GRANT ACCOUNTABILITY TRANSPARENCY ACT

### **Required FY 2018 GATA Grantee Pre-Qualification Process**

All grantees <u>must complete</u> the registration process and be qualified to do business with the State of Illinois.

The grantee pre-qualification registration portal may be accessed directly on the GATA website (http://www.illinois.gov/sites/GATA/Grantee/Pages/default.aspx).

To be qualified to apply for an FY 2018 grant award, an entity must complete the following four steps:

#### 1. Authentication (New for FY 2018)

The Grantee Portal can be accessed through the Grantee Links heading on the GATA website. A personal or business email address is required to establish an account. Authentication is required through the Illinois.gov authentication portal. It establishes or verifies the relationship between an individual and the organization they represent. Authentication is performed once for each individual associated with a registration. If your email was not previously associated with the organization that you represent, click the "Create a new account" link below the "Sign in" button. After you have entered the required information, you will receive a confirmation email that will instruct you to click a link to complete the account creation process. For help with the Illinois.gov/Authentication Portal, please browse to www.illinois.gov/sites/accounts/Pages/default.aspx (http://www.illinois.gov/sites/accounts/Pages/default.aspx). #### 2. Registration

Once your Illinois.gov account is created, you must return to the Grantee Portal log-in screen and enter your user name and password to continue. The system will then ask for your organization's DUNS number. If the DUNS number for your organization is on record with GATA from the previous year, the system will associate you with your organization. The process may require the approval of the primary GATA system registrant for your organization. After accessing your entity's registration information, you must click the "Edit" button found near the top of the screen. This will allow you to correct/confirm the listed information and select the appropriate organization type for your entity.

If the DUNS number that you enter is not found in the GATA system, the system will invite you to create a new grantee account for the entity related to that DUNS number. Please confirm that you entered the correct DUNS number before creating a new account. Creation of a new grantee account is accomplished by providing your organization's:

- DUNS number (View instructions on obtaining a DUNS number (https://fedgov.dnb.com/webform));
- FEIN;
- Organization type (NOTE: school districts, special education joint agreements, and education for employment consortiums should select "School District");
- Secretary of State ID (NOTE: the following types of organizations have been deemed EXEMPT from this requirement: school districts, colleges, universities, Regional Offices of Education, special education joint agreements, and education for employment consortiums);
- Organization name; and
- Address.
- 3. Grantee Pre-qualification

All entities must be qualified to do business with the State of Illinois. To be qualified for a grant award, an entity must:

- Be registered in the GATA Grantee Portal system as described above;
- Have a valid DUNS number (View instructions on obtaining a DUNS number (https://fedgov.dnb.com/webform));
- Have a current SAM.gov account (View instructions on obtaining a SAM Cage Code (http://www.illinois.gov/sites/GATA/Documents/How%20to%20Register%20in%20SAMS.pdf));
- Not be on the Federal Excluded Parties List (Verify utilizing the Quick Search (https://www.sam.gov/portal/SAM/? portal:componentId=6fd72bdf-176f-4f82-99b2bfd794cb124f&interactionstate=JBPNS\_rO0ABXc0ABBfanNmQnJpZGdIVmIId0lkAAAAAQATL2pzZi9mdW5jdGlvbmFsLmpzcA AHX19FT0ZfXw%2a%2a&portal:type=action#1))
- Be in Good Standing with the Illinois Secretary of State, as applicable (Verify Good Standing (https://www.ilsos.gov/corporatellc/)). (NOTE: The following types of organizations have been deemed EXEMPT from this

requirement: school districts, colleges, universities, Regional Offices of Education, special education joint agreements, and education for employment consortiums.);

- Not be on the Illinois Stop Payment list; and
- Not be on the Department of Healthcare and Family Services Provider Sanctions list.

Pre-qualification status will be verified after Grantee Registration is submitted and nightly thereafter. If an entity has a prequalification issue, the specific issue and remediation support is provided through the Grantee Portal. Entities on the Federal Excluded Parties List are not eligible to do business with the State of Illinois.

4. Fiscal and Administrative Risk Assessment (ICQ)

Entities must complete an FY 2018 Internal Controls Questionnaire (ICQ) as the Fiscal and Administrative Risk Assessment. The ICQ is completed annually for each fiscal year. All state agencies will utilize the results of the ICQ. The entity can access the ICQ from the Grantee Portal. The portal provides access to prior year ICQ responses for those entities that received grants in FY 2017. The FY 2018 ICQ template must be completed prior to making application for an FY 2018 grant. The ICQ should be completed by someone with financial or accounting experience.

The status of compliance with each of the requirements described above is displayed in the Grantee Portal for each registered entity. Again, completion of these four steps is required prior to making application for funding for FY 2018.

Entities must also complete a programmatic risk assessment for each grant award in FY 2018. The programmatic risk assessment will be included in each electronic grant application through ISBE. Paper grant applicants will be directed to the IW AS system once applications have been received.

The SAM.gov registration expires annually and must be renewed to maintain your eligibility for funding. Renewal of your cage code at the SAM.gov web site does not require a fee.
