	A.	Start date will be July 1, 2011.

		over the summer. Regular contact and services will continue based on the individual needs of
		each family. Remember that the curriculum, model and IFSP guide program services and
		intensity.
	Q.	Q: Is Ages & Stages Questionnaire considered an assessment tool?

	A.	The ASQ looks at strengths and trouble spots, educates parents about developmental milestones,
		and incorporates parents' expert knowledge about their children. The ASQ helps identify delays as

		early as possible.
		Professionals rely on ASQ for the best developmental and social-emotional <i>screening</i> for children from one month to 5 ½ years. It is highly reliable and valid.
23.	Q.	Does "intensive" mean at least every other week?
	A.	Your program model will provide this guidance. Program models and contacts are listed on pages 23-25 of the RFP.
24.	Q.	We understand the emphasis is going to be on home visits. Yet, there appears to be a place for group parental education. Can you speak to this? What percentage of our time is recommended to be spent on group activities vs. home visits?

25.	Q.	Is a supervisor required in PI?

	A.	Yes. This is a separate proposal and the two will be scored separately.
	Q.	Does anyone in the Chicago area offer the Auto Acoustic (OAE) emissions screening?
27.	A.	ISBE does not have this information. You may want to try your local Early Head Start Program.
28.	Q.	With PAT Program Model changes needing to be implemented by 2014, such as advanced hearing screening procedures (OAE) are we to write these into our grant?
	A.	Not at this time. ISBE is working to provide assistance to programs in FY12 regarding training and implementation of the OAE.

BUDGET/FUNDING QUESTIONS

29.	Q.	In FY 08 my center received funding for a center-based full-day child development program, and we also have a home visiting program. Do we need to write two separate grant proposals, or should they be combined in one proposal?
	A.	One proposal
30.	Q.	What is the average number of families that would be served through the example of \$160,000 per 12 month program?
	A.	This will vary per program as it's relates to community, at-risk characteristics, numbers served, etc. PI does not have a cost per child. Your budget should be reflective of your program model, services and curriculum.
21	Q.	Is there a recommended average cost per family?
31.	A.	No

32.	Q.	Our current budget does not fully support our actual expenses. Therefore, we will need to request more funding for FY12, especially since we must provide a year-round program. Do we write our budget to reflect the actual budgetary needs, even if that amount will be greater than our current allocation?
	A.	Yes
33.	Q.	Can we write for the amount of combined money of our PI and PT previous grants?
	A.	Yes
34.	Q.	In previous years there has been a limit of \$500 per PI employee for professional development. Will that be the case in FY 12? And what about out of state travel (example: Parents as Teachers annual conference in St. Louis, a city approx. 100 miles from my program)?
	A.	Professional Development is an approvable expenditure. St. Louis is not considered out-of-state for travel purposes.
35.	Q.	By asking for fewer funds, are we more apt to get approved than asking for more funds? OR if we provide need and request funds, but are denied, can we still be approved at less funding?
	A.	Your proposal will be scored based on the criteria listed on pages 17-18 of the RFP.
	Q.	Should we base our budget on FY11 funding levels?
36.	A.	You should request/write for the funds needed to maintain a high quality program. This is not funding for expansion.
37.	Q.	Do PI programs need to put any professional development funds into their budgets or is it all provided at no cost?
	A.	Model specific training is provided through our Technical Assistance & Training Institute at no cost. Professional Development is allowable for professional development including travel and lodging if necessary. Out of state travel is not approvable.
38.	Q.	What is an amount we can consider to reasonably serve a family? (i.e. the 3-5 grant is \$3000 per child) Wondering with the emergency money, mileage, materials, salary for provider and supervisor figured in, summer-full round visits, staff development, group times, etc.
	A.	Your budget and program should be based on your actual cost. This will vary per program as it's relates to community, at-risk characteristics, numbers served, etc. PI does not have a cost per child. Your budget should be reflective of your program model, services and curriculum,
	Q.	How does it work to estimate your monthly spending into the budget?
39.	A.	Salaries, benefits, allowable operating expenses, etc. should all be estimated on a monthly basis to determine expenditures for each month.
4.0	Q.	Are there any budget codes or objective codes that we cannot use?
40.	A.	Guidance for preparing your budget, include budget function and object codes are listed on pages 29-30 of the RFP.
	Q.	Can programs request more funding FY12 than they received in FY 11?
41.	A.	Your budget and program should be based on your actual cost. This will vary per program as it's relates to community, at-risk characteristics, numbers served, etc. PI does not have a cost per child. Your budget should be reflective of your program model, services and curriculum. In some cases due to the above there will be an increase. Example: reflective of mileage, materials, salary for provider and supervisor figured in, summerfull round visits, staff development, group times, etc.
