Demographics and Early Childhood-New File Format SY 2021

Requirements

- 1. Allow enrolling of Pre-K Early Childhood students while capturing limited Early Childhood data (Indicators) using simplified Demographics and Early Childhood File Format for SY 2021.
- 2. Updates required for using Demographics and Early Childhood file.
 - File Name Change from Demographics and Early Childhood V3 to Demographics and Early Childhood
 - Incorporating the following new or updated Early Childhood fields:
 - o Early Head Start (Birth to 3)
 - Licensed Child Care
 - Student's Receiving CCAP Subsidy
 - o Meets At Risk Criteria
 - o Family Structure
 - Household Income Criteria
 - Child Welfare Involvement Within the Past Year
 - Family has an Open Intact Family Services Case
 - o Child's Parent is a Youth in Care
 - Student's Family is Receiving TANF
 - Student's Family is Receiving WIC
 - Student's Family is Receiving SNAP
 - Student's Family is Receiving a Housing Subsidy

Validations

- All enrollments must have at least one Program before enrollment can be exited:
 - Preschool for All
 - Preschool for All Expansion
 - Head Start
 - o IDEA
 - Preschool Title I
 - Local District
 - Tuition Based
- Enrollments with any of the following programs must have at least one Provider before enrollment can be exited:
 - Preschool for All
 - o Preschool for All Expansion
 - o IDEA
 - Preschool Title I
- Programs cannot be on more than one enrollment concurrently. Examples: Preschool for All and Preschool for All (unless the child has an IEP); Preschool for All and Preschool for All Expansion.

- If the student has a split enrollment, IDEA Program can be on more than one enrollment, but if the student is IDEA Services ='Yes', than IDEA Program MUST be on at least one enrollment.
- When IDEA Services is "No", the IDEA Program cannot be added.

Requirements

- 1. Update EL Placement Entry Status: Other/Alternative value.
 - a. Change code '13' description to "228.27 Plan"
 - i. Definition EL student who has not achieved English proficiency after three years in the TBE/TPI program (excluding pre-K and K) and is placed in a program established according to 23 Illinois Administrative Code 228.27 District must have an ISBE approved 228.27 program plan to use this placement.

Gifted and Accelerated

Requirements

- 1. To meet ESSA requirement, Districts must provide a Gifted and Accelerated record for each student in grades K-12 that ends the School Year with them.
- 2. Gifted and Accelerated records are unique by Home RCDT and School Year.
- 3. Add the new Gifted and Accelerated file format.

Validations

- Only Grades K-12.
- Only Home District can add/edit Gifted and Accelerated records for enrollments in district.
- Can only add/edit Gifted and Accelerated record for current or previous school year, starting in SY 2020.

- 2. Incorporate all related Illinois State courses under 23 **Subject Areas**.
- 3. Denote select Prior-to-Secondary State Courses per Subject Area.
- 4. Denote Course Start Date (and optional End Date) per course listing.
- 5. Provide an updated course alignment tool to assist districts.

Requirements

- 1. Add new PRTO file format.
- 2. Add new "Event Type" elements:
 - a. 04 Prone Physical Restraint
 - b. 05 Supine Physical Restraint

Validations

• Student must have a valid enrollment in SIS with the home, serving, or service provider RCDTS sending the record.

Can update/add PRTO records starting on July 1, 2016 – current enrollments (starting in SY 2017).

Student Attendance – Update for SY 2021

Requirements

- 1. Update Student Attendance file format.
- 2. Added two new fields E-Learning and Remote Learning.
- 3. Updated the following field names:
 - a. Days Present changed to In Person Instruction.
 - b. Days Absent Excused changed to Absent Excused.
 - c. Days Absent Unexcused changed to Absent Unexcused.
 - d. Days Medically Homebound changed to Medically Homebound.
 - e. Days Hospitalized changed to Hospitalized.

Validations

• The sum of In Person Instruction, E-Learning, Remote Learning, Absent Excused, Absent Unexcused, Medically Homebound, and Hospitalized cannot be more than the sum of days the student is enrolled for the Moth of Attendance reporting, excluding weekends.

Requirements

- 1. Update Student Demographic and Enrollment file format.
- 2. Added one new field Alternate Assessment Indicator.
 - a. Mandatory field of 01 (Yes) or 02 (No).

Validations

• If Alternate Assessment Indicator=01 (Yes), then IDEA Services MUST also =01 (Yes).
